Tension as Kaduna declares 24 hours curfew in 2 LGs

aduna State Government has declared a 24-hour curfew in Jema'a and Kaura local government areas with immediate effect to down tension following advice from security agencies in the affected

The curfew is to assist the security agencies to stabilize the situation in those areas to save lives and property and enable the restoration of law and order, in the places ravaged by terror attacks and killings.

A statement from the Ministry of Internal Security and Home Affairs commissioner Mr Samuel Aruwan stated that security agencies have full authorization enforce the curfew. Government condemns the violence and all acts of lawlessness that have occurred in the area", it stated, adding further updates would be issued as necessary.

Court sacks 20 Cross River lawmakers for defecting to APC

Federal High Court in Abuja has sacked 20 members of the Cross River State House of Assembly for defecting to the All Progressives Congress (APC).

The Peoples Democratic Party (PDP) had instituted a suit against the lawmakers over their defection to the APC.

The affected lawmakers are Michael Etaba, Legor Idagbor, Eteng Jonah William, Joseph A. Bassey, Odey Peter Agbe, Okon E. Ephraim, Regina L. Anyogo, Matthew S. Olory, Ekpo Ekpo Bassey, Ogbor Ogbor Udop, and Ekpe Charles Okon.

Öthers are Hillary Ekpang Bisong, Francis B. Asuquo, Elvert Ayambem, Davis Etta, Sunday U. Achunekan, Cynthia Nkasi, Edward Ajang, Chris Nja-Mbu Ogar, and Maria Akwaji.

In opposing the suit, Mike Ozekhome, counsel to the 4th-25th defendants, had challenged the diction to hear the suit.

He submitted that the cause of action arose in Calabar and that the matter should be transferred to the high court in Calabar.

In his judgement, the presiding judge, Justice Taiwo Taiwo, held that "there is nothing against the law that the suit be heard by this court". He said the 4-25th defendants are joined with other defendants who have their offices in Abuja.

Furthermore, in their defence, the lawmakers had argued that there was rancor in the PDP which led to their expulsion from the party.

The APC had in their submissions, told the court that the lawmakers are not registered members of their

However, the judge held that the defendants had intentions to mislead the court. He said he found gaps and loopholes in their defence as they tried to twist events to suit their own narratives.

Taiwo noted that they not only defect loudly but "took pictures of their defection and were received by the officials of the 26th defendant.

"There is no doubt that the defendants can belong to or join political association and assembly as they are free to do so. However, the truth must be told.

"I consider the attempts of the 6th – 25th defendants to justify their defection, feeble in the circumstances of this case."

Taiwo noted that the public voted for the lawmakers through the plaintiff who sponsored them and they were not voted for as independent candidates.

"They had a vehicle which conveyed them and that vehicle belongs to the plaintiff. They cannot abandon the vehicle," he

He stated that politicians treat citizens that elected them into power as if they do not matter when they assume office, adding that a day will come when elected officers must resign their post if they migrate to another party or seek the permission of the people for permission before they decamp.

EFCC Recovers N152bn, \$386m; Records 2,220 Convictions in One Year -- Bawa

The Chairman of the Economic Financial (EFCC), Commission Abdulrasheed Bawa, on Monday said the Commission had within the last year, secured an unprecedented conviction record of 2, 220 and recoveries in excess of N152billion, \$386milion, among other recoveries.

Bawa spoke at the opening ceremony of the 5th Annual General Assembly (AGA) meeting of the Network of National Anti-Corruption Institutions in West Africa (NACIWA)

Speaking to journalists after the opening ceremony of the two-day event, Bawa added that out of the over 2000 convictions recorded in the last one year, 641 took place in 2022 alone.

"The Commission has also embarked on several reforms aimed at strengthening the institution, including the development of a reporting application named Eagle Eye, to ease the reporting of incidences of economic and financial crimes by the public.

"The EFCC has further developed a five-year Strategic Plan that guides its operational approach in law enforcement action," he said in his speech at the opening ceremony. The NACIWA Assembly was cohosted by both the EFCC and the Independent Corrupt Practices and other Related Offences Commission

Why we are Keeping Obiano in Custody

The Chairman of the Economic and Financial Crimes Commission (EFCC), Abdulrasheed Bawa, on Monday also said the Commission has granted former Governor of Anambra state, Willie Obiano, bail.

He however added that the EFCC is still keeping him because he has not fulfilled his bail conditions.

Bawa, who fielded questions from journalists on the margins of the ongoing 5th Annual General Assembly (AGA) meeting of the Network of National Anti-Corruption Institutions in West Africa (NACIWA), rejected the allegation by the All Progressives Grand Alliance (APGA) that Obiano's travails are political in nature.

"He has been granted bail and we are waiting for him to perfect the bail conditions and everything is going

"There is nothing political here. We have no business with politics. We are just doing our job and we will do what we have to do professionally. We will keep doing all we have to do to ensure we stick to the rules and we are as professional as possible.

It would be recalled that Obiano was arrested at the Murtala Mohammed International Airport, Lagos, last Thursday, few hours after he handed over to his successor, Governor Charles Chukwuma Soludo.

The anti-graft agency subsequently transferred him to its office in Abuja for further interrogation.

The former governor, who had been on EFCC's watchlist, was among other offences, accused of misappropriating public funds totalling about N42billion.

National Assembly must review its position on gender equity bills

It is shocking and disgraceful that after several years of agitation the National Assembly stepped down crucial gender equity bills in the just concluded vote on constitutional amendment.

For several years, the male-dominated NASS has frustrated bills that seek to empower women.

The gender equity bill suffered similar fate in the Sixth Senate in 2010 when Chris Anyanwu first initiated it. The same flimsy ground of religion was adduced for its rejection in blatant negation of Nigeria's secularity as enshrined in the constitution. Such retrogressive attitude, especially from the North, keeps Nigeria down.


The Africa Report details how 11 pieces of legislation that seek to promote gender equality have similarly been frustrated in the last decade. They include the Gender Equal Opportunities, Abuse and Administration Bill, 2010; Gender Equal Opportunities Abuse and Administration Bill 2012 (both sponsored by Helen Esuene). Others include the Affirmative Action (Equal Opportunity for Women) Bill, 2012; Gender and Equal Opportunity Bill, 2014 both sponsored by Uzoma Nkem-Abonta; Women Empowerment and Gender Equality Act, 2015; Electoral Act (Amendment) Bill, 2015 to ensure that all Political Parties are Gender-Sensitive and to eliminate all forms of discrimination in all political parties; and the Women Participation in Election Support Bill, 2018.

Nigeria is signatory to several international treaties and conventions, including the Convention for the Elimination of Discrimination Against Women ratified in 1985; and the Protocol to the African Charter on Human and Peoples' Rights on the Rights of Women in Africa, better known as the Maputo Protocol; an international human rights instrument established by the African Union guaranteeing comprehensive rights to women, including the right to participate in the political process, to social and political equality with men.

It is saddening that the legislators who swore to uphold the constitution allow their religious beliefs to be cloud their judgement. They must be reminded that Nigeria is not a theocracy, but a democratic polity where the constitution remains supreme over any other law. Lawmakers should separate law-making from religion, which ought to be based on personal conviction. For long, unscrupulous politicians have manipulated religious sentiments to gain political advantage and deny the citizens the dividends of democracy.

On religious grounds, some northern states have refused to domesticate the Child Rights Act that says no child under the age of 18 should be allowed to be married. Instead, last year, moves were made by some senators to give voting rights to underage married girls.

When will such folly end? Ironically, in Saudi Arabia, the birthplace of Islam, the minimum age for marriage is 18. Muslim majority countries like Bangladesh and Pakistan have produced female heads of state. Surely, this debunks the falsehood that religion precludes women from holding positions of leadership.

Court strikes out bid by Ebonyi Gov, Deputy to stay execution of sacking

Justice Inyang Eden Ekwo of the Federal High Court, Abuja, on Monday struck out an application by the embattled Ebonyi State Governor, Dave Umahi, and his deputy, Kelechi Igwe, seeking to stop the execution of the judgment of the court that removed them from office on account of their unlawful defection.

The judge threw out the suit following confirmation that a valid appeal had been entered at the Court of Appeal, Abuja division, challenging the verdict that sacked them for defecting from the Peoples Democratic Party, PDP, to the All Progressives Congress, APC.

After several minutes of arguments by Chukwuma Machukwu Umeh SAN, counsel to the governor and the deputy as well as Chief James Ogwu Onoja SAN for PDP, the attention of the court was drawn to the substantive appeal already pending at the Court of Appeal.

Ume thereafter applied for withdrawal of the application to enable his clients to focus and concentrate on the substantive appeal.

The request was not opposed by the PDP counsel prompting Justice Ekwo in a brief ruling to strike out the suit.

Justice Ekwo ordered Governor Umahi and his deputy to shift their legal battle against the judgment that sacked them to the appellate court.

A similar decision was invoked in another application for judgment stay by the sacked 16 lawmakers of the Ebonyi State House of Assembly

Umahi and his deputy had two weeks ago asked the Federal High Court for an order staying the execution of its judgment that ordered their removal from office as governor and deputy governor of the state ntered at the Court of Appeal,

In a motion on notice filed by their counsel, the governor and his deputy prayed the court for an order staying the execution of the orders made in the judgment delivered on March 8, 2022, directing the Independent National Electoral Commission, INEC, to immediately receive from PDP the names of its candidates to replace them.

The court was also prayed to stay the execution of its order directing INEC to hold a governorship election in accordance with Section 177(c) of the 1999 Constitution.

The motion on notice dated March 9, 2022, equally sought an order staying the execution of the order of the court directing INEC to immediately declare the persons nominated by the PDP as governor and deputy governor of Ebonyi State respectively.

Buhari To Commission Newly Built Terminal At Lagos Airport Today

President Muhammadu Buhari, will on Tuesday, commission the newly built international terminal at the Murtala Muhammed Airport, Lagos.

The Lagos terminal is one of the five built in a bilateral arrangement between the Federal Government of Nigeria, and the People's Republic of China. The terminals are in Lagos, Abuja, Port Harcourt, Kano and Enugu.

In a press statement by the acting general manager, Corporate Affairs, Federal Airport Authority of Nigeria (FAAN), Faithful Hope-Ivbaze, the international terminal will generate about 3,000

direct and indirect employment for Nigerians, as well as enhance passenger facilitation and comfort at the Lagos airport.

According to her, the terminals in Abuja and Port Harcourt have been completed and commissioned while, Kano terminal will be completed and commissioned soon.

The FAAN spokesman further stated that the new terminal, built on 56,000 square metres, has 66 check-in counters will also facilitate 14 million passengers per annum.

"Other facilities in the terminal are, 5 baggage collection carousels, 16 Immigration desks at arrival, 28 Immigration desks at departure,

8 security screening points, 6 passenger boarding bridges (out of which 2 has already been installed), 2 food courts, 4 premium lounges, 22 guest rooms and spa.

"Others are, 16 airline ticketing offices, Visa on Arrival and Port Health facility, as well as praying area and more than 3,000 square metres of duty free space, amongst others."

"The Authority will also sign a memorandum of understanding with the Lagos State Government on the 9km Airport-Shasha-Alimosho link Road to be constructed by the State Governmen," she added.



APC convention: South-West govs reject Buhari's allies as secretary, vice-chair

outh-West politicians from the Congress for Progressive Change bloc in the All Progressives Congress are set to lose out at the national convention following their rejection by governors in the region.

The defunct CPC bloc is made up of politicians, who joined Major General Muhammadu Buhari (retd.) to merge with the Action Congress of Nigeria to form the APC in 2013 before he won the 2015 presidential election.

The former Minister of Communications, Adebayo Shittu, who is running for the national secretary of the APC; and the Executive Director, Niger Delta Power Holding, Ife Oyedele, were being resisted by the APC governors in the South-West.

It was also learnt that a former Chairman of the Senate Appropriations Committee, Iyiola Omisore, might be endorsed as the national secretary ahead of a former Oyo State Commissioner for Finance, Zaccheus Adedeji.

Also, Dayo Israel was tipped to emerge as the national youth leader of the APC according to sources.

A top source in the APC said, "There are attempts by some people in Abuja to impose some of the CPC elements on the South-West. Let me restate that the governors are the leaders of the party. We have met and have micro-zoned the positions given to our region.

"We will not tolerate any interference from outside. Shittu, Oyedele and others have lost out completely."

External forces trying to impose persons on S'West, says Akeredolu. In a statement on Sunday, Ondo State Governor, Rotimi Akeredolu, who is also the Chairman, South-West Governors' Forum, said the governors had agreed on micro-zoning, adding that those scheming from outside the region were only trying to cause confusion

Akeredolu said in the statement titled, 'External forces trying to impose persons on South-West', that a former Chairman of the APC in the state, Isaac Kekemeke, had been endorsed as the national vice chairman for the South-

The statement by the Commissioner for Information and Orientation,

Donald Ojogo, stated that all the governors of the South-West had endorsed Kekemeke.

It read in part, "This is to confirm that one of our own, the former APC state chairman, Duerimini Isaac Kekemeke, is in the race for the position of the National Vice-Chairman (South-West). Kekemeke has the full backing of Governor Akeredolu and his brother governors in the South-West.

"It should be noted that critical stakeholders in the South-West had earlier micro-zoned the positions that were brought to the region. Among these were the national vice-chairman, which was retained in Ondo, and the secretary, which was micro-zoned to the Oyo/Osun axis.

"For emphasis, what we are going for is national vice-chairman with Kekemeke as our candidate, and not national secretary. Those outside the South-West, who are attempting to micro-zone our offices for us in the South-West, are only creating unnecessary confusion and any such of their permutations outside the decision of stakeholders in the South-West should be ignored."

He said: "Our concern for the hardship our people are going through is the reason for the meeting.

"We're also looking ahead towards 2023 because it's very clear that PDP is the only viable option to rescue this country from its present situation.

"That's why we felt the need to hold this meeting because the stability and unity of this country are more important to us than our ambition.

"We felt the need to work together because we believe the three of us here are committed and with a lot of reserve energy moving ahead. There is great hope for this country to move ahead.

"The three of us have shown aspiration to lead this country but we have also come to realise that we are all capable of leading this country but at the end of the day, it's only one person that will get the ticket

"That's why we have resolved to work closely together to ensure a consensus arrangement emerge among the three of us moving forward."

It was learnt yesterday that the PDP will decide zoning after receiving and deliberating on the report of the committee it recently constituted for the purpose.

Senate Minority Leader and Chairman, Senate Caucus of the PDP, Senator Enyinnaya Abaribe, disclosed this during a telephone chat with our correspondent in Abuia.

The PDP had set up a 37-member committee to determine suitable zoning formula for all elective offices, particularly the Presidency, Senate President, and House of Representatives Speaker.

Abaribe said: "The party just set up zoning committee and that zoning committee which is made up of one person from each state of the federation will come up with the zoning formula."

A former Ekiti State Governor, Mr Ayodele Fayose, said he would abide by whatever decision the PDP takes on zoning.

Speaking through his media aide, Lere Olayinka, he said: "Fayose will not have a contrary opinion to that of the party leadership on which zone should produce our candidate for the 2023 presidency."

PDP National Secretary, Senator Samuel Anyanwu, also said the zoning decision was yet to be made.

He said the party was waiting for the committee to turn in its report on the issue before a decision on it would be taken.

"This is why we have set up the 37-man committee to advise us on the issue of zoning," he said.

However, a former PDP National Vice Chairman, Dr. Eddy Olafeso, believes it was too late for the party to zone the presidential ticket.

He said southern governors were entitled to their opinion to demand a president from their regions.

"If they decide to zone, we might come up with a presidential candidate that will not make any difference in the future of the country.

"It is better advised to encourage every Nigerian to participate. If we have a good president, unfairness, inequity, nepotism will be a thing of the past," he said.

The Niger State Chairman of the PDP, Tanko Beji, is confident that the best candidate will emerge.

Speaking when he hosted former Anambra State Governor Peter Obi at the PDP Secretariat in Minna, Beji said: "We Will provide an enabling environment for all aspirants at the state and federal levels."

The faction of the PDP led by Chief Bode George is set to meet to decide their position on zoning.

A leader and chieftain of PDP, Chief Ebenezer Babatope, said: "I am a fanatical member of PDP and I belong to the faction of Bode George.

"We are going to meet very soon to decide what to do with the presidential election, especially on zoning."

Those who have declared their intention to contest for president on the PDP platform from the Southeast are former Senate President Anyim Pius Anyim and renowned pharmacist and former Senator Sam Ohuabunwa.

Obi said he was still consulting, while Rivers State Governor Nyesom Wike is rumoured to be interested.

AGF Malami approves NDLEA request for seizure of Kyari, accomplices' assets

he Attorney-General of the Federation and Minister of Justice, Abubakar Malami, SAN, has approved a request by the National Drug Law Enforcement Agency for the confiscation of suspended DCP Abba Kyari and his co-accused assets.

It was gathered that the NDLEA's request, which was dispatched to the justice ministry penultimate week, had received the AGF's nod.

With this development, the former Commander, Inspector-General of Police Intelligence Response Team and his accomplices may lose their assets, cash and money in bank accounts; vehicles; real estate, notably hotels, residential and commercial buildings; personal effects such as wristwatches, jewellery and other valuable possessions.

Media reports last week indicated that about N4.2bn was traced to Kyari and his co-accused, ACP Sunday Ubua's bank accounts.

The NDLEA had on March 7 arraigned Kyari, Ubua and four members of the IRT, Sunday Ubia, Bawa James, Simon Agirigba and John Nuhu, on eight counts of conspiracy, obstruction and dealing

in cocaine, and other related offences before the Federal High Court, Abuja.

Two other suspects arrested at the Akanu Ibiam International Airport in Enugu, Chibunna Patrick Umeibe and Emeka Alphonsus Ezenwanne, were also listed as defendants in the suit marked FHC/ABJ/57/2022.

A senior justice ministry official said, "The AGF has endorsed the request by the NDLEA seeking approval for the confiscation of the assets of Abba Kyari, Ubua and the other police officers involved in drug dealing.

"With the approval, the drug agency can now go after their property such as real estate, bank accounts, cash, vehicles, stocks, bonds and anything of monetary value."

The source further said the seizure of the embattled DCP and his co-accused assets was to ensure that they did not benefit from the proceeds of crime.

The NDLEA spokesman, Femi Babafemi, had confirmed that the accused persons' bank accounts would be frozen, noting that this was standard practice.

Kyari, who is wanted in the United States for alleged involvement in a \$1.1m scam carried out by a notorious Internet scammer, Ramon Abass, aka Hushpuppi, was suspended by the police last July.

Ganduje's ex-aide Yakasai dumps APC, gives reasons

alihu Tanko Yakasai, a former Director-General, Media and Communications to Kano State Governor, Abdullahi Ganduje, has finally dumped the ruling All Progressives Congress.

Yakasai, who announced the decision in a statement on Monday, noted that he ceased to be a member of the party from March 21, 2022.

Yakasai was sacked in February 2021 by Ganduje after criticising the President, Major General Muhammadu Buhari (retd.), for his failure to end the security crisis rocking the country.

The statement read in part, "I have been a bonafide member of the All Progressive Congress party of Nigeria right from its inception almost a decade ago, precisely in February 2013.

"I travelled to different parts of the country to campaign for the party at the local, state and federal levels. I stuck out my neck, risked my life, gave my word and trust, and extended my belief in a party that we all thought in 2015 will usher in the leadership that will answer the cry of millions of Nigerians for good government, social stability, and material prosperity.

"By 2019, we reelected the APC again to manage the affairs of the country with the hope that its first term of four years was not enough to clear the mess it inherited from the defeated PDP administration.

"Regretfully, the trust and confidence we reposed in the APC (the government as well as the party) on two occasions (first and second terms) was betrayed. If anything, things became worse in the second term. The benefit of the doubt we gave the party in the first term vanished as we moved deeper into the second term.

"Failure', our people say, 'is an orphan', especially when everyone recognises it as such. No one in his right mind wants to be associated with it. But in the case of the ruling APC, those in power do not see themselves as having failed Nigerians. On the contrary, they perceive themselves as performing excellently. They douse themselves in self-praise, self-congratulations, and self-centred behavior in public office. Many people in this country will rightly see their conduct as delusional. But the privileged ones in the office today hardly notice the reality surrounding the lives of ordinary citizens:

"No food, no potable water, no stable power supply, no jobs for the youth, no regular salary for public servants, no pensions and gratuity paid; no respect for government agreement with university teachers; no control over inflation, no security of life and property, and no defeat of the stubborn insurgency in the northeast, with petroleum theft in the south-south becoming an existential threat to the entire nation.

"In the interim, I will take a few weeks to further consult, reflect and digest the political terrain, before deciding on my next line of action.

Panic as further increase in food prices loom

There are growing concerns that the price of bread and other food items may rise again across the country, following Russia's invasion of Ukraine.

Russia and Ukraine are major wheat exporters to Nigeria and some African countries. Wheat is the main ingredient for food items such as bread, cereals, biscuits, pastries, and pasta.

Even before the Russian army crossed into Ukraine, bread and food prices had been on the rise for the past year. So far, prices of bread have risen by 100 per cent in most parts of the country, no thanks to incessant increases in the prices of baking materials, factory rent and wages, which had made it difficult for the bakers to break even.

Due to Nigeria's dependence on

Russian durum wheat, the nation is at risk of suffering from significant food shortages and uptick food inflationary pressure, due to the

Speaking with journalists in Abuaj, the National President, the Federation of Agricultural Commodity Associations of Nigeria (FACAN), Dr. Victor Iyama, noted that the war in Ukraine could push up the price of bread as Nigeria and other countries rely on Ukraine and Russia, which are major producers of wheat, most of is imported by countries in the Middle East and Africa.

According to him, higher wheat prices would translate into higher bread prices for all.

The financial consequences on consumers will be large given the relatively high percentage of income spent on food, and bread in particular, experts said.

Right now, there are no subsidies for staples such as wheat and could drive the price of bread with inadequate local production.

A university don, Prof Abiodun Adeloye warned that the hostility in Ukraine could have a possible ripple effect in African nations. His words: "Bread is a staple in household diets. It is the delicacy of the young growing children. Bread forms one of the easy to access foods which are offered by parents at affordable prices but the main constituent of bread is wheat. Thirty per cent of the global production of wheat comes from the war affected zones, Russia and Ukraine. So, it is expected that the cost of bread may rise soon. Such rise in cost of bread would cause a shift in household dietary needs to other alternatives such as yam, cassava, and cocoyam - the costs of which would equally rise."

Edo APC, PDP clash over Obaseki's achievements, governance style

The Edo State chapters of the All Progressives Congress and the state government have again clashed over the projects executed by Governor Godwin Obaseki as well as his leadership style.

Queues persist in northern states despite 1.824 billion litres fuel supply

The queues by motorists for Premium Motor Spirit, popularly called petrol, particularly in Abuja and northern states have refused to clear despite the supply of about 1.824 billion litres of PMS by the Nigerian National Petroleum Company Limited.

Also, the NNPC on Sunday denied claims that it had reviewed the ex-coastal, exdepot and the NNPC Retail prices for petrol downward. It described the claims as fake news, in a series of tweets via its official Twitter handle.

Figures obtained by our correspondent from the company on Sunday showed that between February 14 and March 13, 2022, the oil firm released a total of 1.824 billion litres of petrol in a bid to keep the country wet with petrol.

But the queues in filling stations, which were triggered by the imports of adulterated fuel in January this year, refused to disappear and had persisted for about two months.

Meanwhile the presence of black marketers who sell petrol in jerrycans is currently a normal sight in Abuja, as some filling stations in the capital city now dispense PMS far above the approved price of N162-N165/ litre

A filling station in Kubwa, Khalif Civic Oil and Investment Limited, for instance, dispensed petrol at N280/litre on Sunday and still had queues of motorists, while the few major outlets that had products were greeted with massive queues.

Petrol supply data from the NNPC indicated that the oil firm distributed a total of 387.59 million litres of PMS from February 14 to 20, 2022, in its bid to bridge the petrol supply gap.

The NNPC also stated that it evacuated 381.88 million litres of petrol between February 21 to 26, 2022, adding that from February 28 and March 6, 2022, it supplied a total of 538 million litres of PMS.

The company went ahead to state that it evacuated a total of 514.69 million litres of petrol between March 7 and 13, 2022. This brings the total supply during the one month period to 1.824 billion litres.

In its most recent petrol supply data for March 7 to 13, the company stated that over 70 per cent of all the evacuation took place at the top 20 high loading depots, as other loading depots evacuated less than 30 per cent

The top 20 high load-out depots, according to NNPC, include Pinnacle-Lekki, Matrix, Nipco, A.A. Rano, Aiteo, Ardova, 11 Plc, Fradro, AYM Shafa, Prudent, MRS, among others.

Other depots that evacuated less than 30 per cent include Integrated Oil, Pinnacle, Virgin Forest Energy Limited, Nepal, Conoil, Petrostar, MRS Plc, among others.

The NNPC has been the sole importer of petrol into Nigeria for about four years running. It had ensured that the commodity remained available nationwide, being the supplier of last resort.

However, despite efforts by the firm to keep the country wet with petrol, the queues in the nation's capital have refused to clear, as well as in some other locations across the country.

The few filling stations along the Zuba-Kubwa expressway that dispensed petrol on Sunday, such as A.A Rano, Nipco and the NNPC, had lengthy queues.

Similarly, the queues in the two filling stations, Conoil and Total, located directly opposite the headquarters of NNPC in Abuja, have continued to be greeted with queues since January, as the queues persisted on Sunday.

The Minister of State for Petroleum Resources, Chief Timipre Sylva, and the Group Managing Director, NNPC, Mele Kyari, had repeatedly stated that efforts were ongoing to clear the queues nationwide.

Also, the Nigerian Midstream and Downstream Petroleum Regulatory Authority had assured citizens in Nigeria that the queues would be cleared following the imports of billions of litres of petrol by NNPC.

Their promises have, however, not materialised in full yet.

Meanwhile, NNPC tweeted on Sunday that "it has come to the attention of the NNPC Limited that the company has reviewed ex-coastal, ex-depot and the NNPC Retail prices. This is not true."

The company added, "It is fake news obviously concocted to cause confusion and to undermine the progressive drive of the NNPC to restore normalcy to the market.

"The general public and in particular industry operators at all levels should disregard this mischievous act of misinformation."

The NNPC said it remained focused and determined to reposition itself to provide value to its shareholders while meeting its statutory obligation as a provider of energy security for Nigeria.

Russia recently exposed military biological cooperation projects conducted by the U.S. in Ukraine, further unmasking the U.S., an empire of military biological activities.

Among all countries in the world, the U.S. has carried out the most military biological activities. The country has inherited the evil legacy of the notorious Unit 731 of the Imperial Japanese Army that waged the war of aggression against China, and developed biological weapons with Fort Detrick as the major base.

Its research and development of biological weapons at the base has continued even after it joined the BWC in 1975. The international community has therefore referred to Fort Detrick as "the center of the U.S. government's darkest experiments".

In the past few decades, the U.S. has continuously expanded its scope of military biological activities. According to data released by the country, the U.S. Department of Defense (DoD) carries out biological cooperation projects in more than 30 countries around the world.

The country controls several hundred biological laboratories using pretexts including cooperation for reducing biosecurity risks and strengthening global public health. Its military biological activities in Ukraine are only the tip of the iceberg.

Despite the international consensus ensuring compliance with BWC through multilateral verification, the U.S. has regarded its global military biological activities as its domestic affairs and allowed no external inspection and verification. Therefore, military biological activities have been running wild.

Given that the U.S. runs biolabs all over Central Asia, East Europe, Southeast Asia, South Asia, Middle East, and Africa, do all these biolabs operate under the so-called "cooperation" model as that in Ukraine?

The international community has no reason not to support the U.S. if it really intends to safeguard biosecurity and strengthen public health. Nevertheless, if the U.S. is using its biological research facilities overseas to grab biological resources and even develop biological weapons, it's quite another matter.

For the sake of the health and safety of people in Ukraine and its surrounding regions as well as the entire world, it's time the U.S. gave the international community an explanation for its military biological activities.

It's hoped that the U.S. will clarify thoroughly its military biological activities around the world with a responsible attitude and stop standing alone in opposing the establishment of the BWC verification regime, so as to help improve global biosecurity.

Compliance with convention doesn't equal shouting slogans. All countries must uphold the authority of international law.

The international community has every reason to assess the documents disclosed by Russia under the framework of the United Nations and the BWC, and at the same time listen to the explanation of the U.S. side in a fair and just way. This will help restore the international community's confidence in America's fulfillment of its international obligations and improve global biosecurity, which conforms to the common interests of the international community.

Nigeria's February Inflation Rate Rises To 15.70%

igeria's consumer price index, (CPI) which measures inflation has increased to 15.70 per cent for the month of February.

This is according to the National Bureau of Statistics, which disclosed this in their CPI and Inflation Report on Tuesday.

The report states that "this is 1.63 per cent points lower compared to the rate recorded in February 2021 (17.33) per cent," indicative that the headline inflation rate slowed down in February when compared to the same month in the previous year.

Also detailed in the report, were increases in all COICOP divisions that yielded the Headline index. On a month-on-month basis, the

Headline index increased to 1.63 per cent in February 2022, this is a 0.16 per cent rate higher than the rate recorded in January 2022 (1.47) per cent.

"The percentage change in the average composite CPI for the twelve months period ending February 2022 over the average of the CPI for the previous twelve months period was 16.73 per cent, showing 0.14 per cent point from 16.87 per cent recorded in January 2022."


Concerning the urban inflation rate, an increase to 16.25 per cent (year-on-year) in February 2022 from 17.92 per cent was recorded in February 2021, while the rural inflation rate increased to 15.18 per cent in February 2022 from 16.77

per cent in February 2021.

"On a month-on-month basis, the urban index rose to 1.65 per cent in February 2022, up by 0.12 the rate recorded in January 2022 (1.53) per cent, while the rural index also rose to 1.61 per cent in February 2022, up by 0.19 the rate that was recorded in January 2022 (1.42) per cent."

"The twelve-month year-onyear average percentage change for the urban index is 17.29 per cent in February 2022. This is lower than the 17.44 per cent reported in January 2022, while the corresponding rural inflation rate in February 2022 is 16.18 per cent which is lower than the 16.31 per cent recorded in January 2022," the report also said.

According to him, this project would support trade in West Africa, impacting the lives of over 500 million people, reducing transport costs and increasing intra-regional trade volume.

"It will support 75 per cent of the trade in the West African region. The project will impact the lives of over 500 million people. It would reduce transport cost by 48 per cent. It would increase intraregional trade volume by 15 to 25 per cent. It would connect landlocked cities to port countries," he


The AfDB president also said that the Affirmative Finance Action for Women in Africa has been critical in supporting women's businesses in Africa.

Businesses Are Suffering, Elumelu Laments Over Hardship, Poverty In Nigeria

igerian Economist and businessman, Tony Elumelu on Thursday lamented over the worsening electricity, hike in prices of diesel, and its effect on businesses in the country.

The CEO of Heirs Holdings in a series of tweets said businesses are suffering under the situation with Nigerian citizens groaning under food inflation as well.

"How can a country so rich in natural resources have 90% of its citizens living in hardship and poverty?," Elumelu said.

"This morning, I am listening to my colleagues at the office bemoan the very pressing issues that they face every day in this country, and how things have been getting worse and worse – no electricity for 5 days, hikes in the price of diesel, frightening food inflation, etc.

"I have often said that access to electricity is critical for our development, alleviation of poverty and hardship. And speaking of security, our people are afraid!" he lamented.

Speaking further, the entrepreneur who also runs a leading non-profit organisation, Tony Elumelu Foundation said the country is unable to meet its OPEC production quota due to oil theft.

"Businesses are suffering. How can we be losing over 95% of oil production to thieves? Look at

the Bonny Terminal that should be receiving over 200k barrels of crude oil daily, instead, it receives less than 3,000 barrels, leading the operator @Shell to declare force majeure," he said.

"Why are we paying taxes if our security agencies can't stop this? It is clear that the reason Nigeria is unable to meet its OPEC production quota is not because of low investment but because of theft, pure and simple!

"Meanwhile, oil-producing countries are smiling as their foreign reserves rising. What is Nigeria's problem? We need to hold our leaders more accountable!"

Concerning the 2023 election, Elumelu urged those running for offices to prioritise security and urged Nigerians to advocate for leaders that deliver.

"Elections are coming – security and resources need to be everyone's agenda – let's be vocal for our nation's priority.

"Evil prevails when good people are silent. We need to be vocal about 2023. Let's focus on Nigeria. Demand and advocate for leaders that deliver.

"In 2023, Nigeria must be on a strong trajectory for progress and development."

Elumelu in 2020 was named on Time's list of the 100 most influential people in the world.

Elon Musk's net worth hits \$232 billion as Tesla stock goes on rampage

Elon Musk, CEO of Tesla and SpaceX, continues to remain the world's wealthiest person. Tesla shares surged at the end of the trading week, adding to Musk's wealth.

Musk's current net worth is \$232 billion after gaining nearly \$8 billion on Friday. The tech billionaire, however, has lost about \$38.8 billion this year. His net worth exceeded Jeff Bezos' net worth by \$46 billion.

He currently has a net worth equivalent to about 120 million troy ounces of gold and 2.15 billion barrels of crude oil.

Prices for the stock rose nearly 4% on Friday, pushing its market value to about \$935 billion.

According to Musk's recent tweet, Tesla's stock is gaining momentum. "We are currently working on Part 3 of our master plan," he said.

Following a report tagged Part Deux, published in 2016, a Part 1 authored by Musk in 2006 comes with Part 3 of the master plan.

The first plan called for an expensive, low-volume car that would help build a mid-range

Part 3 could focus more on autonomy. As well as Tesla's plans to expand its vehicle line to more segments, it will be included. In order to maintain its growth, Tesla will eventually need to build smaller, lower-cost EVs.

On the price movement chart, MRS shed 9.96 per cent to close at N12.5., Ikeja Hotel depreciated by 9.87 per cent to close at N1.37 per share.

WAPIC lost 9.43 per cent to close at 48k per share while Mutual Benefits Assurance dropped 7.41 per cent to close at

Diesel price: Telcos mull tariff hike

Telecommunications services providers under the aegis of the Association of Licensed Telecoms Operators of Nigeria have said a tariff review for telco services may happen if the rise in the price of diesel is sustained.

The Chairman, ALTON, Gbenga Adebayo, disclosed this to our correspondent in an interview.

According to him, the telecoms industry is one of the major consumers of diesel in the country.

The sector, he said, had already been impacted by the current hike in diesel prices and scarcity of the product.

He said, "It is already impacting us and very significantly so. We are one of the industries that have the highest consumption of diesel across the country.

"Our need is not just in the major cities; it is all across the country. Diesel is required in all the places that require services. We are already significantly impacted. And it is not just about the high costs, it is also about availability. Suppliers are beginning to find it difficult to supply the commodity because of scarcity.

"When they find, costs of haulage have gone up. The cost of procurement of the diesel itself has gone up significantly. We are actually in a very bad situation. And how this will play in enduser pricing requires us to follow the right channel, the regulatory procedure for conveying our complaint to the regulator."

According to Adebayo, telcos will continue to ensure that there are no service disruptions in the nation. However, he added that there might be a need for a tariff review if the present diesel crisis persists.

He said, "The diesel situation is a problem at this time. We are doing all that we can to ensure the business continues as usual in all cases and other every circumstance. The assurance for the public is that there would not be a time of outage because of the current diesel crisis. What I cannot assure is that at some point there may not be a consideration for some form of tariff review.

"I cannot guarantee that it will not happen sometime in the near future. I cannot guarantee that. But as it stands today, I will reassure the public that there would be continuous service at all times.

"We will continue to solve the problem to the best of our ability. We certainly need to approach the government for some intervention at some point. We are where we are. All that we are doing at this time is to ensure there are no disruptions to service."

According to a source in one of the telecoms companies in the nation, the operating environment for teles is now tougher. The source added that the present crisis might cause service disruptions if it persists.

The source said, "For instance, we have about 20,000 base transceiver stations across the nation, and each one of them has two industrial generators.

"You can imagine what it must be costing to fuel two generators in over 20,000 places. It is a lot. As you are aware, we do not directly manage those stations anymore. But irrespective of who is managing it, the cost has definitely been impacted. Operating is more difficult now.

"In the long-term, this will cause service disruptions. We might have to renegotiate contracts with those helping us manage to the stations. As you know our call rates are regulated, meaning there is a ceiling and a floor. We cannot because of this change our call rates."

The price of diesel has tilted towards N850/litre, and is continuing to increase daily. In January, diesel was N350 per litre in Lagos.

Afreximbank agrees to \$207m facility with NEXI in combating COVID-19

frican Export-Import Bank (Afreximbank) has announced the finalisation of a 207 million dollars facility granted by Nippon Export and Investment Insurance (NEXI), the state-owned Japanese organisation focused on trade and investment.

Afreximbank's Media Contact, Amadou Sall said this in a statement in Abuja that the agreement was consummated on Friday in Cairo, Egypt. The facility would support the bank's broader response measures to the Covid-19 pandemic, especially its financing efforts for the acquisition of COVID-19 vaccines for Africa through the African Vaccine Acquisition Trust (AVAT).

" Today's announcement represents the second collaboration between Afreximbank and NEXI.

"In 2020, NEXI approved a 520 million dollars facility which was also designed to support the

Bank's response to the COVID-19 pandemic by enabling it to finance the import of Covid-19 containment materials as well as related essentials.

"The range of facilities supports the implementation of the Japanese Government's decision at the TICAD7, to support African countries by facilitating the deployment of private capital," he said.

Sall said that Mitsubishi UFJ Financial Group (MUFG) acted on the deal as Mandated Lead Arranger, Bookrunner, Agent, and Global Coordinator, and was involved in the first of NEXI's facilities agreed with Afreximbank in 2020.

He said that the President and Chairman of the Board of Directors of Afreximbank, Prof. Benedict Oramah, said.

"This facility, the second in a series demonstrates the strong commitment of the Government of Japan to the African continent as it emerges from the COVID-19 pandemic.

" It will significantly bolster Afreximbank's activities in financing vaccination acquisition and delivery on the continent.

"The Japanese government made a commitment to assist African countries to manage, and adjust to, the pandemic, and today's announcement provides yet another evidence of this in action," Oramah said.

I Will Never Negotiate with Terrorists Again – Masari

pparently regretting his rapprochement Leterrorists in Katsina State, Governor, Aminu Bello Masari, has vowed not to negotiate or trust the hoodlums again because of their nefarious activities despite the two peace deals he had with them.

The governor added that with the benefit of hindsight, his government should never have negotiated with the terrorists, let alone grant them amnesty because "they are not propagating any ideology, they are criminals."

Masari explained that some of the 'so-called repentant' terrorists who were released from custody as a result of the peace deals are now leaders of terrorists with more than 100 gangs and various camps in Zamfara, Sokoto and Katsina states.

In an interactive session with members of a high-powered foreign delegation led by the Head of United Nations Development Programme (UNDP) in Nigeria, Mohammed Yahya, at the Government House, Katsina, Masari insisted there was no need to negotiate with the criminals.

The United Nations Children's Fund (UNICEF) Representative in Nigeria, Peter Hawkins, Head of Cooperation, European Union in Nigeria, Cécile Tassin-Pelzer and Norway Ambassador to Nigeria, Knut Éiliv Lein, were among the delegation.

Although Governor Masari said he never regretted his decision at the time, he admitted that information available to him confirmed that engaging the terrorists who had killed and raped innocent citizens in the state was not the right thing to do.

Consequently, he urged the United Nations Development Programme, European Union

(EU) and the United Nations (UN) to support the Nigerian government with the provision of technologies that will enable security agencies to have access to the nation's ungoverned forest

He said: "Because they (terrorists) said they are Muslims, we went as far as asking them to swear to the Holy Qur'an that they will never participate in banditry again. All of them did in this office but even those that have been in jail for over two years that were brought out are today bandits' leaders.

"In fact, I will never trust them again because we realised they are not ideologically inclined. So, we are negotiating with thieves. Anybody who says he is going to engage them on anything is free. I will pray for him but I will not do it again.

"They have failed me once; they have failed me twice so I will be a fool to go the same way. And you even see the Zamfara governor who engaged them. They have failed him more than three times."

Masari added: "They are common criminals. Even in Katsina not to talk of Zamfara, there are more than 100 gangs: a gang of two, three, four and a gang of 10, so with whom are you going to talk?"

Earlier, Yahya told the governor that the delegation was in the state to ascertain the security challenges afflicting the state and know what the international community can collectively do towards the development of the state.

In a letter of invitation sighted by our correspondent, the event will commence at 11AM with important dignitaries expected to



Leaked Obiano's video in EFCC detention surfaces online

short video of former Anambra Governor Willie Obiano in the Economic and Financial Crimes Commission's detention has surfaced online.

In the video which lasted 12 seconds, Obiano was seen sipping water from a bottle.

He was also discussing with an unidentified person in the video.

The Economic and Financial Crimes Commission said former Governor Willie Obiano of Anambra State is being quizzed over the alleged misappropriation of N42 billion belonging to the state.

The agency had last year placed the former governor on its watch list and also asked the Nigeria Immigration Service to stop him from leaving the country in a letter to the Comptroller-General of Immigration dated November 15, 2021

Obiano was arrested by EFCC on Thursday night, hours after handing over to the new Anambra Governor, Prof. Chukwuma Soludo.

The EFCC spokesman, Wilson Uwujaren, said, "Obiano has been flown to Abuja (on Friday). He is currently at our Abuja office.

"Obiano was arrested for alleged misappropriation of public funds, including, N5bn Sure-P and N37bn security vote which was withdrawn in cash. Part of the funds was also allegedly diverted to finance political activities in the state."

Meanwhile, the All Progressives Grand Alliance has condemned Obiano's arrest by the Economic and Financial Crimes Commission.

The party described the arrest of the former governor as a

"politically-motivated witchhunt", saying that the EFCC had resorted to the use of fifth columnists.

Addressing journalists in Awka, on Saturday, the National Coordinator, APGA Media Warriors Forum, Evang Chinedu Obigwe, said the allegation that the former governor misappropriated N42bn, out of which N37bn was used to fund political activities was baseless and does not hold water.

Obigwe said efforts by the EFCC to dent the hard-earned reputation of Obiano would not succeed as he remains innocent until proven guilty by a competent court of law.

He said as of today, Nigerians don't have confidence in the anti graft agency anymore, saying that "when they see the real corrupt politicians joining APC, they would turn to toothless bulldogs.



DSS Raises Alarm Over Planned Protests Against Fuel Scarcity

The Department of State Services has raised the alarm over a plot by aggrieved persons to stage protests over the worsening fuel scarcity.

The DSS said in a statement by its Spokesman, Peter Afunaya, that university lecturers who are part of the ongoing strike embarked on by the Academic Staff Union of Universities would also be part of the demonstrations.

The agency alleged that the plan was to hold protests that would be similar to the #EndSARS demonstrations that rocked the country in 2020.

The statement read in part, "The service is also aware of a plot to use students, striking university teachers, labour unions, disgruntled individuals and strategic groups as well as exploit the global energy situation to carry out a mass protest like the ENDSARS. This is despite ongoing efforts by the government to address the issues.

"While the service views the machination as unpatriotic, it is on the trail of the agents of destabilisation who are desirous of using violence to achieve ulterior goals.

"Though it has placed measures to disrupt these tendencies, it warns the ring leaders and their cohorts to desist from acts capable of causing a breakdown of law and order."

The DSS added that there was a sinister plan by some elements to stoke violence in parts of the country particularly the North-Central.

It said the aim is to cause ethnoreligious crisis, ignite reprisals and heat up the polity.

"In a bid to achieve this, the sponsors have mobilised foot soldiers and held several meetings in and outside the target areas," it said.

The DSS said it would work with other security agencies and go "after the sponsors of this scheme and ensure the law takes its course."

It advised citizens to engage according to rules but should resist persuasions to be used to destroy their own country.

"Those who may wish to go contrary to the law will, however, face the consequences," the DSS threatened.

Nigeria In Deep Mess Because God-Fearing Leaders Aren't Allowed To Lead- Peter Obi

Peter Obi, People Democratic Party (PDP) Vice Presidential candidate in the 2019 elections, has attributed the challenges confronting Nigeria to lack of God-fearing leaders.

Speaking at a reception organised for the President of Afrieximbank, Dr. Benedick Okey Oramah, who was honoured with a Doctorate Degree on Development Economics at the Nnamdi Azikiwe University, Awka, Obi called on the Federal Government to possibly suspend all political activities ahead of 2023 and address pressing issues

Obi said Nigeria's problem is more than 2023 election, which seem to be capturing the attention of the government at the moment.

"If possible, suspend all political activities for now and focus on how to address the lingering fuel scarcity and other societal challenges confronting Nigerians at the moment," he said.

Obi said if things continue this way, the electorate may not have the appetite to participate fully in the 2023 electoral process.

He said something must be done to minimise the suffering of the masses, particularly as a result of fuel scarcity and Academic Staff Union of Universities (ASUU) strike saga.

"Nigeria is in economic

mess today because it failed to implement the right policies and refuse to allow those with skills and God-fearing heart to govern."

"In my observation as a true democrat, I can tell you that several businesses are shutting down, especially as the fuel crisis worsens. Millions of Nigerians can no longer afford three square meal and there is high rate of prostitution among young ladies.

"Farmers are not free from the situation, with repeated threats from bandits, who have taken over most of the farm settlement, especially in the northern part of Nigeria.

"It has been proved everywhere in the World that the more educated a society is, the better it is for development. The only way we can measure development is through Human Development Index (HDI), which is hindering in education. And if you check countries that have same trajectory like Nigeria. For instance, in the vear 2000, Bangladesh, Ghana, to mention but few, had same low Human Development Index (HDI) with Nigeria, but they have moved from low-medium while Nigeria remains in same low position.

"In the year 2010, Nigeria per capital was 2,250 dollars while Bangladesh was 780 per capital,

because the country invested in education, thereby pulling people out of poverty. Today, their per capital is 2,650, ours is still 2000, meaning that the Nigerian economic is collapsing.

effective and sustainable European security architecture in line with the principle of indivisibility of security, so as to safeguard peace in Europe and the world at large.

Abuja-Kaduna standard gauge rail lines, which are already in operation, the ongoing work on the Kaduna-Kano railway, Abuja Light Rail, the upgrade of the Port Harcourt-Maiduguri narrow gauge, Abuja-Keffi-Makurdi road and the building of new airport terminals in Abuja, Lagos, Port Harcourt and Kano, among others, as the "visible monuments that testify to the warm relations and great cooperation between the two countries".

The Minister also lauded the cooperation between the StarTimes of China and the Nigerian Television Authority, which culminated in the birth of the Integrated Television Services (ITS), which is the Federal government-owned signal distributor that is playing a major role in the Digital Switch Over in Nigeria.

He urged the Chinese Ambassador to facilitate the granting of the 500-million-dollar loan to Nigeria by the China Export-Import Bank for the execution of three major projects in the public broadcast sector.

"Also worthy of mention, Your Excellency, is the 500-million-dollar loan which we are seeking from the China Export-Import Bank for three major projects - the digitization of the NTA, the construction of a headquarters complex and transmission network for Integrated Television Services (ITS), a Federal Government-owned signal distributor that is a major component of the country's Digital Switch Over (DSO), and the construction of an ultra-modern Media City in Ikorodu.

"I want to use this opportunity to appeal to Your Excellency to continue to use your good offices to fast-track the evaluation and approval process of the loan by the China Export Import Bank, and to thank you for your efforts so far in this regard," Alhaji Mohammed said.

In his remarks, Ambassador Chui said China is re-strategizing its bilateral relations with Nigeria to focus on Growth, Development and Progress.

He said the new strategy, tagged "5 GIST" will be a holistic, complete and sustained approach to focus on political support, economic cooperation, security and military collaboration, international affairs coordination, infrastructure, ICT, industry, investment, import and export, among others.

The Ambassador said the new focus will be anchored on people-to-people communication and relationship as well as cultural exchanges.

he unfolding tragedy in the Ukraine's war with Russia deserves the universal attention it is receiving. Where better to discuss it than the United Nations, UN? Where best in the UN than the Security Council which has all the powers of the world body, has teeth and can bite. But when the matter was discussed at the Security Council, it suffered defeat because that exclusive club of five permanent members that dictates to the rest of humanity, runs on veto power. That group comprising the United States, US; China and three European countries: Russia, France and the United Kingdom, UK, decide what is best for the rest of the world irrespective of the opinion of the rest of humanity.

The war is a matter in which the members of the big boys club had differing interests and the rule is that if any of them objects, no binding decision can be taken. So, calling a meeting of the castrated UN General Assembly on the issue became more a motion without movement; an academic exercise or more of moral suasion.

Also, the motive of calling the Assembly was more of the West showing that there are more countries that supports it than its rival Russia. A more meaningful objective would have been how the world can pressure both sides of the conflict to accept immediate ceasefire, a negotiated settlement and return of peace, more so when an escalation may have negative consequences on the world.

A non-legal or nonbinding vote was taken of 193-member assembly with 141 states voting against Russia, five in favour, 35 abstentions, while 12 did not vote. In a world supposedly wedded to democracy, this Assembly would have been an opportunity for the world to insist on changing the power relations in the UN to allow the equality of votes or the will of the majority to prevail rather than a world where the vote of a single country overrides that of the entire world. That was why the manifest evil called Apartheid in South Africa endured until 1994; because the US and UK would not allow the world take decisive steps at the UN against that Evil Empire.

When in 1976, Africa boycotted the Montreal Games Olympic because the International Olympics Committee refused to disqualify New Zealand that was making rugby tours in Apartheid South Africa, some Western countries denounced us for allegedly mixing sports with politics. Interestingly, the US boycotted the 1984 Moscow Olympic Games because the Soviet Union intervened in Afghanistan; the same country

Sense and nonsense in Nigeria voting against Russia



America was to invade 17 years later. Today, Russian sportsmen and women are being barred from international competitions; is this not mixing sports and politics? The point I am making is not to justify any attacks or invasion, including the war in Ukraine. Rather, it is to make the point that countries play international politics primarily based on the promotion and defence of their national interests. So in Nigeria voting against Russia at the UN Assembly, what interest was being served? National interest or a mindless casting of vote? First, in taking sides in the intra-European squabble, we have lost the opportunity to play the needed mediatory role and lost relevance in the resolution of the Russian-Ukrainian conflict.

Secondly, we lost sight of the fact that unlike the West, Russia has never constituted a threat to Nigeria or Africa.

Thirdly, the Buhari administration displayed a lack of historical knowledge. The defunct Union of Soviet Socialist Republics, USSR, which was inherited by Russia, was in the forefront of the global struggles against colonialism. It applied pressure that colonies like Nigeria must be freed. Even while being colonised, the Soviets and their allies provided thousands of Nigerians scholarship to ensure an independent Nigeria has the trained manpower required to run a new country.

Moscow also provided African colonies fighting for liberation with funds, military training, arms, scholarship and vital international support. This it did in the bloody liberation wars in Algeria, Angola, Mozambique,



Guinea Bissau, Cape Verde, Zimbabwe, Namibia and South Africa. The Soviets did not mind that the colonialists they armed us against were their fellow Europeans!

In the specific case of Nigeria, when the civil war broke out and countries like France and Israel equipped the then rebels with military hardware and training to secede, the UK refused to supply Nigeria needed air force equipment as it did not want the federal side to have air superiority, and the US declared itself neutral.

It was Moscow that came to Nigeria's aid. On August 2, 1967, then Information and Labour Minister, Chief Anthony Enahoro, was in Moscow to sign an arms deal, including the supply of aircraft. Soviet ally, Czechoslovakia followed six days later, agreeing to supply the federal side military aircraft and training.

The Soviet Union did not mind that Nigeria was opposed to socialism; its position according to Premier Alex Kosygin, was based on the Soviets desire to "prevent the country from being dismembered".

Nigerian Ambassador to the Soviet Union, Brigadier George Kurubo, declared that Russian support was "responsible for the federal victory more than any other single thing, more than all other things put together". In November 1968, while

the war was on, Moscow came to Nigeria's aid by agreeing to provide the funds to build the crucial Kainji Dam.

Also, when in Nigeria's quest for development it decided to build an iron and steel complex, the West refused on the basis that we did not need this mother of all industries.

It was Moscow that came to our rescue by providing funds and building the Ajaokuta Iron and Steel complex.

Nigeria as the giant of Africa forgets that in the event of a conflict between a NATO member and an African country, like the one brewing between Mali and neo-colonial France, the Europeans will collectively fight against the African country. It forgets that with the shortage of gas from Russia, desperate European countries will turn on countries like Nigeria for gas they will want virtually for free even if it means subverting us or removing a non-compliant government.

This is our experience. The basis of Buhari's foreign policy is truly amazing: from supporting the military coup in Chad to abstaining on December 31, 2020 in the UN Resolution on: "A global call for concrete action for the elimination of racism, racial discrimination, xenophobia and related intolerance..." In other words, it refused to vote for the universal elimination of discrimination and racism!

At the UN General Assembly, Nigeria should either have abstained or not voted like its more sensible brothers such as Cameroun, Burkina Faso, Senegal, Morocco, Togo, Mali, Burundi, Equatorial Guinea and South Africa. Like we say in Nigeria: Common sense is not common.

igeria will continue to lag behind in Tuberculosis control activities as only 31% of TB funding got into the coffers of the country. This position was disclosed by the Acting Board Chairman of Stop TB Partnership Nigeria, Dr. Queen Ogbuji who said that out of the \$373 million needed for Tuberculosis(TB) control in 2021 only 31% was available to all the implementers of Tuberculosis control activities in Nigeria totalling (7% domestic and 24% donor funds), with 69% funding gap.

According to Ogbuji, less than half of the Global US\$15 billion annual funding for TB which world leaders promised promised at the United Nations High-Level Meeting (UNHLM on TB in 2018), has been delivered. The Stop TB Nigeria head said that TB remains one of

the world's deadliest infectious killers that kills about 4,100 people daily and nearly 30,000 people fall ill with this preventable and curable disease.

She said, "TB is the leading cause of death of people with HIV and a major contributor to antimicrobial resistance. Global efforts to combat TB have saved an estimated 66 million lives since the year 2000."

"The COVID-19 pandemic has reversed years of progress made in the fight to end TB. For the first time in over a decade, TB deaths increased in 2020."

She noted that the 2022 World TB Day is an opportunity to focus on the people affected by this disease and to call for accelerated action to end TB suffering and deaths, moreso in the midst of the ongoing COVID-19 pandemic.

"The theme for 2022 World TB Day is "Invest to End TB. Save Lives". And the slogan

for Nigeria is "Give More, Do more, End TB Now!" The theme – 'Invest to End TB. Save Lives' conveys the urgent need to invest resources to ramp up the fight against TB and achieve the commitments to end TB made by global leaders".

"This is especially critical in the context of the COVID-19 pandemic that has put End TB progress at risk, and to ensure equitable access to prevention and care in line with the drive towards achieving Universal Health Coverage. More investment to TB will save millions more lives, and accelerate the end of the TB epidemic."

"The Stop TB Partnership and all partners are calling on all those involved in the fight against TB to unite under this overarching theme and sound the alarm that the low levels of funding for the TB response year after year cannot continue

nor be accepted anymore".

We therefore call on the government at the federal, state and local government levels as well as corporate sector and philanthropists to invest in TB and prevent people from dying from a preventable and curable disease, she said.

According to the Executive Director of KNCV Foundation, in Nigeria Dr Odume Bethrand, the World TB Day is a day set aside to educate the public about the socio-economic impact of TB. Bethrand disclosed the KNCV TB Foundation Nigeria, along with funding Partner the USAID, the STOP TB Partnership Nigeria and the Government will use the opportunity to share successes, create awareness and most importantly highlight the key challenges that hinder the progress toward meeting set targets for TB control in

Nigeria.

He said, "Nigeria still accounts for 4.6% of the global estimated TB cases, with the highest TB burden in Africa, the 6" globally and 1 of 10 countries that accounts for 70% of the global gap between the estimated global incidence of multidrug resistant TB each year and the number enrolled on treatment."

"About 75% of TB patients in Nigeria and their households are facing catastrophic costs. Though Nigeria is 1 of 4 countries that improved case notification against the impact of the COVID-19 pandemic, but we can do so much more to close the about 70% gap in TB notification."

He enjoined that "To end TB in Nigeria we must address the funding gap; invest more in human and material resources needed to control the TB epidemic."

FG to transform health system as NPHCDA hosts PHC Summit

In a bid to transform Nigeria's Primary Health Care,PHC, system, Executive Director of the National Health Care Development Agency, NPHCDA, Dr. Faisal Shuaib has said that agency in collaboration the Ministry of Health is set to host the PHC Summit on 24th and 25yh of March, 2022 in Abuja. to health correspondents, the agency said that the launch of the programme is aimed at transforming the PHC in Nigeria for a strengthened quality health care system in the country. in Nigeria by leveraging private sector, international agencies and government collaboration." According to him, the Summit themed: 'Reimagining PHC"will converge national elected leaders, top government officials, and leading private sector executives to brainstorm on attainable plans that will on a large scale move Nigeria's primary health care

(PHC) system by the year 2030, adding that the programme is solutions-focused and dedicated to delivering improved PHC services across the country. "Thus, the Summit will kick-start fund mobilization to realize the programme's goals – it will be an inclusive project, leveraging the know-how and resources of the private sector, government, and

global development agencies."

As government of continuity, the Prosperity Government continued all abandoned projects inherited by his predecessor including the second phase of Isaac Boro Road, the 89km Sagbama-Ekeremor Road, the 38km Yenagoa-Oporoma Road and the 22km Elebele-Igbogene Ring Road, which the first phase



from Igbogene-Okarki is already inaugurated. The government also inherited uncompleted key projects like the Glory Drive Road from Igbogene to Onopa, where the Government House is located, was conceived during the Timipre Sylva administration. The road is now under construction after clearing all court litigations that put the project onhold for years.

Moreover, the Government also facilitated the commencement of commercial flight after the administration secured the certification of operational licence last year from the Nigeria Civil Aviation Authority (NCAA). Since then the airport airlifting passengers to different parts of the country with affordable fees.

To enable night-time flights at the airport, the Diri administration has procured Instrument Landing System (ILS) and other required equipment. It had earlier undertaken the construction of the airport's perimeter fencing, a condition that the NCAA insisted upon even though there were other considerations for delaying the operational licence.

Bayelsa security outfit code-named "Operation Doo-Akpo", which has significantly reduced crime and criminality in Yenagoa and its environs. It also strengthened the state's complementary security outfits - Bayelsa Volunteers and Bayelsa Vigilante - by harmonising their operations with the Operation Doo-Akpo after the Bayelsa Community Safety Corps Law came into force. The inhabitants of Bayelsa can now sleep with their two eyes close, which the security personnel are visibly stationed in all the strategic locations of the state. The administration also embarked on massive expansion of roads and roundabouts like the Swali ultra-market and the Tombia roundabouts which cultists and some criminal elements used as a hideout to pepertuate crime and criminality.

In addition, the administration also embarked on the construction of 18 new internal roads in the state capital alone out of 20, while 51 other internal roads were rehabilitated within the period under review.

The administration also commissioned The Unity Bridge connecting the Nembe people of Ogbolomabiri and Bassambiri in Nembe Local Government Area of the state. It gathered that the bride got damaged several years ago at the height of a protracted dispute between both communities. The rift was so deep that the communities could not even agree on rebuilding the strategic route that bonded them.

Apart from establishing technical and vocational colleges in all the local government areas of the state, it is vigorously pursuing the introduction of Science Technology Engineering and Mathematics literacy in secondary schools.

The government also launched Ijaw history book, The Izon of the Niger Delta. An idea conceived and nurtuered by late Dr. Diepreye Peter Solomon Alamieyeseigha's led government but did not see the light of the day until the present administration. The intention of the book is to revive the Ijaw language which was gradually going into extinction. It also make the compulsory learning and teaching of the Ijaw language in our primary and secondary schools across the state.

The administration has also commissioned the Kaiama Referral Hospital, which it inherited from his predecessor and increase the testing capacity of the infectious Covid-19 pandemic, and the sustenance of the Bayelsa Insurance Scheme which is enjoying by all Bayelsa civil servants and their family members.

Ensuring food sufficiency, the government of Senator Douye Diri provide land and seedlings to farmers in collaboration with the apex bank (Central Bank of Nigeria) build fish processing plant of over 20,000-metric tonnes capacity, which are all effective and functional.

If this is not checked, they will come back as usual to do their illegal businesses.

"Sadly, owners of the landed property have failed to develop their property and people take advantage of the fallow land to build all manner of shanties and batchers. Yesterday, we went to Utako village to clean the place, to be taking over by its rightful owner, the Nigeria Police ."

"We are going round the city to clean up the environment, the minister has mandated us to commerce intensive clean up of transportation lapses beginning from the Airport road, we are going to be clearing the areas, with strong focus on traffic-related violations."

"The new Director, Directorate

of Road Traffic Services (DRTS), Dr Abdulateef Bello as you all know is knowledgeable about security. He will be leading a comprehensive team to commence massive traffic clean up starting from Monday. There is so much he intends to achieve and we all will be working with him", he added.

FCT to crush 1,500 impounded motorcycles

The Federal Capital Territory Administration (FCTA) is set to crush 1, 500 motorcycles popularly known as okada, it was learnt at the weekend.

The motorcycles were impounded by the Directorate of Road Traffic Services (DRTS) otherwise known as the Vehicle Inspection Office (VIO) by riders who violated traffic rules and regulations in the FCT.

The Director of the Directorate of Road Traffic Services (DRTS), Dr Abdulateef Bello said this when he paid an on-the-spot-visit to the DRTs task force office in Wuye to acquaint himself with the activities of the task force

He said: "As we did the last time, these motorcycles were impounded and would be crushed. They are motorcycles whose riders were arrested

because they contravened the traffic law and regulations by driving against the traffic within the city centre.

"Right now, we have over 1,200 motorcycles to be crushed. As much as the exercise is ongoing, we are within the confined areas estimating that when we have 1,500 motorcycles, then we begin another second round of crushing.

"These motorcycles were impounded within three to four months. We did the last exercise around November/ December, and then we started assembling the newly impounded motorcycles."

Bello, however, said the government will not rest on its oars until the FCT is free from

okada, which constitutes a nuisance and security threat.

He warned motorcycle riders to obey the rules and the restraining order not to ply the FCT routes.

He said: "They should stay such as estates and market places, not to approach the highways. So, all those that contravened traffic rules will face this particular punishment of having their motorbikes crushed."

On what they will use the crushed motorcycles for, the DRT boss said it will be given to auctioneers who have use for the parts.

Annie had revealed during one of the episodes of the show that she has been subjected to many humiliations and embarrassment and would always question how 2face made the same mistake twice.


"When you meet someone,

The Russo-Ukrainian War is the most severe geopolitical conflict since World War II and will result in far greater global consequences than September 11 attacks. At this critical moment, China needs to accurately analyze and assess the direction of the war and its potential impact on the international landscape. At the same time, in order to strive for a relatively favorable external environment, China needs to respond flexibly and make strategic choices that conform to its long-term interests.

Russia's 'special military operation' against Ukraine has caused great controversy in China, with its supporters and opponents being divided into two implacably opposing sides. This article does not represent any party and, for the judgment and reference of the highest decision-making level in China, this article conducts an objective analysis on the possible war consequences along with their corresponding countermeasure options.

I. Predicting the Future of the Russo-Ukrainian War

1. Vladimir Putin may be unable to achieve his expected goals, which puts Russia in a tight spot. The purpose of Putin's attack was to completely solve the Ukrainian problem and divert attention from Russia's domestic crisis by defeating Ukraine with a blitzkrieg, replacing its leadership, and cultivating a pro-Russian government. However, the blitzkrieg failed, and Russia is unable to support a protracted war and its associated high costs. Launching a nuclear war would put Russia on the opposite side of the whole world and is therefore unwinnable. The situations both at home and abroad are also increasingly unfavorable. Even if the Russian army were to occupy Ukraine's capital Kyiv and set up a puppet government at a high cost, this would not mean final victory. At this point, Putin's best option is to end the war decently through peace talks, which requires Ukraine to make substantial concessions. However, what is not attainable on the battlefield is also difficult to obtain at the negotiating table. In any case, this military action constitutes an irreversible mistake.

2. The conflict may escalate further, and the West's eventual involvement in the war cannot be ruled out. While the escalation of the war would be costly, there is a high probability that Putin will not give up easily given his character and power. The Russo-Ukrainian war may escalate beyond the scope and region of Ukraine, and may even include the possibility of a nuclear strike. Once this happens, the U.S. and Europe cannot stay aloof from the conflict, thus triggering a world war or even a nuclear war. The result would be a catastrophe for humanity and a showdown between the United States and Russia. This final confrontation, given that Russia's military power is no match



for NATO's, would be even worse for

3. Even if Russia manages to seize Ukraine in a desperate gamble, it is still a political hot potato. Russia would thereafter carry a heavy burden and become overwhelmed. Under such circumstances, no matter whether Volodymyr Zelensky is alive or not, Ukraine will most likely set up a government-in-exile to confront Russia in the long term. Russia will be subject both to Western sanctions and rebellion within the territory of Ukraine. The battle lines will be drawn very long. The domestic economy will be unsustainable and will eventually be dragged down. This period will not exceed a few years.

4. The political situation in Russia may change or be disintegrated at the hands of the West. After Putin's blitzkrieg failed, the hope of Russia's victory is slim and Western sanctions have reached an unprecedented degree. As people's livelihoods are severely affected and as anti-war and anti-Putin forces gather, the possibility of a political mutiny in Russia cannot be ruled out. With Russia's economy on the verge of collapse, it would be difficult for Putin to prop up the perilous situation even without the loss of the Russo-Ukrainian war. If Putin were to be ousted from power due to civil strife, coup d'état, or another reason, Russia would be even less likely to confront the West. It would surely succumb to the West, or even be further dismembered, and Russia's status as a great power would come to an end.

II. Analysis of the Impact of Russo-Ukrainian war On International Landscape

1. The United States would regain leadership in the Western world, and the West would become more united. At present, public opinion believes that the Ukrainian war signifies a complete collapse of U.S. hegemony, but the war would in fact

bring France and Germany, both of which wanted to break away from the U.S., back into the NATO defense framework, destroying Europe's dream to achieve independent dream to diplomacy and self-defense. Germany would greatly increase its military budget; Switzerland, Sweden, and other countries would abandon their neutrality. With Nord Stream 2 put on hold indefinitely, Europe's reliance on US natural gas will inevitably increase. The US and Europe would form a closer community of shared future, and American leadership in the Western world will rebound.

2. The "Iron Curtain" would fall again not only from the Baltic Sea to the Black Sea, but also to the final confrontation between the Westerndominated camp and its competitors. The West will draw the line between democracies and authoritarian states, defining the divide with Russia as a struggle between democracy and dictatorship. The new Iron Curtain will no longer be drawn between the two camps of socialism and capitalism, nor will it be confined to the Cold War. It will be a life-anddeath battle between those for and against Western democracy. The unity of the Western world under the Iron Curtain will have a siphon effect on other countries: the U.S. Indo-Pacific strategy will be consolidated, and other countries like Japan will stick even closer to the U.S., which will form an unprecedentedly broad democratic united front.

3. The power of the West will grow significantly, NATO will continue to expand, and U.S. influence in the non-Western world will increase. After the Russo-Ukrainian War, no matter how Russia achieves its political transformation, it will greatly weaken the anti-Western forces in the world. The scene after the 1991 Soviet and Eastern upheavals may repeat itself: theories on "the end of ideology" may reappear, the resurgence of the third wave of democratization will

lose momentum, and more third world countries will embrace the West. The West will possess more "hegemony" both in terms of military power and in terms of values and institutions, its hard power and soft power will reach new heights.

4. China will become more isolated under the established framework. For the above reasons, if China does not take proactive measures to respond, it will encounter further containment from the US and the West. Once Putin falls, the U.S. will no longer face two strategic competitors but only have to lock China in strategic containment. Europe will further cut itself off from China; Japan will become the anti-China vanguard; South Korea will further fall to the U.S.; Taiwan will join the anti-China chorus, and the rest of the world will have to choose sides under herd mentality. China will not only be militarily encircled by the U.S., NATO, the QUAD, and AUKUS, but also be challenged Western values and systems.

III. China's Strategic Choice

1. China cannot be tied to Putin and needs to be cut off as soon as possible. In the sense that an escalation of conflict between Russia and the West helps divert U.S. attention from China, China should rejoice with and even support Putin, but only if Russia does not fall. Being in the same boat with Putin will impact China should he lose power. Unless Putin can secure victory with China's backing, a prospect which looks bleak at the moment, China does not have the clout to back Russia. The law of international politics says that there are "no eternal allies nor perpetual enemies," but "our interests are eternal and perpetual." Under current international circumstances, China can only proceed by safeguarding its own best interests, choosing the lesser of two evils, and unloading the burden of Russia as soon as possible. At present, it is estimated that there is

still a window period of one or two weeks before China loses its wiggle room. China must act decisively.

2. China should avoid playing both sides in the same boat, give up being neutral, and choose the mainstream position in the world. At present, China has tried not to offend either side and walked a middle ground in its international statements and choices, including abstaining from the UN Security Council and the UN General Assembly votes. However, this position does not meet Russia's needs, and it has infuriated Ukraine and its supporters as well as sympathizers, putting China on the wrong side of much of the world. In some cases, apparent neutrality is a sensible choice, but it does not apply to this war, where China has nothing to gain. Given that China has always advocated respect for national sovereignty and territorial integrity, it can avoid further isolation only by standing with the majority of the countries in the world. This position is also conducive to the settlement of the Taiwan issue.

3. China should achieve the greatest possible strategic breakthrough and not be further isolated by the West. Cutting off from Putin and giving up neutrality will help build China's international image and ease its relations with the U.S. and the West. Though difficult and requiring great wisdom, it is the best option for the future. The view that a geopolitical tussle in Europe triggered by the war in Ukraine will significantly delay the U.S. strategic shift from Europe to the Indo-Pacific region cannot be treated with excessive optimism. There are already voices in the U.S. that Europe is important, but China is more so, and the primary goal of the U.S. is to contain China from becoming the dominant power in the Indo-Pacific region. Under such circumstances, China's top priority is to make appropriate strategic adjustments accordingly, to change the hostile American attitudes towards China, and to save itself from isolation. The bottom line is to prevent the U.S. and the West from imposing joint sanctions on China.

4. China should prevent the outbreak of world wars and nuclear wars and make irreplaceable contributions to world peace. As Putin has explicitly requested Russia's strategic deterrent forces to enter a state of special combat readiness, the Russo-Ukrainian war may spiral out of control. A just cause attracts much support; an unjust one finds little. If Russia instigates a world war or even a nuclear war, it will surely risk the world's turmoil. To demonstrate China's role as a responsible major power, China not only cannot stand with Putin, but also should take concrete actions to prevent Putin's possible adventures. China is the only country in the world with this capability, and it must give full play to this unique advantage. Putin's departure from China's support will most likely end the war, or at least not dare to escalate the war. As a result, China will surely win widespread international praise for maintaining world peace, which may help China prevent isolation but also find an opportunity to improve its relations with the United States and the West.

South Korea to send non-lethal military supplies to Ukraine

outh Korea will send nonlethal military supplies to Ukraine, Defense Ministry spokesperson Boo Seung-chan said in a briefing Tuesday.

The supplies will be worth about \$800,000 and include bulletproof helmets, tents, blankets, bedspreads, non-perishable military food kits, first aid kits and medicines, a ministry official confirmed.

Delivery logistics have not yet been finalized, Boo added.

In February, the presidential Blue House ruled out South Korean military deployments or lethal support for Ukraine, a position reiterated by the Defense Ministry last week.

▼krainian President Volodymyr Zelensky has shared a letter he wrote to the family of American journalist Brent Renaud, who was killed in Ukraine.

"It is with deep sadness that I am writing to extend my heartfelt condolences to you on the tragic loss of your beloved son and brother, Brent Renaud." Zelensky said in a copy of a letter addressed to Renaud's family posted on Twitter.

"With all his courage and determination, he traveled to the most dangerous war zones to film the unprecedented ruthlessness and evil, also inflicted upon our nation by the aggressor state."

Award-winning reporter Renaud was killed by Russian forces in the Ukrainian city of Irpin, police in Kyiv said in social media posts Sunday.

CNN has not independently verified the account given by

Another American journalist, Juan Arredondo, was wounded. Time magazine told CNN that Renaud was in Ukraine in recent weeks to work on "a Time Studios project focused on the global refugee crisis."

On Monday, Russia's Ambassador to the United Nations said at the UN Security Council, without providing evidence, that Renaud died at the hands of Ukrainian forces in Irpin — not Russian forces.





Russia claims troops are making progress in Ukraine

The Russian army has advanced a further 12 kilometres into eastern Ukraine and reached the border of the settlement of Nikolske near Mariupol, says Russian Ministry of Defence spokesman Igor Konashenkov.

Bayern Munich make 25m Gravenberch bid as they move ahead of Manchester United for Ajax star

The German champions have formalised their interest in the teenager amid his latest impressive season at Johan Cruyff ArenA

Bayern Munich have made a €25 million (£21m/\$28m) bid for Ryan Gravenberch to move ahead of Manchester United in the race to sign the Ajax star, GOAL and Voetbalzone can confirm.

Gravenberch has attracted high profile admirers across Europe since breaking into the Ajax first team at just 16 in 2018, showing off his talents in both Eredivisie and Champions League.

Man Utd and Real Madrid have been among those credited with an interest in the Netherlands international, but Bayern have made the first move to secure his services ahead of the summer transfer window.

The German champions have submitted an opening offer for Gravenberch, whose contract with Ajax is due to expire in June 2023.

GOAL and Voetbalzone have learned Bayern's opening bid came in €10m below Ajax's €35m (£29m/\$39m) asking price, but they are hopeful the Eredivisie club will be willing to compromise in order to avoid losing the 19-year-old on a free transfer next year.

Gravenberch is flattered by Bayern's interest and open to a move to Allianz Arena, where he would see his current salary demands met.

The Argentina international had been in talks with the Serie A side over a new deal, but will instead depart the club for free at the end of the season.


The January signing of Vlahovic from Fiorentina has changed the

There's this nostalgic remembrance of Ngige on ABS saying..." Nkwo to Nkwo, uzo nke a di na Phase 2 or Phase 3". Peter Obi as a Governor took every little opportunity he could find to communicate to Ndi Anambra. He was on T.V, Radio and you can easily find him at burial ceremonies, child dedication, wedding ceremonies, church services etc, always looking for the minutest opportunity to interact. In this day, the development in ICT has made it even easier and more effective. Numerous platforms offer easy access for interaction. There are Twitter spaces, Instagram live, Facebook Live etc. Prof Soludo is an excellent communicator. Therefore, this will rather be a walk in the park.

CLANNISHNESS:

Willie Obiano took clannishness to a whole new level never seen before in Anambra State. The Governor completelyabdicatedhisresponsibilities to his kit and kins. On the streets, they were referred to as the Aguleri cabal. They controlled appointments, government revenues, contracts etc. It is a recipe for disaster and
