ASUU States condition for schools' resumption

The Academic Staff Union of Universities (ASUU), Abuja zone has said there will be no resumption in public universities until renegotiated 2009 agreement is signed, implemented and the University Transparency and Accountability Solution (UTAS) deployed.

The ASUU Zonal Coordinator, Dr Salawu Muhammed Lawal, who made this known said members are ever ready to return to their duty post as soon as their demands are met by the Federal Government.

NAN reports that the zone comprises the Federal University of Lafia, Federal University of Technology Minna, Nasarawa State University, Keffi, Ibrahim Badamasi Babangida University, Lapai, and the University of Abuja.

He said, "You would recall that the Academic Staff Union of Universities (ASUU) declared a four-week rolling strike at the University of Lagos National Executive Council (NEC) meeting held on Feb. 14

"Owing to the failure of the Federal Government to act within that period, the national action was rolled over for another eight weeks following the resolution taken at an emergency NEC meeting at the Festus Iyayi National Secretariat on March 14.

"The action as you are probably aware is to among other things, compel the Federal Government to sign and implement the draft renegotiated 2009 ASUU-FGN Agreement submitted to it by the Prof. Munzali Committee in May 2021.

"Deploy for use in the Nigerian university system, was the homegrown payment and personnel solution called UTAS developed by ASUU as a replacement for the failed IPPIS.

usual, the Federal "As Government has ignored ASUU's call for full implementation of that famous agreement and other memoranda signed with the union.

"No meeting has been held between the two parties since the commencement of the ongoing strike. The only exception is our union's re-submission of UTAS for a retest.

"The summary is that unless and until the renegotiated 2009 agreement is signed and implemented and UTAS deployed, there will be no work in public universities," he added.

ational Leader of the All Progressives Congress (APC), Bola Tinubu, is says he is unperturbed by the declaration of Vice President Prof. Yemi Osinbajo, to contest for president in the 2023

election. Emerging from a meeting in Abuja with 17 APC Governors, Tinubu spoke to the press.

"I have no son grown enough

to declare," Tinubu replied when asked his thoughts about his political 'son's' declaration this morning.

Osinbajo was Attorney General and Commissioner of Justice of Lagos State during the eight years' reign of Tinubu as governor of the state.

The governors in attendance at the meeting with Tinubu include Governors Abubakar Bagudu

of Kebbi State, Nasir El-Rufai of Kaduna State, Bababjide Sanwo-Olu of Lagos, Abdullahi Ganduje of Kano, Gboyega Oyetola of Osun, Mai Mala Binu of Yobe, Simon Lalong of Plateau and Abubakar Badaru of Jigawa.

Others include Dapo Abiodun of Ogun State, Hope Uzodinma of Imo State, Abdullahi Sule of Nassarawa state, amongst others.



Tinubu may leave APC if he fails to secure ticket

s the contest for All Progressive Congress (APC) Presidential Licket tightens, former Lagos Governor, Bola Tinubu, might leave the party if he fails to clinch the ticket, reliable sources close to the APC national leader have said. Osinbajo, after months of speculations rumours and sponsored advertisement, opened up on his desire to succeed his boss, President Muhammadu Buhari, in 2023.

"I believe that the very reason why the Almighty God gave me these experiences, these insights, and these opportunities, is that they must be put to the use of our country and its great peoples.

"Which is why I am today, with utmost humility, formally declaring my intention to run for the Office of the President, Federal Republic of Nigeria, on the platform of our great party, the All Progressives Congress," he said. However, the controversial

declaration, according to feelers in

Bourdillon, has rattled Tinubu and the former Governor is making plans to exit the party should he lose at the primaries.

"Baba didn't expect that Osinbajo would make the declaration at that time. Even though reports were getting to Tinubu about Osinbajo's rumoured ambition everyone here thought the whole publicity stunt would die down," a source stated.

Another source stated that while Tinubu is ready to slug it out with any aspirant at the primaries, he won't hesitate to leave the party if the outcome of the election does not favour him.

"Where we are going next after that, we don't know but that is the plan B," he revealed.

A few months ago, Tinubu announced his intent to run for the office during a visit to the Aso Villa. Asked what the response of the president was to his ambition, the former two-time Lagos State

governor replied, "That's our business. He is a democrat. He didn't ask me to stop. He didn't ask me not to attempt and pursue my ambition, which is a lifelong ambition.

"So, why do I expect him to say more than that? You are running a democratic dispensation, and you must adopt the principles and the values and the virtues of democracy. That's it.'

The APC leader stated, "I don't want to discuss individuals now. I must discuss myself. I have the confidence, the vision, the capacity to rule, build on the foundation of Mr. President, and turn Nigeria better. I've done that with commitment, you know, in Lagos State. You've seen that experience and the capacity to turn things around and that is what we are doing."

Analysts believe that have told having two candidates from the same political base might affect the chances of both Tinubu and Osinbajo.

Kaduna Train Attack And The Growing Tragedy Of Insecurity In Nigeria

igeria is faced with an unprecedented wave of different but overlapping security crises - from kidnapping to extremist insurgencies - almost every corner of the country has been hit by violence and crime

The Abuja-Kaduna highway has become one of the most dangerous roads in the country as kidnappers regularly ambush and attack vehicles at several points along the expressway.

Over the last few years this has pushed many to avoid the 150km (93-mile) journey by road instead opting for the rail link, which opened in 2016. It is more expensive but considered safer as the trains have armed guards on board. Many Nigerians opt for the train to avoid the dangerous Abuja-to-Kaduna highway

But the ill fated attack on the rail line that happened on Monday evening of 28th of March 2022, changed everything.

Terrorists detonated an IED on the track forcing the train, carrying 970 passengers, to a stop. Gunmen subsequently surrounded the carriages and opened fire, an unknown number of passengers were abducted from the train, 8 persons were reported killed, 26 persons injured during the attack.

The Minister of Transportation Rotimi Amaechi reacting to the attack said he had warned that lives would be lost. Amaechi who was speaking to reporters after visiting the scene of the attack, said the unfortunate event could have been avoided if a N3 billion digital security equipment had been acquired. He lamented that now it will take more than N3 billion to replace what has been lost to the attack on the Abuja-Kaduna rail route. "We knew what the problem would be. We knew we needed to have digital security equipment. We applied for it. Because if we had those equipment, you will see nobody on that track. And I warned that lives will be lost. Now, lives are lost". Speaking on the security situation Chairman, House Committee on Aviation, Hon Nnolim Nnaji recalled that on Friday, 25th of March, 2022, there was a horrific armed banditry attack at the Kaduna International Airport, culminating in the death of a security guard of the Nigerian Airspace Management Agency NAMA. Henoted that coupled with train attack it means now here is safe again in Nigeria. "The armed bandits attacks at Kaduna International Airport may escalate to other airports across the country, if not check mated ``hesaid."No one is safe to travel by air if positive steps are not taking urgently to safeguard our airports from banditry attacks, considering the international standards on airport security management as outlined by International Civil Aviation Organization (ICAO), he said in a motion. Speaker further on the issue, Nnaji said that the implication of the attacks was that international flights may stop coming into the country. The Nigerian Railway Corporation has however issued a statement suspending persenger activities along line.

"We were challenged some few days ago, for us to have an infraction at the airport, which means no way is safe. If our roads are not safe; if our rails are not safe; if our airports are not safe, then it calls for us to suspend everything political to begin to address the critical needs of Nigerians" said Nnolim. TheKadunaStateGovernor, NasirEl-Rufai, inisreactiontotheattacks and the spate of insecurity in Kaduna state, vowed to hire foreign mercenaries to fight terrorism if the federal government fails to do its job. He said, if actions are not taken, it becomes a must for governors to take measures to protect citizens, according to him, "even if it means we will import mercenaries from outside the country to do it. If our soldiers fail, I swear to God, we will do that. This issue has gotten to an alarming state". El-Rufai disclosed an interview conducted in Hausa language with the BBC. The reaction of the Kaduna state governor to the train attack has been described by many commentators as extreme. It is however a reflection of the growing state of frustration to the Federal Governent's seeming inability to check the growing state of insecurity in the country.

Insecurity: No plan to shift 2023 election -- INEC

hose who want the 2023 general elections shifted should perish the thought, the Independent National Electoral Commission (INEC) said yesterday. The Commission said it was

constitutionally bound by its timetable, despite threats.

INEC National Commissioner and Chairman of Information and Voter Education Committee, Festus Okoye, told The Nation: "Postponing and or suspending the 2023 general election are not options on the table.

"The Commission is not considering or contemplating such an eventuality.

"The Nigerian people empanelled the Commission to organise, undertake and supervise elections and not to lament.

"The Commission conducted the Anambra Governorship election in the context of challenging security conditions and Nigerians adjudged the election as free, fair, credible and inclusive.

"There are significant security challenges in Nigeria and no one is glossing over them.

"The security challenges in Nigeria will no doubt impact the electoral process but the conduct of the election is not a tea party.

"Conducting election is a complex and complicated venture involving a complex set of stakeholders with varying and differing perspectives and competence.

"The Commission will continue to work with and consult with the security agencies and all the critical stakeholders towards degrading the security situation in the country. "Nigerians must be in a position to

access the polling units unimpeded. "Nigerians must have confidence that their votes will count.

"The Commission will continue to make it possible for Nigerians displaced by conflicts and who are in IDP camps to vote."

Besides, Okoye said sections 76(2), 116(2), 132(2) and 178(2) of the Constitution provide that an election for the office of the president and governor must be held on a date not earlier than 150 days and not later than 30 days before the expiration of the term of office of the last holder of that office.

"This constitutionally circumscribed timeframe is not movable and no individual or court can extend this period.

"The alternative is a constitutional crisis that may lead to indeterminate outcomes.

"As a Commission, we have our eyes on the ball and will continue to plan and deploy conflict mitigation tools and strategies in the electoral process," the National Commissioner said.

On how the security situation may affect the election cost, Okove said: "It is too early to make a determination whether the security situation in the country will dramatically affect the cost of elections.

"Nigerians must remain positive and work towards the peaceful resolution of the challenges of our nation.

"Democracy is not a finished product. We must continue to work and nurture it." Army promises safe polls

The Nigerian Army said it would ensure hitch-free elections next year with Operation Safe Conduct.

It said the operation would provide a secured and conducive

environment for the conduct of the 2023 general elections. The Chief of Army Staff, Lieutenant General Faruk Yahaya, said the Army would remain

apolitical. Speaking at the closing of the Chief of Årmy Staff Quarter Conference in Abuja, he said: "As we carry out our constitutional duties of maintaining peace and security in aid of civil authority across the country, let me emphasise that we should all remain professional and glaringly apolitical.

"We should also continue to uphold human rights principles in the conduct of our operations in tandem with the constitution and our rules of engagement.

"This is particularly important as the activities outlined in the INEC calendar gather steam.

"In line with our constitutional responsibilities, we will continue to provide a conducive and secured environment for the conduct of the general elections through Operation Safe Conduct in aid to civil authority. "I also want to reaffirm the

commitment and unalloyed loyalty of the officers and soldiers of the Nigerian Army to the Constitution and to the President.'

N37b National Assembly renovation begins this week

years after it got WO Presidential approval to give the National Assembly a face-lift, the Federal Capital Development Authority (FCDA) will begin the renovation of the sprawling edifice this week.

Thirty-seven billion naira was voted for the project in the 2020 Appropriation Act which President Muhammadu Buhari signed following request to that effect by the leadership of the National Assembly.

DAYBREAK learnt yesterday that the contractors have been mobilised to commence work. As a result of prolonged decay,

the foyer of the White House and other parts of the Complex had succumbed to massive leakage due to torrential rainfall in June 2021.

Apart from the leaking roof, the leadership of the National Assembly often complained of excessive heat during plenary and committee sessions.

It was observed that two hearing rooms in the House of Representatives were recently fitted with industrial Air conditioning units as part of remedial measures to curb heatwave.

Last year, the Red and the Green chambers referenced the leaking parts of the complex as a justification for its request to President Muhammadu Buhari to approve the N37 billion repair vote. Some Nigerians had criticised the

amount voted for the renovation. The National Assembly also ordered a cooling system to serve as an alternative.

A source close to the leadership of the National Assembly, confirmed the development.

"The National Assembly has made a contingency plan by importing additional chiller as backup to the one the FCDA contractor is fixing in the renovation plan as budgeted for by FCDA,' the source said.

Confirming Peter's arrest, FCT Police Public Relations Officer, Josephine Adeh said: "He is now in our custody. The younger brother of the deceased reported the matter and we have commenced investigation."

Electoral Act 84 (12): Appeal Court stops Malami

The Court of Appeal has restrained the Attorney-General of the Federation and Minister of Justice Abubakar Malami (SAN) and others from frustrating the hearing of an appeal against a judgment mandating the AGF to delete Section 84 (12) from the Electoral Act 2022.

A three-member panel, led by Justice Rita Nosakhare Pemu, in a ruling, granted the Peoples Democratic Party (PDP) permission to appeal, as an interested party, against the March 18, 2022 judgment by Justice Justice Evelyn Anyadike of the Federal High Court in Umuahia.

The Appeal Court made the order in a ruling delivered at the Owerri Division on April 7.

The court also granted an accelerated hearing in the appeal.

The ruling was on a motion marked: CA/OW/87m/2022 filed by the PDP, with Chief Nduka Edede (plaintiff in the suit decided by Justice Anyadike) and the AGF as respondents.

It reads: "Leave is hereby granted the applicant (PDP) to appeal as person interested in this appeal – CA/OW/87/2022.

"Due to the exigencies of this appeal and its constitutional colourisation, there is need to hear this matter expeditiously.

"Accordingly, the appellant is hereby given up to Tuesday 12th of April, 2022 to file its notice of appeal and the parties are to file their respective briefs of arguments within three days from the date of service of the notice and record of appeal on the respondents.

"There shall be a further three days given to the appellant to file

a reply.

"Parties should desist from taking any step to frustrate the hearing of the appeal.

"The matter is adjourned to the 4th of May, 2022, for the hearing of the appeal.

"Fresh hearing notice to be issued on the 2nd to the 12th respondents."

The National Assembly has also indicated its intention to formally appeal the judgment by Justice Anyadike.

Justice Anyadike had in the March 18 judgment in the suit by Edede marked: FHC/UM/ CS/26/2022, held that Section 18(12) of the amended Electoral Act is unconstitutional and should be struck down.

The judge noted that sections 66(1)(f), 107(1)(f), 137(1)(f) and 182(1)(f) of the 1999 Constitution already stipulated that government appointees seeking to contest elections are only to resign at least 30 days before the election.

She held that any other law that mandates such appointees to resign or leave the office at any time before the 30 days provided in the Constitution was unconstitutional and void to the extent of its inconsistency with the clear provisions of the Constitution.

Justice Anyadike then ordered the AGF to delete the said Section 18(12) from the amended Electoral Act.

Section 84(12) of the Electoral Act provides: "No political appointee at any level shall be a voting delegate or be voted for at the convention or congress of any political party for the purpose of the nomination of candidates for any election."

The PDP has already filed a separate suit before the Federal High Court in Abuja in which it is challenging among others, President Muhammadu Buhari's request that the National Assembly should alter the provision of Section 84(12) of the Electoral Act.

The case marked: FHC/ABJ/ CS/247/2022, before Justice Inyang Ekwo, has been adjourned till April 28 for hearing.

Minister of Transportation, Rotimi Amaechi, who at the weekend declared his interest in the race, may be affected by the Electoral Act provision.

Going by Section 84 (12), he is expected to resign to participate in his party's primary, being a political appointee.

Minister of Labour, Chief Chris Ngige, who had hinted that he may contest, will also be expected to resign should he eventually declare.



Insecurity: Akwa Ibom evacuates stranded citizens from Katsina over bandits' attacks

A kwa Ibom State Government weekend evacuated from Katsina State a total of 34 of her citizens, who were stranded following attacks by bandits and insurgents in some parts of Katsina state.

The victims, who arrived Uyo the State capital on Saturday were recieved by the Commissioner for Women Affairs and Social Welfare, Dr Ini Adiakpan at the Women Development Centre along IBB Way, Uyo.

Addressing newsmen, Adiakpan explained," The attention of the state government was drawn to a viral video on social media where some displaced Akwa Ibom indigenes in Katsina State were calling for help, because their houses, shops and other sources of livelihood were either vandalised or burnt by bandits.

"So the state government immediately ordered for their evacuation and safe return to the state. The Governor has made adequate arrangement for them to be recieved.

"Relief materials will also be

released to them, and we will then begin to reintegrate all of them with members of their families immediately ". One of the returnees, and President

of Akwa Ibom Community in Katsina State Chief Effiom Williams, recounted the origin of the incident and how he was able to mobilize the citizens to his house for safety.

Williams who is also a lecturer in the Department of Mathematics, Federal College of Education, Katsina narrated: "I got a distress call from our members in Batsari, Danja, Dan Musa and other Local Government Areas that their houses, and shops were being attacked.

" I quickly mobilised them into safety in my house. When some of them arrived, they had nothing left because they had lost everything to the crises, so the Community had to raise money in order to get them clothes and other effects.

"We later reached out to the state government for assistance. We are very happy that the Governor has intervened ".

A survivor and native of Ikono

LGA Elizabeth Emmanuel, explained that her shop and home were razed down by the arsonists, who attacked their community at night, killing several people in their sleep.

Mrs. Emmanuel who said she resides in Jibia LGA of Katsina State expressed appreciation to the State Governor, Mr. Udom Emmanuel for the timely intervention.

"We got back home and started hearing loud shooting at night. And we all started running for our dear lives. All I could take from our house are my children and few clothes. Luckily for us, we were escorted to the IDP camp by soldiers ".

Emmanuel further narrated how they were, linked to the President of the Akwa Ibom Community in Katsina by a fellow Akwa Ibomite in the Internally Displaced Person's (IDPs) camp. Similarly, a shoe cobbler who spoke

similarly, a snoe coobler who spoke on ground of anonymity lamented that his source of livelihood was completely destroyed during the attack by bandits, adding that it was by luck he was able to escape with his family to Katsina Metropolis

FG calls for synergy among Commissioners for workable national economic development

Ountries are in a tough situation today, having to cope with COVID-19 while ensuring economic development and livelihood.

However, ignoring global stability and livelihood concerns, the U.S. has imposed a series of unilateral sanctions against Russia and forced other countries to obey them through the threat of secondary sanctions. Its practices of weaponizing its economy, economic hegemony and financial terrorism have triggered widespread concerns of the international society, and are condemned by many countries.

Since the outbreak of the Ukraine-Russia conflict, the U.S. has made every effort to avoid direct military engagement. However, by providing massive military assistance for Ukraine and imposing sanctions, it has launched hybrid warfare against Russia.

The U.S. not only imposed Russian sanctions on government officials, but also excluded a number of Russian banks from the SWIFT (Society for Worldwide Interbank Financial Telecommunication) messaging system, the main system underpinning global financial transactions. Besides, it has frozen the assets of Russia's central bank, placed new debt and equity limitations on Russian enterprises and entities,

imposed bans on the exports of over half of its high-tech products to Russia, and prohibited the purchase of petroleum and natural gas from Russia.

The facts demonstrate that the target of these unprecedented sanctions is not a truce, but rather the militaristic and economic annihilation of Russia. Even after positive signals were released from the new round of negotiations between Russia and Ukraine held on March 29, the U.S. and its allies still said they would keep intensifying sanctions on Russia. It's fair to say that the Ukraine crisis once again

revealed the true colors of the "sanctions superpower" - to safeguard its hegemony by fair means or foul and at the expense of the interests of all the people in the world.

Driven by economic hegemonism, the U.S. implemented comprehensive and indiscriminate sanctions, which impeded global economy and hurt the people.

Kristalina Georgieva, managing director of the International Monetary Fund (IMF) noted that the war in Ukraine and massive sanctions against Russia have triggered a contraction in global trade, driving up food and energy costs and forcing the IMF to lower its global growth forecast. According to Oxford Economics, the sanctions against Russia may bring down the GDP in the Eurozone by 0.5 percentage points before the end of 2023.

It is obvious that if the U.S. further escalates its sanctions, a major crisis may hit global trade, finance, energy, food, and industrial and supply chains, wreaking havoc on the already slow global economy.

Plundering the world with financial terrorism, the U.S. has exacerbated global poverty and inequality. The middle-income trap in Latin American countries, Japanese economic crisis and Southeast Asian economic crisis were all related to American financial hegemony. The number of sanctions imposed by the U.S. has surged tenfold during the past 2 decades.. Economic and financial sanctions are what the country constantly resorts to.

Recently, the White House unfroze and embezzled \$7 billion in Afghan funds in U.S. banks, sparking protests in many places across Afghanistan. Such practice was called a bare robbery. Today, freezing the assets of Russia's central bank, the U.S. is once again making the rules of international finance a tool for it to plunder others. The U.S. will definitely

itself hurt upholding economic hegemonism and financial terrorism. Chief Economist of Euro Pacific Capital Peter Schiff believes that the U.S. would suffer a long-term consequence of turning the U.S. dollars into a weapon with sanctions, which will cause countries to worry about whether this weapon would be used against them one day. IMF Chief Economist Gita Gopinath said the world would reevaluate the security of taking U.S. dollars as foreign exchanges. Zoltan Pozsar, a senior adviser at the U.S. Department of the Treasury noted the U.S. and other Western countries have shaken the foundation of the existing international monetary system by freezing the assets of Russia's central bank.

Even the allies of the U.S. are trying to mitigate the damaging consequences of U.S. sanctions. An expert pointed out that a crack is appearing in the monetary system from which the U.S. has long benefited, and the Ukraine crisis will hasten the process.

It is neither responsible nor ethically justifiable for the U.S., under the disguise of the so-called "rules," to undermine international order and provoke confrontations with economic and financial hegemony.

The U.S. should immediately discard the Cold War mentality. It needs to see farther and pursue common interests, rather than hegemony and private gains, so as to work with all relevant parties to safeguard the long-term stability and sustainable development of the world.

CBN in its guidelines published on its website said the key objective of issuing PSB licenses was to boost financial inclusion, especially in rural areas and facilitate transactions.

"To enhance financial inclusion in rural areas by increasing access to deposit products and payment/ remittance services to small businesses, low-income households and other entities through highvolume low-value transactions in a secured technology-driven environment," the CBN had stated.

The new move by MTN Nigeria will see it competing with traditional banks and Point Of Sales (POS) operators for market shares.

43% of Nigerian girls get married before age 18, says World Bank

Nigerian girls get married before they turn 18 years which stalls the chances of attaining their full potentials.

It also said Nigeria ranks highest in terms of under five mortality rate in the world.

This was disclosed at the launch of Policy Note by World Bank yesterday in Abuja tagged: Supporting Adolescent Girls to Kick-Start the Stalled Demographic Transition and Harness the Demographic Dividends in Nigeria.

Presenting the policy note, Samik Abdukarim of World Bank, said less than 10% of Nigerian secondary school female finish secondary schools and attend up to higher education as a result of cultural and religious practices, particularly in the Northern part of the country.

Other factors he listed include: High poverty rate in the country and lack of resources, which according to him push young girls into early marriage and high teenage pregnancy.

This development, Abdulkarim said stalls demographic tradition and dividend Process in Nigeria.

Also, he said the trend further exacerbate the poverty ratio in the country and that dependent rate will also continue to go higher as human capital development continues to suffer.

Demographic dividends is the

The World Bank says 43% of economic benefits accrue by a country when it undergoes a rapid declining mortality rate for a rapid declining birth rate, resulting to small and healthier families and ready to address the labour market.

According to him, some of the states in the Northern region of Nigeria have continued to push this figure up, making the country to rank highest in the world.

"Advancement in medical sciences leads to decline in death rate, increase in adult longevity and child survival second stage. Several studies from Nigeria have shown very strong link between declining in fertility rate with increase in economic growth. Fertility in one child can lead to 29% increase income per capital by 2050.

According to the report, Nigeria is one of only 4 countries in the region that has total fertility rate that is higher than 5% and stalled demographic dividend, which is less than 5% per year in the last two decades.

Similarly, one of the key consequences is that Nigeria will continue to have a large number of young dependants in the population in the next 30 years.

The implication is that by 2050, Nigeria will have 1 out of 5 young people within the working age population compared to other countries.





Pfizer raises awareness on adult vaccines

n its quest to curb the menace of infections amongst the Adult population, Pfizer Africa has stepped up efforts towards managing the burden of preventable diseases.

Ône of the steps the global pharmaceutical body has taken is to organise awareness and bring to the fore underlying issues that could affect older persons.

At a virtual media roundtable by Pfizer recently, discussions centred on the need for vaccination in adults and the burden and management of vaccine preventable diseases in older people.

Amongst the panel of discussants at the roundtable Professor Olufunke was Olavinka Adeyeye, a Consultant Physician at the Lagos State University College of Medicine Ikeja Lagos and Dr. Ogugua Osi-Ogbu, Chief Consultant and Head of Geriatrics Unit at

the National Hospital Abuja, who emphasised the importance of adult vaccination as well as the challenges and gaps in adult vaccination as these individuals have a decreased immunological response when they are exposed to infections.

According to Prof. Adeyeye there is need for a "systematic review of infections in individuals older than 65 years found that coronary heart disease, diabetes mellitus, and chronic obstructive pulmonary disease, were all associated with significantly higher risk of acquiring pneumococcal infections."

Osi-Ogbu noted that "Pneumococcal disease is an important cause of morbidity and mortality in older adults. Many high-income countries pneumococcal recommend vaccination in older adults but, even where policies are in place, coverage is often low. Very few Low and/or mid-income countries currently provide pneumococcal vaccination to older adults as a part of a routine programme."

Justifying the need for Pfizer's involvement in the forum, Dr. Kodjo Soroh, Medical Director, Sub-Saharan Africa, Pfizer said, "Pfizer has a long history in vaccine research and development. Through the development of innovative delivery systems and technologies, we've created scalable solutions that address prevention of deadly bacterial infections.

"The key to maintaining and building on these advances is constant vigilance and continued access to immunisations is essential to preserving the progress we've made against vaccine-preventable conditions and strengthening our ability to address emerging health threats."

National Grid Collapses Again As Kano, Lagos, Abuja, Others Hits Blackout

It is another blackout in Kano Lagos, Abuja, Katsina and Jigawa States after the national grid collapsed on Friday evening.

At least three Distribution Companies (DISCOs) confirmed the development via their respective social media handles, informing their customers of the situation in their respective domains.

They include Eko Electricity Distribution Company (EKEDC), Abuja Electricity Distribution Plc (AEDC), and Kano Electricity Distribution Company (KEDCO).

While their various updates, they blamed the outage being experienced by consumers in various states and the Federal Capital Territory (FCT) on a general system collapse that occurred at about 6:30pm and 8:50pm.

"Dear Esteemed Customers, we regret to inform you that a system collapse occurred on the National Ĝrid at 6:30pm, Friday, April 8, 2022," EKEDC said in a tweet. "Our partners are assessing the extent of the damage to the National Grid and how soon it will be restored, more information will be provided soon.

"We sincerely apologize for the inconvenience this has caused to our customers and we assure you that we are working on a swift resolution."

AEDC, on its part, sought the understanding of its customers with an assurance that the relevant stakeholders were working to bring the situation under control.

In its update to consumers in Kano, Katsina, and Jigawa States, KEDCO apologised for any inconveniences the outage might have caused.

"We write to inform our numerous customers in Kano, Katsina, and Jigawa States that the current power outage is due to a system collapse on the National Grid.

"Which as a result causes the current power outage on our network. We sincerely apologise for any inconveniences this may cause to our customers," it tweeted.

Despite the government's effort to improve the power supply, major cities in the country experienced blackouts at least twice in March

Accompanied by top officials, including Dr. Magdalene Ajani, Permanent Secretary, Federal Ministry of Transportation and Fidet Okhiria, Managing Director, Nigerian Railway Corporation, NRC, Amaechi lamented the slow pace of work by China Civil Engineering Construction Corporation, CCECC, urging them to come up with the number of equipment and personnel needed to quicken construction of the project.

"The project was inaugurated last year but it is at this level because enough funding was not given to them. Now, they have something that can make them go further from where they are. They have some level of funding and I hope that we secure the loan before they exhaust what we currently have.

"Our expectation is that they get to Enugu by September in terms of track-laying. I think we also need to ask them whether they will be able to construct the stations because there are stations that are yet to be approved by the cabinet. We need to go back to the cabinet to ask for those approvals," he said.

He also harped on the need to provide cover for the workers, saying "I think we need more security here than we currently have, so we don't have any kidnap cases."

On what to expect of the stations along the corridor, Amaechi said: "What we are trying to do in this narrow gauge is to build the same infrastructure that you have on the standard gauge because you can never tell when you will have a standard gauge on this line.

"Now, when building the standard gauge on this line, if I were still the Minister for Transportation, I would have asked that whoever is designing should design it in such a way that they use the same stations. That way, you reduce cost."

On what to expect on his next inspection tour, the Minister noted: "I expect that they should have cleared up to Imo river; I expect that they should have started formation work and they should have gone far, because there is nothing much to do here. It already exists, it is a reconstruction.

"So, I expect that by the time we come back, formation work should have commenced and got close to Elele and should have either got to Imo river or exceeded Imo river, if we must meet the target of September to get to Enugu."

The origin of these so-called unknown or faceless gunmen is allegedly traceable to the military wing of the outlawed Indigenous People of Biafra, IPOB, known as Eastern Security Network, ESN.

2023: Ignoring zoning'll spell doom for PDP — Bode George

Normer Deputy National Chairman of the Peoples Democratic Party, PDP, Olabode George, weekend, warned that any attempt to jettison the zoning arrangement will affect the PDP's chances in 2023.

George, who gave the warning when he met with selected journalists in Lagos, insisted that the PDP will lose the trust of Nigerians if it goes against zoning.

Citing Section 7, sub-section 3(c) of the party's Constitution, he noted that in the spirit of equity, fairness and justice, the PDP must zone the presidential ticket of the party to the South East.

Violence mars Enugu PDP

meeting, lawmaker escapes death Recalling how the founding fathers of the PDP came up with the idea of zoning, he said the leaders took the decision to ensure equity and fairness, just as he urged the National Working Committee of the party not to ignore it.

His words: "So no zone, whether you are minority or majority, will go home without something to show to their people. But when you look at it like that, after eight years, all positions in the South will go to the North and all the positions in the North will come to the South.

"But they never envisaged a situation where you will have another political party that can produce the president. It wasn't in their political equation. And you know we were always boasting that we would remain in power for the next 60 years. But the APC produced a Northern President in 2015."

George, who was a member of the PDP zoning committee, said the zoning committee had only made a recommendation by saying the Presidential ticket should be thrown open, urging the National Executive Committee, NEC, of the PDP "to listen and feel the pulse of the people on the issue."

He said: "When the National hears all the voices coming from the country, and they see that this can break or make Nigeria, maybe some sense will come into the discussion.

"Some people are arguing that President Muhammadu Buhari is not from our party and I laughed and told them that he may not be a member of our party but he is from the North.

"Personally, my view is that the PDP should make a definitive statement that this thing is zoned to the South, so that we will be seen as not only obeying the law of our party, we will appear before that lady of justice blindfolded with the sword and the scale. She doesn't care who you are, the truth will come out and I am saying this for posterity's sake.

"If we start counting from 1960, together with the military era, how many people have occupied this position from the north and how many from the south? We should stop counting from 1999; it is half-measured counting. The party must come out and be honest and say that this thing must go to the south.

"Though, we don't have the power to override our national Constitution which gives every Nigerian the right to contest for any position of the land except you are an ex-convict. We must be strong enough, to tell the truth to power, that is the very fundamental of democracy."

Expressing worry over the lingering crisis rocking the Lagos PDP and other state chapters as a result of the last state congresses held by the party, he urged the National Chairman of the party, Iyorchia Ayu, to as a matter of urgency to revisit these issues with a view to finding a lasting solution.

He warned that failure to adhere to this warning may affect the chances of the party in the states where these crises seem unresolvable, citing Lagos and Kano as examples.

George pointed out that looking into these issues and addressing them on time will prepare the party for the battle ahead.

Lawmaker condemns terrorists' attack on Plateau communities

he member representing Pankshin, Kanam and Kanke (PKK) in the House of Representatives Yusuf Adamu Gagdi, has condemned the terrorist's attacks on several communities in Kanam Local Government Area.

The communities are Kukawa, Kyaram, Gyambau and Dungur, among others.

The lawmaker, in a statement, said he was in Medina for Lesser Hajj along with some of his colleagues when the news of the attack broke.

He commiserated with the families of those who lost their lives and prayed to God Almighty to forgive their shortcomings and grant them everlasting rest. The lawmaker, who is the

Chairman of the House Committee on Armed Forces, said he contacted the Minister of Defence,

General Magashi (rtd), to request immediate military presence in the affected communities and those bordering them in order to arrest the surging activities of bandits in communities within his constituency.

Gagdi flayed the Federal Government's act of negligence to provide security for Plateau communities, despite intelligent reports by the Directorate of State Service (DSS) concerning the influx of bandits into Plateau State and other neighbouring states.

According to him, the Federal Government, which has exclusive control of the security apparatus in the country, has woefully failed in its primary responsibility of protecting the lives and property of Nigerians.

Gagdi said he was going to cut short the Lesser Hajj and return to the country in order to visit the affected communities to console victims of the attacks, provide relief materials, as well as to see for himself the extent of damage inflicted on the communities by the marauders.

He commended Plateau State Governor Simon Lalong for his swift response to the situation.

He stated that even though Lalong has no direct control over the security operatives within the state, his swift action to reach out for security interventions in times of infractions has always been commendable, the lawmaker said.

Gagdi raised the alarm for citizens within boundary communities, particularly in Wase and Kanam local government areas, to be on the alert, as fleeing bandits from Zamfara and other Northwest states are traced to be camping within the thick bushes in the mentioned local government areas.

2023: Southern PDP aspirants clash with Southeast governors

The crisis over the zoning of the presidential ticket of the Peoples Democratic Party (PDP) for next year's election has pitched aspirants from Southeast with two governors from the region.

Four presidential aspirants from the Southeast have complained that Governors Okezie Ikpeazu of Abia state and his Enugu state counterpart, Ifeanyi Ugwuanyi, are working against their aspirations.

The aggrieved aspirants are former Senate President Pius Anyim, former Anambra State Governor Peter Obi; renown industrialis Mazi Sam Ohuabunwa; and United Statesbased medical doctor Nwachukwu Anakwenze.

They have expressed disappointment with the two governors over their alleged support for another aspirant from the Southsouth, Rivers State Governor Nyesom Wike.

The friction between the aspirants and the two governors got to a climax at the weekend when they attended stakeholders meetings on Friday and Saturday where they reiterated their demand zoning to the South.

Ikpeazu and Ugwuanyi had joined four other PDP governors at a meeting on Friday night without inviting the four Southeast contenders.

The Abia and Enugu governors had attended the meeting with Governors Seyi Makinde (Oyo); Wike (Rivers); Duoye Diri (Bayelsa) and Udom Emmanuel (Akwa Ibom), who hosted the meeting in Abuja.

The six PDP governors, had, after their meeting, reiterated their demand for zoning to the South.

However, there were speculations that the governors had adopted a resolution at the meeting to support one of their own, who is also eveing the ticket.

China's Tianzhou-2 cargo spacecraft accomplishes mission and reenters Earth's atmosphere

hina's Tianzhou-2 cargo spacecraft was deorbited and re-entered the Earth's atmosphere underground control according to plan on March 31, Beijing time, after completing all of its scheduled tasks involving key technology verification and extended application tests in orbit for the construction of China's space station.

Most of the spacecraft burned up during the re-entry process, while a small amount of the debris fell into the intended area of safe water in the South Pacific.

The re-entry of Tianzhou-2 into the Earth's atmosphere means that Chinese astronauts sent into space onboard the country's Shenzhou-13 spaceship will also return to the Earth soon.

The Tianzhou-2 is the first cargo spacecraft sent into orbit in the key technology verification phase of the China Space Station, carrying 6.8 tonnes of supplies to the space station.

The regular duration for Chinese astronauts to work and live in China's space station during its operations is six months, which means that crew rotation and cargo replenishment are carried out every six months. Before crew members leave the space station, the cargo spacecraft normally leaves first to take away most of the waste produced during their space life. After Tianzhou-2 cargo spacecraft's recent separation from the space station, China's Shenzhou-13 crew members are preparing for their return to the Earth in mid-April.

Deorbiting and destroying cargo spacecraft that has accomplished its tasks represents another vivid practice of peaceful utilization of space resources, and demonstrates China's sense of responsibility as a major player in space, according to Li Zhihui, deputy commanderin-chief of the Tianzhou-2 cargo spaceship with the China Academy of Space Technology (CAST).

Generally speaking, it is extremely dangerous for an in-orbit spacecraft to hit space junk larger than 10 centimeters. Space junk often makes spacecraft have to change obit to avoid collisions and ensure its own safety, and sometimes severely affects spacecraft's orbital flight missions.

The treatment of space debris faces huge difficulties. It takes years or even decades for space debris in low-Earth orbit at an altitude of 400 kilometers to gradually drift out of the orbit and disappear.

For China, deorbiling its spacecraft that has completed tasks is an inevitable choice.

At the end of their life, low-Earth orbit satellites or other spacecraft descend to lower altitudes with the aerodynamic forces intensifying under the action of atmospheric drag or control system; at this point, the spacecraft can be



considered to have re-entered the Earth's atmosphere, said a designer of Tianzhou-2 with the CAST.

During the re-entry, low-Earth orbit spacecraft travels at a speed of eight kilometers per second. Under the action of aerodynamic heating and forces, the spacecraft gradually disintegrates, and then again, finally burns up, the designer added.

To reduce the risk to ground personnel, the common practice for deorbiting large near-Earth spacecraft is to carry out a controlled re-entry. In this way, it is able to fall out of orbit and into a safe area, which are generally the uninhabited areas in the South Pacific.

China already accomplished the controlled reentry missions of its Tianzhou-1 cargo spacecraft and Tiangong-2 space laboratory in 2017 and 2019, respectively.

The deorbiting of Tianzhou-2 cargo spacecraft according to international practices this time can not only reduce the amount of space debris to avoid hazards to in-orbit spacecraft and the ground and create a safe and clean space environment for other spacecraft, but play an important role in global space environment governance and avoid occupying orbital resources. In the next five years, China will advance the construction of a space environment governance system comprehensively. The country will strengthen space traffic control, build and improve its space debris monitoring facility system, cataloging database and early warning service system, and coordinate the work related to inorbit maintenance of spacecraft, collision avoidance control, and space debris mitigation to ensure the safe, stable and orderly operation of the space system.

"What we are experiencing now is the cumulative effect of the leadership failures over the years," he said.

The vice presidential candidate of the PDP in the 2019 elections said, with the current situation in the country, Nigerians are yearning for "a leader who has the competence, and the capacity to genuinely start tackling the innermost problems affecting our country, starting from the issue of cohesion and unity."

"We are so divided today as a nation. (We have) the issue of insecurity; the issue of the economy, especially tackling unemployment, which is currently at a level that is not acceptable.

"Dealing with the issue of education, power supply, corruption. The list is endless," he added.

Mr Obi also expressed pain that universities are closed down in the country due to the industrial action embarked upon by the Academic Staff Union Of Universities (ASUU).

He said it is unfortunate that politicians are discussing the 2023 elections even when Nigerian students are wasting away at homes due to the industrial action, adding that the situation was another evidence of leadership failure in the country.

"Our universities are closed for months and we (political leaders) are not even talking about it. Rather, we are talking about the next elections

"It is painful. Our children are at home at this time when education is the most critical asset for tomorrow, " he added.

He contended that the Nigerian government would have fulfilled the agreements with ASUU if they placed enough value on education.

ASUU had embarked on a fourweek warning strike on February 14th and later extended the action by another two months to press home its demands, with the prominent ones being the renegotiation of the ASUU/ FG 2009 agreement and the sustainability of the university autonomy by deploying UTAS to replace the government's "imposed" IPPIS.

2023: Southern PDP aspirants clash with Southeast governors

he crisis over the zoning of the presidential ticket of the Peoples Democratic Party (PDP) for next year's election has pitched aspirants from Southeast with two governors from the region.

Four presidential aspirants from the Southeast have complained that Governors Okezie İkpeazu of Abia state and his Enugu state counterpart, Ifeanyi Ugwuanyi, are working against their aspirations.

The aggrieved aspirants are former Senate President Pius Anyim, former Anambra State Governor Peter Obi; renown industrialis Mazi Sam Ohuabunwa; and United Statesbased medical doctor Nwachukwu Anakwenze.

have They expressed disappointment with the two governors over their alleged support for another aspirant from the Southsouth, Rivers State Governor Nyesom Wike.

The friction between the aspirants and the two governors got to a climax at the weekend when they attended stakeholders meetings on Friday and Saturday where they reiterated their demand zoning to the South.

Ikpeazu and Ugwuanyi had joined four other PDP governors at a meeting on Friday night without inviting the four Southeast contenders.

The Abia and Enugu governors had attended the meeting with Governors Seyi Makinde (Oyo); Wike (Rivers); Duoye Diri (Bayelsa) and Udom Emmanuel (Akwa Ibom), who hosted the meeting in Abuja.

The six PDP governors, had, after their meeting, reiterated their demand for zoning to the South.

However, there were speculations that the governors had adopted a resolution at the meeting to support one of their own, who is also eyeing the ticket.

Governors Wike and Emmanuel purchased the PDP have

presidential nomination forms. Also, Wike has intensified with consultations

stakeholders in recent times. Piqued by the actions of the two governors, the four presidential aspirants have also called a meeting on Saturday where they demanded zoning to the Southeast.

The meeting, which held at a popular hotel in Asokoro District, Abuja, was attended by all the four aspirants.

Anyim, who addressed reporters after the meeting, was diplomatic when asked if the four aspirants were working in tandem with the PDP Southern governors that met the previous day.

He asked reporters to direct the question to the PDP Southern Governors.

Anyim said: "Whatever they (PDP Southern governors) are doing or whatever they are not doing is not necessarily before us. So, when you meet them in their own meeting, you can ask them.

Tinubu meets with APC Govs over 2023

Il Progressives Congress (APC) presidential aspirant Asiwaju Bola Tinubu on Monday met with Governors elected on the platform of the All Progressives Congress (APC) in Abuja to seek their support.

The meeting, which took place at the Kebbi Governor's Lodge, Asokoro, Abuja, lasted for about an hour with 12 Governors in attendance.

He said: "Asiwaju Bola Ahmed Tinubu, this morning, met members of the Progressive Governors Forum where he stated what he has made public already – his intention to seek for the office of the President come 2023 which he has already announced publicly. He briefed us on his reasons, his thinking and his message.

"All the Governors in attendance graciously came to listen to him. He acknowledged the role of the Governors in the last convention of our party, where, according to him, the Governors of the party steadied the party by helping in the evolution of the leadership that is accepted and widely acknowledged as that which we wish for our party.

"We appreciated him, and his message and will discuss the message at one of our forum meetings." The PGF chairman faulted insinuation that the presidential ambition of Tinubu and Vice President Yemi Osinbajo may be putting the Governors in a tight corner.

Rather, he said their aspirations have further thrown up APC as the choice party with an array of capable hands showing interest to lead the country.

According to Bagudu: "On the contrary, we appreciate our party because it has become a party that has endeared itself to Nigerians.

"We have many brilliant people in our party, some serving and some not serving. The fact that we have people in our party that express a desire to lead the party into the highest office in electoral contests shows how much our party has resonated with Nigerians and our party members.

"For us, it is a hallmark of success that people are showing interest but at the end of the day and because they are leaders of the party, they will always put the party's interest at heart."

On the possibility of the party adopting a consensus candidate for its presidential flag bearer, the PGF Chairman said the party will adopt the best option insisting the party always goes for the best.

"Don't forget that in the 2015 presidential election primary, President Buhari contested against several others and it was a beauty contest.

"There is nothing wrong. Members of the party always want to see consensus if it is possible but we are a democratic party.

"In our last convention, we had consensus in some of the offices and election in some others. There is always misrepresentation of consensus as if people are being snowballed into positions they would rather not take."

igeria's response to the onset of murderous mass violence has evolved through phases of co-optation, brutal reprisal, appeasement, and state incapacity. The two options that have never quite been attempted with conviction effective accountability are and civic inclusion. Through anti-terrorism, phases of counter-terrorism and, now, interminable and metastasising counter-insurgencies, the country has found itself mired in chronic mass violence as the only language of political dialogue. With many reluctant to acknowledge how the country quite ended up in this denouement, it is important to look back briefly in order to look forward.

Outlawry in post-colonial Nigeria has a long and tawdry history. Stephen Ellis, who spent a lifetime researching and analysing this in some detail, recounted in his final book, This Present Darkness: A History of Organised Crime in Nigeria, when the spike started: "shortly before the civil war, when government broke down in some parts of the Western Region and there was a blurred line between political violence, crime, and organized insurgency." Many would argue that Nigeria has been one long insurgency since then, in what has been - on close inspection - a long war against the logical consequences of chronic leadership failure.

The post-war continuation of the error that we can shoot our way out of this failure of both leadership and national inclusion, can be traced back to the public executions by firing squad of armed robbers, which began at the former Bar Beach in Lagos on April 26, 1971. The spike in armed robbery in Nigeria coincided with the mismanagement, by the Yakubu Gowon regime, of demobilisation in the aftermath of the Nigerian Civil War. With neither preparation for post-military life nor skills to survive in the rough and tumble of civilian existence after the war, the tens of thousands of hurriedly demobilised men found alternative uses for their arms and skills, often not in the most civil way possible. Public execution did not end armed robbery. If anything, violent robbery escalated in both frequency and brutality.

The onset of presidential politics in 1979 did not just make civilians of soldiers, it also made civilians of armed robbers, who provided the violent brawn to complement the political brains of politicians in savage electoral brigandage. The numbers confectioned by this criminal tag-team, as acknowledged by the Bolarinwa Babalakin Judicial Commission of Inquiry into the Federal Electoral

The curse of an incapable state

By the beginning of this century, the police and security agencies in Nigeria had come to adopt the methods of the people whom they were supposed to hold accountable.

Commission (FEDECO), often received judicial benediction from election tribunals. Senior Police officers, including former Inspector-General of Police Sunday Adewusi and former Police commissioner in the old Anambra State, Bishop Eyitene, both now sadly late, compiled infamous records of electoral joint enterprise with these merchants of violence.

With the return of the military to government in 1983, we had a gradual escalation of violence to the point where, by the mid-1990s, the regime General Abacha fully of deployed criminal gangs and networks against peaceful civic advocacy in the Niger Delta. In institutions of tertiary education, vice chancellors in various universities and rectors of polytechnics did the same. By the time the country returned to civil rule in 1999, the politicians were happy to resume their marriage with violence and its unlicensed suppliers. This time, as former senator, Shehu Sani, recalls in the title of his book, in addition to using them to rig elections, they were also freely deployed as tools of political assassination.

When the Police liquidated a little known Islamic Cleric, Mohammed Yusuf, and hundreds of his followers Maiduguri, North-East in Nigeria, in July 2009, they did not realise how swiftly or steeply the violence would switch gears. Law enforcement, hitherto used to deniable means of committing such atrocities, had become fully converted to the methods of outlawry. The blowback ended any pretence to

a law enforcement response to Nigeria's violence and launched the country into an interminable season of mass atrocities.

In 2011, President Goodluck Jonathan, embattled in the North-East, invited a blueribbon panel to help the country understand the issues and think through its options. To lead this task, he tapped Gaji Galtimari, a former public administrator and diplomat and leader of the Borno Elders Forum, who died in 2019. When it reported at the end of 2011, the Galtimari Committee "traced the origins of private militias in Borno State, of which Boko Haram in particular is an offshoot, to politicians who set them up in the run up to the 2003 general elections. The militias were armed and used extensively as political thugs. After the elections and having achieved their primary purpose, the politicians left the militias to their fate since they could not continue keeping them employed. With no visible means of sustenance, some of the militias gravitated towards religious extremism, the type offered by Mohammed Yusuf. Galtimari Report The

recommended the that government should "beam their searchlight on some politicians who sponsored, funded and used the militia groups that later metamorphosed into Boko Haram and bring them to justice." In its White Paper issued in May 2012 on the report, the Federal Government accepted this recommendation and directed the National Security Adviser to co-ordinate compliance. One decade later, nothing has come of this recommendation.

Instead, what followed has been a descent into sovereign abdication followed by capitulation. Three years later, in 2015, the crisis in North-East Nigeria had become a source of earnings, not merely for elements in the security services but also for mercenaries imported by government and paid with public funds. This, notwithstanding that Nigeria was one of the prime movers behind the Convention for the Elimination of Mercenarism in Africa adopted in 1977, which criminalises mercenarism and renders liable to punishment all persons involved in it.

As candidate in 2015, Muhammadu Buhari cashed in on this and promised to provide the kind of leadership to end it. Far from keeping his word, Buhari doubled down on the abdication, and scaled it up to capitulation before replacing it with the bare-faced coddling of terror and insurgents. This appears to have led the rest of the country to the conclusion that insurgency was the only path to dialogue. So, from the North-East, mass violence has been replaced by an epidemic of mass atrocity and from the North-East, the sites of these atrocities under him have spread to all of the country.

As The New Humanitarian memorably reported around the time of the Galtimari Whitepaper, the conclusion was inescapable that "Nigeria's criminal justice system has failed under the strain, with security force abuses not being investigated and those responsible for Boko Haram attacks not being prosecuted."

One decade later, the situation is inestimably worse, not better. In what looks like an ultimately doomed effort to divert attention from capitulation to mass atrocity this past week, the Chief Judge of Nigeria's Federal High Court issued new rules directing that all terrorism trials "shall be held in camera." This is a breathtaking assertion by one judicial officer of power to re-write with administrative ink the clear provisions of the Constitution and of international treaties on human rights to which Nigeria is party. Section 36(4) of that Constitution requires that every accused person is "entitled to a fair hearing in public" and the only person or authority who can order trials in camera is the trial judge before whom the person is charged under section 36(4)(a) or "the court or tribunal" before whom the accused is charged.

Indeed, in its 2017 Report, the Justice Biobele Georgewill Presidential Investigation Panel on the Compliance with Human Rights Obligations and Rules of Engagement by the Nigerian Armed Forces, insisted, in a recommendation accepted by the Federal Government, that "an arrest under the Terrorism Prevention Act 2015 as amended or any other Acts of Parliament, must be followed by expeditious prosecution

within a reasonable time before a court of competent jurisdiction as prescribed by the provisions of Chapter IV of the Constitution of Nigeria 1999 as amended." As important as his office is, the Chief Judge of the Federal High Court lacks powers to blithely amend the Constitution or so cavalierly expropriate rights granted by it.

This mis-step by the Chief Judge of the Federal High Court is the latest in a series of symbolic acknowledgements of the far-reaching collapse of state capacity to guarantee that most basic affirmation in section 14(2)(b) of the 1999 Constitution that, "the security and welfare of the people shall be the primary purpose of government." By the beginning of this century, the police and security agencies in Nigeria had come to adopt the methods of the people whom they were supposed to hold accountable. Two decades later, the courts appear keen converts to outlawry in a pretence to fight outlaws. The politicians and their families had for long lived by the mantra that all is fair in the rat race to power. With all of Nigeria's rulers so committed to denuding it of legitimacy, is it little wonder that the curse of state incapacity in Nigeria is delivering that which communism failed to deliver – a proletarian Nirvana – in which all are joined by the assurance of painful death in mass atrocity or decapitation following mass abduction? 2023 will be interesting.



FCTA flushes out 150 Beggar of Abuja, to repatriate 1,000 more

The FCT Administration has evacuated about One hundred and fifty (150) beggars and destitutes from the major streets of Abuja, the Federal Capital Territory(FCT), for allegedly constituting nuisance and disturbing the peace in the city.

The beggars mainly women and children including old men were carried out at the weekend , by officials of the Social Development Secretariat (SDS) in collaboration with the Abuja Environmental Protection Board (AEPB), Directorate of Road Traffic Services, FCT Security Department and office of the Senior Special Assistant to the FCT Minister on Monitoring, Inspection and Enforcement.

The exercise was following FCTA's renewed clampdown on street begging in the nation's capital of complaints about the menace of street begging.

The team picked up the beggars from streets having shopping malls, supermarkets, Mosques and other notorious spots for alms begging within Maitama, Wuse II and Garki and other areas of the city.

After profiling them, they were later given Iftar meal to break their Ramadan fast in the evening, by the FCT administration.

The Secretary Social Development Secretariat (SDS), Hadiza Mohammed Kabir, who revealed that the FCTA is targeting to evacuate between 400 to 1,000 beggars from the city, said the FCT Minister of state had embarked on removing beggars from the streets and



cleaning the environs of Abuja.

She added that by by the time they finished evacuating beggars and camping them in some of FCTA centres, for proper documentation, the Minister will liaise with all the governors of their states of origin, and thereafter, they will be repatriated back their respective states.

"As you are seeing today, the Minister has just sent a strong and sound warning through me as the leader of this team to them that they should go off the streets, because we are coming out massively for them."

"The minister has already sent them food and drinks to eat and break fast in the evening, but we are coming for them if they don't leave the streets, as they stop begging on the streets of Abuja", the SDS Boss reaffirmed."

The secretary however announced a ministerial pardon by the Minister of State for those evacuated during the weekend with a strong warning that they should not return back to the street.

Meanwhile, the Senior Special Assistant to FCT Minister, on

Monitoring, Inspection and Enforcement, Ikharo Attah, noted that what the FCTA did was to evacuate the beggars from the streets and take them to a safe place, profile and ensure that they are that most of them are well catered for and subsequently repatriated.

Attah said, "During the month of Ramadan where most of Muslim brothers and sisters are devoting themselves to the service of Almighty Allah, we saw excessive beggars who from across the country flooding into FCT so we had to move them off the streets, sensitive areas where they gather in large numbers to beg for alms, and in the process they disturb people, and the complaints came in, and we moved in and cleared them in a friendly manner that most of them very happy about."

We are promising that we will take

them back to their respective states, so that they would actually leave the streets. But with the pardon by the Honourable minister of state it is now left for them to vacate the streets,Attach said

The veteran defender's first season at Paris Saint-Germain has been plagued by injury but he hopes to spend a few more seasons at the top level

Sergio Ramos hopes to continue playing at football's top level for up to five more years.

The 35-year-old joined Paris Saint-Germain from Real Madrid last summer after his contract with the Spanish giants expired.

But the Spain international's time in France has been plagued by injury, limiting him to to just seven appearances in all competitions this season.

Ramos' issues have sparked suggestions he could leave PSG after just one season at the club, but he insists he wants to see out his contract with the organisation and spend even more time playing in a top league.

"I would like to play between four and five more years at the top level and then live another experience," the centre-back told Amazon Prime.

"I have two years at PSG, we will try to do three and then we'll see. As long as my physical condition holds up, I think I can keep my mind focused.

"I prefer to play in the best team in the world than to be the best player because in the end football is a collective sport and it is about winning as a team.

"Before being the best in the world, I prefer to play world championships, Champions League. And for everything, you always need the work of the team."

Ramos made his sixth Ligue 1 appearance on Saturday when they beat Clermont 6-1.

It is the first time he has completed the full 90 minutes for PSG since January 23, when they beat Reims 4-0.

Since then, the defender had been out of action with a calf injury. Earlier in the season he had been kept out by a previous calf injury

"I knew he was going to pass the ball inside," he continued.

Emery: Villarreal's respect for Bayern Munich must be enormous in second leg of Champions League quarter-final

The Spanish side have a 1-0 lead from the first leg of the tie but the coach has warned

that they must be cautious Villarreal coach Unai Emery has warned his team to show "enormous" respect to Bayern Munich when they meet in their Champions League semi-final tie this week.

Villarreal beat the German giants 1-0 in the first-leg in Spain last week and travel to Munich to conclude the tie on Tuesday.

But Emery has warned that his team cannot underestimate Julian Nagelsmann's side and admits that the clash will be the most difficult of his coaching career.

Salisu: Ghana World Cup legend Asamoah Gyan backs Southampton star's call-up

The former Sunderland attacker believes the centreback will be a good addition to the Black Stars for Qatar

Legendary Ghana striker Asamoah Gyan would welcome Southampton defender Mohammed Salisu into the Black Stars set-up ahead of the World Cup should the centre-back avail himself for national duty.

The 22-year-old, who has refused to play for Ghana, has become a major subject of discussion, particularly following the Black Stars' qualification for the global showpiece.

Although he has turned down

invitations to the national team so far, there have been reports that the World Cup qualification is likely to soften his stand. However, a section of Ghana fans have questioned the player's level of commitment to the country and if he deserves a place in the squad to Qatar.

"Why not, he is not only the best defender in the Premiership, but the Premiership is also the best league in the world," Gyan said on Peace FM when asked whether the Southampton man should be considered for the World Cup.

"If he is rated among the top three defenders, definitely he is eligible to play for the national team if only he is in the plans of the coach and he [Salisu] has it in mind to play [for the country].

"Definitely, he should be ready for the national team, but it will depend on him and the technical team."

Ahead of their World Cup qualifying play-off clash with Nigeria last month, Ghana caretaker boss Otto Addo held another meeting with Salisu with the intention to convince the defender to change his mind.

The centre-back, however, rejected the call one more time. "I watch him as a fan because he is doing well at Southampton," Gyan added.

"I think he is one of the top three defenders in the Premier League and he being a Ghanaian, I think he is selling the country.

"He is performing well but I don't know if he wants to play for the national team."

Salisu has been hailed as one of the best defenders in the Premier League this season, as he currently stands as the player with the most interceptions so far.

He has made 29 league appearances for the Saints this term, starting in all but one of the matches.

Asamoah Gyan: Former Sunderland ace reveals Suarez assault thoughts

The Ghanaian opens up on his encounter with the Uruguay star after the 2010 World Cup in South Africa

vs Liverpool

Former Sunderland striker Asamoah Gyan has revealed he once considered physically assaulting then Liverpool attacker Luis Suarez as payback for Ghana's 2010 World Cup heartbreak at a Premier League game.

With the score at 1-1 in extratime, Ghana almost scored a dramatic last-gasp winner but for Suarez, who handled a goal-bound Dominic Adiyiah header, conceding a red card and a penalty which Gyan struck against the woodwork before the South Americans went on to clinch a 4-2 penalty shootout victory.

"I remember a game between Sunderland and Liverpool. We were playing at home on that day and all players were shaking hands. I wanted to hit him [Suarez] because people had said things that stuck in my mind," Gyan, currently unattached, told Peace FM on Monday.

"I was naïve at that time but when I thought about it later, I realized that I had to let it go because I would have done the same thing if I was in his position."

Had Suarez not handled or Gyan scored the resulting penalty, Ghana would likely have won the game to become the first African nation to reach the semi-final of the World Cup.

At the time of the World Cup, Suarez and Gyan were on the books of Ajax and Stade Rennes, respectively, before securing transfers to Liverpool and then Premier League side Sunderland.

In 2012, the Ghanaian went on to become captain of the Black Stars, leading the side to the 2015 Africa Cup of Nations final where they lost to Cote d'Ivoire on penalties, a shoot-out the striker watched from the sidelines.

"As captain [of the Black Stars], I'll say it [my biggest regret] was in 2015 [Afcon] when I asked to be substituted against Ivory Coast in the final," Gyan said. "I feel like if I was not substituted,

"I feel like if I was not substituted, I could've helped in the penalty shoot-out. But due to some things that were going on, I felt I needed to give the chance to another player.

However, despite criticizing the Egypt captain for his struggles in the opening half, Shearer went on to laud him for the impact he had, when he set up Sadio Mane for the leveler moments after the half-time break.

"At half-time, I looked at some of Mohamed Salah's numbers: no shots, no crosses, no dribbles completed, and far too many examples of giving up possession," the now 51-yearold told the Athletic. "By his own standards, he was pretty awful; and then he comes onto the pitch and shapes the perfect pass that sets up the equaliser."



The Pharaohs attacker has now gone five matches in all competitions without a goal, but the ex-England striker believes it is just a matter of time before the 29-year-old gets back to his best. "Greats like Salah can never be written off and it's only a matter of time before he gets back on the goal trail. He can pull brilliance from nowhere," Shearer concluded. Leaders in political parties should stop any action or inactions that are undemocratic and unlawful, which are the basis of conflicts within the party.

Democracy thrives with the rule of law. The fundamental principle is that the law is always supreme and must be the guiding spirit of all actions in public life. Those who fail to abide by the letter and spirit of the law get punished. If a law is found wanting or repressive, using the instruments of the legislature or judiciary, the law is interpreted, amended, or repealed. The Constitution is the bedrock of the law, and any rule or law that conflicts with the Constitution is null and void and of no effect. These are the foundations on which our democracy is built. Instead of abiding by these principles, politicians, political parties, and power wielders act rascally and abuse the law with impunity. Little wonder, the Independent National Electoral Commission (INEC) recently warned all political actors and parties to comply with the Constitution, the Electoral Act, the provisions of their own party constitutions, and the guidelines they (INEC) have issued.

Is there anything in our genes or natures that says we cannot obey rules? From historical antecedents, Nigerian political parties and political elite have little or no room for compliance with rules, laws and statues; and I mean any law at all. Nigerian political parties can pass for a good study in lawlessness and rascality. Partly, this may be why there is increased judicial intervention in our politics, both in internal party affairs and in electoral outcomes.

In our democracy, political parties are supposed to be vital institutions that provide the platform on which people participate in politics. Using a football analogy, political parties are like football clubs where all members share the same hope and aspiration that their clubs succeed in football games and tournaments. Each club creates its brand, ideology, and essence and puts in place the administration to select, coach and mobilise a team to compete effectively in football tournaments. So, the club is not just a vehicle for winning football games but an institution that represents an ideology, a way of life and the collective vision of its members and supporters.

Likewise, political parties are not just vehicles for winning elections, but critical institutions of democracy built on solid values, ideologies, and visions. As a critical democratic institution, a party must allow rules and laws to guide the power struggle. When this is not the case, anarchy is inevitable.

Parties must never cherry-pick which rules or laws to comply with and which ones to jettison. This flagrant disregard for the rule of law and even their own constitutions as political parties, has led to great distrust by the people and it is part of our perennial leadership malaise. No matter what political party leaderships say, Nigerians are sceptical that there is no place for rules in politics in this part of the world. At least, this is what the political actors have sown in the minds and heads of citizens. Nigerians now believe that politics is a game with no rules, and which is not fit for anybody with a modicum of a moral foundation.

lawlessness and impunity This exhibited by parties force the exclusion of capable leaders from joining politics. It is disturbing that whenever I discuss with great private sector leaders the importance of joining politics to increase the quantity and quality of leadership in our political space and enrich our democracy, and better the lives of our people, they often come back with "this your Nigerian politics is too dirty and uninspiring for us". The famous social scientist Professor McKenzie probably had Nigeria in mind when he warned several years ago that "if the rules limiting the struggle for power are not observed more or less faithfully, the game will disappear amid the wreckage of the whole system".

However, Nigerian parties are victims of society's rascality, which started in the military era, but they have gone ahead to perfect the lawlessness and rascality with impunity. Our political parties and stakeholders chose to borrow and adopt a military culture of impunity, by which a tiny clique of influential party leaders believes their interests are above the party rules and the laws of the land. The rules and laws make no meaning to these political overlords, and they breach them, while political parties expect that there will be no consequences for these acts. The rascality of political actors have led to the emergence of judicial rascality, especially on matters of political dispute.

Political rascality is an open invitation to anarchy, which we are yet to realise because the political elite often gets away with it. The established norm is that the rules to which we collectively subscribe guide the right of the individual members of a political party and citizens.

Recently, INEC called on parties not to conduct primaries outside the constituencies for which parties are nominating candidates, in line with Section 84 of the Electoral Act 2022. This rule is clear, and all parties know about it. However, it will not surprise anyone interested in politics in Nigeria when some parties flagrantly begin to break this rule and conduct primaries outside the constituencies for which the parties nominate candidates. In the past, we had examples of party primaries happening entirely outside of the constituencies or sometimes in "unknown" places for the interest of some selfish leaders within the party.

There are many examples where the rascality of parties has cost the parties and their members dearly. The example of Zamfara State All Progressives Congress (APC) is still fresh in our minds. In the Zamfara case, the Supreme Court's decision significantly impacted the electoral system and allowed another incursion of the judiciary into our politics. The parties are still reeling from the consequences of the intra-party conflicts that led to those problems.

I hope all stakeholders would work hard to avert such conflicts and minimise judicial interventions in electoral outcomes. The basics of most intra-party conflicts are the impunity and rascality of the parties and their leadership, and they must reduce these to the barest minimum. They are, in fact, the bane of our democracy.

The rascality of parties is heinous in three significant ways. It is wishful thinking to expect a group of lawless individuals to lead a peaceful and prosperous country on the basis of law and order. No group of individuals, be they a political party or otherwise, can give what they do not have. Besides, if the political parties can disregard their constitutions, ignore INEC guidelines, breach the Electoral Act, and assault the country's Constitution, then democracy is in danger. Furthermore, a political party lacking internal cohesion and discipline cannot successfully administer the state or the people, even if it succeeds in winning elections.

We expect parties to have mechanisms for internal discipline, internal selfcorrection, and internal protection of the rule of law. Nigerian political parties must follow the law. They must provide platforms credible enough to form governments that are peopled by individuals who agree with and abide by the ideology and principles embedded in their operations, have the leadership qualities to deliver the dividends of democracy to all and have an overwhelming desire to obey their own rules and laws, those of INEC, the Electoral Act, and the Constitution of the country. Intra-party conflicts, which often lead to pre-election litigations, are bad omens that do us no good, they subtract from our democracy and are distractions from the serious business of leading and serving the people.

In the end, I recommend that political parties set up mechanisms to ensure that they abide by all the rules and laws guiding their internal systems and external activities, regarding preelection preoccupations, elections, and post-election ventures. Leaders in political parties should stop any action or inactions that are undemocratic and unlawful, which are the basis of conflicts within the party. The personal and selfish interests of leaders must be subsumed, whilst the collective interests of the members must dominate. Nigerians are becoming politically savvy. Recent events show that Nigerian youths are waking up to their responsibilities and mobilising to make an impact. Any party that neglects this fact and goes back to "business as usual" may be creating its doom. In the 2023 general elections, let us say no to party rascality and impunity!
