# PDP Convention: Jonathan's absence unsettles leadership

- \* Party hierarchy worries that former President is dodgy and may have joined the APC

The conspicuous absence of former president Goodluck Jonathan at the just concluded People's Democratic Party convention National increased speculation that he wants to dump the PDP and then vie for the presidential ticket of the ruling APC.

According to observers this may be the reason why he deliberate avoided the justconcluded PDP National Convention in Abuja.

Mr Jonathan said on Friday he was leaving Abuja on Saturday for Nairobi, Kenya, to attend the African Union retreat on the promotion of peace, security and stability in Africa.

According report some PDP leaders believe the former president only used the trip as a "convenient excuse" to stay away from the party convention. "If indeed he was interested in the convention and the affairs of the party, he would have attended briefly and perhaps give a short speech before travelling on Saturday, " one party chieftain advised that. "He could also have sent his former deputy, former Vice President Namadi Sambo or anyone else to deliver a goodwill message on his behalf." Party insiders said Governor Douye Diri of Mr Jonathan's own Bayelsa State, and his Oyo State counterpart, Oluseyi Makinde, met with the former president on Friday to persuade him to attend the convention. Our sources said when Mr Jonathan said he had a scheduled flight to Nairobi, the governors urged him to at least make a brief visit to the convention ground. They also offered to arrange a flight for his trip after the event if necessary. Mr Jonathan declined, When this newspaper contacted Mr Jonathan's media


aide, Ikechukwu Eze, Sunday morning, he requested that the paper send a message to him via WhatsApp. He was yet to respond to the question about Messrs. Diri and Makinde's meeting with the former president as of the time of filing this report. Mr Eze is currently with Mr Jonathan in Nairobi. Prior to the convention, even before the list of Bayelsa delegates was compiled, Governor Diri reportedly met Mr Jonathan to request him to lead delegates from the state to the event. Our sources said Mr Jonathan agreed. Some party chieftains said they suspect Mr Jonathan's heart was no longer with the party. Aside from his absence at Saturday's convention, the former president has not been attending the PDP National Executive Committee meetings, nor involved in the effort to resolve the party's intractable internal crises. There have been speculations that the All Progressives Congress would want to put forward Mr Jonathan as its candidate in the 2023 presidential election.

#### ... As Atiku, Saraki, Tambuwal, Bala, Kwankwaso Square up for PDP Presidential ticket

The race for the 2023 presidential ticket of the Peoples Democratic Party (PDP) has intensified as top northern aspirants turned the national convention to a campaign ground to test their popularity.

While no candidate has expressed interest for position from the south, top contenders are lining up from the north as a result of the party's position on zoning.

Top contenders for the PDP ticket who didn't hide their intentions to contest for the party's presidential tickets are: former vice president Atiku



Abubakar, Sokoto State Governor Aminu Tambuwal, his Bauchi counterpart, Bala Mohammed, former Senate President Abubakar Bukola Saraki and former Kano State governor. Senator Musa Kwankwaso. Posters, banners and branded vehicles of the presidential hopefuls were visible within and outside the Eagle Square venue of the PDP 2021 National Convention. Despite promises of a level playing field for all contestants into elective Peoples Democratic Party (PDP) national offices, two unity lists emerged at the venue of the national convention. Unity list, in the party's parlance, is a list of consensus candidates as agreed by power brokers to occupy various party offices through affirmative election. Although both lists indicated that 21 persons have been endorsed by

the party power brokers, the major difference was the position of deputy national champion, which has remain contentious between Prince Olagunsove Ovinlola and Taofeek Arapaja. While of the lists has Oyinlola and deputy national chairman the other list had Ambassador Taofeek Arapaja for same position. However, according to the lists, Senator Iyorchia Ayu and Amb. Umar Iliya Damagum (North) were cleared as the National Chairman. Others are Senator Samuel Anyanwu (National Secretary), Hon. Ahmed Yayari Mohammed (National Treasurer), Hon. Umar Bature (National Organizing Secretary), Daniel Woyegikuro (National Financial Secretary), Stella Effah-Attoe (National Women Leader) and Mohammed Kadade Suleiman (National Youth Leader). The

Ologunagba (National Publicity Secretary), Okechukwu Daniel (National Auditor), Arch. Seteonji Koshoede (Deputy National Secretary), Ndubuisi David (Deputy National Treasurer) and the Deputy National Publicity Secretary (Ibrahim Abdullahi). According to the document, Chief Ighoyota Amori and Hon. Adamu Kamale got cleared as Deputy National Organizing Secretary and Deputy National Financial Secretary; Hajaja Wanka, Timothy Osadolor, Barr. Okechukwu Osuohaand Hon. Abdulrahaman Mohammed we're given a clean bill of health as the Deputy National Women Leader, Deputy National Youth Leader, Deputy National Legal Adviser and Deputy National Auditor respectively. Before the election some of the aspirants announced that they have stepped down for the sake o,f and interest of the party. While the party has yet to take an official position on where its 2023 presidential ticket will be zoned to, it was learnt that the party is set to throw it open for all aspirants. Although none of the northern presidential hopefuls have openly declared their intention to contest the 2023 election, their supporters besieged the venue of the national convention yesterday to project the popularity of their benefactors. Dressed in colorful attire, they hailed their preferred candidates as they danced and moved round the venue of the 2021 Convention, tagged "Nigeria Rescue Mission", yesterday at the Eagle Square, Abuja. Supporters engaged in a subtle contest to out-cheer opposing camps. Supporters of the former vice president, the 2019 Presidential candidate of the PDP, Atiku Abubakar were seen with his posters with inscriptions like "2023, Atiku is the answer", "I stand with Atiku" and "2023: Support Atiku" and dancing from one end of the convention



## **EDITORIAL**

# The unending violence and killings in South-East

he worsening insecurity in the South-East, demonstrated in the orgy of killings, is a cause for concern and signposts of an unfortunate collapse of governance, and failure of leadership at all levels in the region.

Worryingly, life has become unacceptably short, brutish, cruel, and nasty in many parts of the South-East. In response, the military has launched an operation in the region. Movements for national self-determination should not depend on violence for their success.

Things came to a head following the brutal killing of Chike Akunyili, the widower of the late Minister of Information and Director-General of the National Food and Drug Administration and Control, Dora Akunyili. In broad daylight, he was assassinated by gunmen.

Akunyili, a medical doctor, was killed alongside his driver and orderly, at Afor Nkpor in the Idemili North Local Government Area of Anambra State. Sadly, the trio was not the only casualty.

Media reports said several people were killed in different parts of the state as a result of the tension created by the political climate and the Anambra Guber elevtions.

The proscribed self-determination agitators, Indigenous People of Biafra, however, dissociated themselves from "the senseless killing of innocent citizens in Anambra State." IPOB claimed it had "raised the alarm that some cruel politicians were hiding under the cloak of the situation in Biafra land to eliminate their political enemies and blame it on IPOB." The security and intelligence agencies, therefore, have their job cut out: Unravel the brains behind the dastardly killings and bring them to justice.

In Akinyuli's case eyewitness claimed that the surgeon was murdered when his vehicle ran into a traffic jam on his way back from Onitsha, where he went to receive an award on behalf of his late wife. The eyewitness said, "The killers attacked

him (Akunyili) when they spotted a policeman in his car. Maybe, they felt threatened when they sighted his police orderly. So, they killed him, the orderly and his driver. They took him to be a politician." This is bestiality at its peak. The security agencies should unravel the mystery behind the breakdown of law and order in the region in recent times.

This spectre of insecurity will devastate the region, known for commerce and industry, and it should be arrested immediately. The solution lies in the hands of the people of the region, both the leaders and the led. The lethargic state governors should rise to the occasion and fashion out well-defined strategies to restore peace and order in the South-East and end the rampant killings.

What is required now, more than ever before, is a united front by the political leaders in collaboration with religious, traditional leaders, opinion moulders and groups like Ohanaeze Ndigbo to confront the menacing insecurity in the region. This is not the time to stand aloof or point fingers if the South-East is to be saved from itself. It is unacceptable that from Abia to Ebonyi, Anambra to Enugu and Imo, the state governors appear helpless in the face of monumental security breaches in their jurisdictions. This is a violation of Section 14(1) of the 1999 Constitution: "The security and welfare of the people shall be the primary purpose of Government."

It is reflective of the leadership quality in the region that an attempt by the five state governors to form a regional security network codenamed Ebubeagu has since been mired in unhelpful politics. It is not salutary that nothing has been heard again of the group since its official formation in May while the region reels in insecurity. Whatever hope raised by the formation of Ebubeagu has since evaporated. The result is that the South-East has no answer to the raging violent occurrences in the region.

ground to another. Also, supporters of Senator Kwankwaso had placards and banners which read: "The People's Choice," which were sponsored by PDP Kwankwasiyya Patriotic Movement. For Tambuwal, his supporters had placards which read: "The Bridge Builder-North East Vision For Tambuwal." The Saraki Support Group had a poster with the inscription, "Saraki Hope For Nigeria". His branded vehicles were also seen around the premises. Kwankwaso and his Kwankwasiyya followers, however, stole the show. Garbed in their white attire and red caps, they marched, in their large numbers, around the venue chanting "Kwankwaso! Kwankwaso!" Kwankwaso himself joined in the march, cheered his followers along. Supporters of former minister of the Federal Capital Territory, Abuja, and governor of Bauchi State, Senator Bala Mohammed, also moved around with posters and flyers of the Kauran Bauchi for 2023. Meanwhile, PDP leaders at the convention took turns to lambast the ruling All Progressives Congress (APC) for misruling Nigeria just as they vowed to salvage the country from the precipice. They accused the party of failing to make an impact since it assumed office because it was built around an individual who is bereft of ideas on what to do with victory. They added that the APC administration had undone all the gains made by Nigeria since it took over power in 2015. While delivering an address at the convention, former Vice President Atiku Abubakar called on the PDP to ensure that it rescues the country from "mismanagement, bad governance, insecurity and disunity," saying Nigeria has been put in bad shape by the ruling APC since it came to power in 2015. The former Vice President who said that the "mission to rescue Nigeria is a collective thing," added that the PDP must position itself to "rescue and restore the dignity, security and economic growth of Nigeria." This is as he asserted that the decision taken at the party's national elective convention would determine the country's future. Speaking also, Senate minority leader, Sen. Enyinnaya Abaribe lampooned the APC for not having any clear ideas on how to manage Nigeria, lamenting that under its watch Nigeria has become the world poverty capital. On his part, chairman of the PDP governor's forum and Sokoto State governor, Tambuwal, said the country is going through trying times. He said, "Our people are in need of policy intervention and leaders that can provide solutions to the challenges of security, unemployment, rising cost of energy, food and other essential items for living a decent life. "We need a strong and smart Nigeria that can provide the leadership that will help sustain institutions capable of promoting collaboration in the areas of security, innovation, trade, investment and defence of our democracy. "Our young

people need a secured, safe and enabling country that will allow them to realise their desires to be educated, employ and deploy their entrepreneurship skills. They need to take advantage of their potential to fulfill their ambitions," he said. While he welcomed new members who joined the party, he noted that more will join. In his welcome address, chairman of the national convention committee and governor of Adamawa State, Ahmadu Fintiri, said: "We have demonstrated our commitment to these time-tested ideals that Nigerians have every reason to trust us enough more than a contraption that was formed solely for the purpose of winning election and around the personal ambitions of certain individuals bereft of the knowledge of what to do with the victory. "The PDP has traversed multiple stages of institutional consolidation that places it far ahead of any other political party in Nigeria. In spite of any setback, the party has remained afloat and waxing stronger with all its statutory organs functioning, from the BoT, the NWC and the NEC. The other contraption cannot boast of the same credentials. "For Nigeria, the present APC-led government is hell-bent on rail-roading the country into multifaceted recession on all fronts. Indeed, the country has never had it this bad. "That Nigeria is better by far with PDP in power is not in doubt: that the people relish those golden moments when the PDP held sway at the centre is not in doubt; that citizens are yearning for the return of PDP at the centre as the 2023 elections draw nearer is equally not in doubt. "We therefore have a duty not to disappoint our teeming supporters. We have to take back our country as we have always done. We have to save Nigeria. If we could force the country out of the clutches of the military, we can do this one huge task: push the people who don't know the true definition of good governance and national coexistence out of power. This is a Nigeria rescue mission. This is the role PDP was invented to play." He said the 2021 national convention presents a starting point for the Nigeria rescue mission. He disclosed that 34 candidates indicated interest to vie for various national positions in the party, out of which 28 were cleared, two withdrew voluntarily and four were disqualified, adding that the Screening Appeal Committee under leadership of Senator Ekweremadu had submitted its report. "I am glad to tell you that this is the least acrimonious convention ever in the history of the party," he said. Speaking on the mode of election and why the winners have to tarry a while before swearing-in, Fintiri said, "While we hope to conduct and declare election results on this convention ground, the winners of today's election must wait till December 9 to be sworn into office. This is to enable the subsisting NWC







members to exhaust their statutory tenure of office and ensure a smooth transition in the party." He also explained why the party is deferring vote on its constitutional amendment, saying, "This convention will also not give us the opportunity to make and adopt amendments to our constitution. This is because we are foreseeing a need for more amendments after the new Electoral Act passed by the National Assembly is signed into law. "We are therefore deferring the votes on constitutional amendments to a special convention to be held on any convenient date to be decided by the NEC," he said. Senate Minority Leader Eyinnaya Abaribe, however, moved the motion for the election to choose a new National Working Committee (NWC) to begin.

In his remarks, the acting national chairman of the party, Elder Yemi Akinwomi, appealed to all party members to come together, bury their personal, individual and collective differences and put PDP and the interest of Nigeria above any other considerations. "We all know the disturbing and uncomfortable condition and situation Nigerians are in today due to our loss of power. The APC ledgovernment is so clueless that Nigerians need a better hand to get them out of this mess. I believe we can do it as we did before," he said. Meanwhile, the party has introduced reforms to improve the process and the integrity of its congresses to reduce incidents of complaints that usually plague the exercise. The PDP equally disclosed the introduction of "pictured ballot papers" containing the photographs of party aspirants at the gubernatorial and presidential primaries to ensure free, fair and transparent primaries. The PDP national secretary, Senator Umaru Tsauri, stated this in a report at the convention yesterday in Abuja. Listing other steps taken, the party said that it had created a computerised party register to ensure control and to avoid fraud. It said that the computerised party register was piloted by a committee headed by the Edo State Governor Godwin Obaseki. According to it, the e-Registration "would be done across the 8,809 wards in the country with Edo, Anambra, Ekiti and Osun states as pilot states."

### Major Stakeholders Call for Suspension of APC Congress in Oyo State

ajor stakeholders of the All Progressive Congress, APC, in Oyo State have called for the suspension of its State

This was announced in Ibadan by a former Senator of the Federal Republic of Nigeria and Chieftain of the party, Senator Ayo Adeseun, during a press conference in Ibadan, Oyo State capital.

The conference which had in attendance, former guber-candidate of the party, Bayo Adelabu; House of Rep member, Tolu Akande-Sadipe; Minister for Sports, Sunday guber-aspirant, Mogaji Dare: Cardiovascular surgeon, Dr. Adeduntan; NCC Chair, Prof. Adeolu Akande; former ALGON Chair, Abass Aleshinloye among other party chieftains condemned the high-handedness of a serving Senator and former Governor of Oyo State, Adebayo Alao-Akala who surreptitiously cornered the party and pocketed its ward and local government delegates lists.

The chieftains called for a suspension of the congress following an alleged forgery of wards and delegates lists by the serving senator and a former governor of the State for their selfish reasons.

Calling for the suspension, Senator Adeseun decried the insensitive manner at which the culprits manipulated the delegates' lists, despite what was sent to Abuja by the State Executives after the legitimate ward and local government

congresses held in Oyo State.

He noted that top-ranking party officials said the call for suspension was in order, adding that the culprits behind the shenanigans do not have the true interest of the party at heart.

Senator Adeseun said the list sent from Abuja for the State congress was in complete variance from what was sent from the State, noting that there is a limit to what the party membership could condone.

He therefore appealed to the National leadership of the party to take up the matter seriously and if need be, limit the list of delegates from Oyo State to the statutory number, according to the party's constitution.

He said, "We received information that the list sent in from Abuja had been tampered with by a serving senator and a former Governor of the State. In order to safeguard the integrity of the process, we appeal to our National Chairman to suspend the State congress until all of this is sorted out".

"We appeal to our National Excos to suspend this process. Oyo is a sensitive state. The National congress could be attended by the statutory list of delegates from the State", he said.

Senator Adeseun added that, "Oyo APC is ready to take over only if we are sincere with our hard earned democracy."

"The so-called State congress has been postponed. We have committed too much to the party, than for anyone to make a fool of us"

# PDP convention: **Secondus rejects Appeal Court Ruling, heads for Supreme**

he embattled National Chairman of the Peoples Democratic Party, Prince Uche Secondus, says he will appeal the judgement rejecting his request to stop the party's national convention.

Secondus had approached an appeal court in Rivers seeking an order of injunction to restrain the opposition party from holding its national convention scheduled for October 30th and 31st.

This was after multiple court orders were issued against Secondus resulting in his removal from office, and Yemi Akinwonmi, deputy national chairman (south), was appointed in his stead.

Delivering judgement on the matter on Friday, a three-member panel unanimously dismissed the application for lacking in merit.

But reacting to the ruling in a statement issued by Ike Abonyi, his spokesman, Secondus said he will appeal the judgement "immediately" to avoid abuse of the party's constitution.

"I have just been briefed of the ruling of the Court of Appeal, Port Harcourt dismissing my motion to halt the National Convention of the party. I respect the position of the court even though I disagree totally with it." the statement reads.

"Even as the substantive case is still pending at the Court of Appeal, I have instructed my lawyers to study the ruling with a view to appealing it immediately as no abuse of the constitution of our dear party should be allowed to stand.

"The issue is not about Prince Uche Secondus but the sanctity of our party constitution and core democratic principles of justice and rule of law, not only in PDP but in our democracy. No impunity must be condoned.

"I will therefore wish to emphasise the fact that I did not take the party to court and would not have done that. As a foundation member of this party who has served at various levels, State Chairman, Chairman of state Chairmen, National Organising Secretary, National Chairman, Deputy Acting National Chairman and now National Chairman, I am very much abreast with the workings of the party. I have been a witness to how much harm litigations have done to our party in the past and as a result I have been a strong advocate against settling issues in

courts.

'This was why I resisted and rejected entreaties of those who wanted me to go to court to halt these forces when it was obvious that they were determined to disrupt my leadership and truncate my tenure in office with the sole objective of hijacking the party for their selfish ulterior motives.

"To allow this travesty to stand is to reduce our beloved party to a level where anybody can wake up overnight and remove officers against the proscribed constitutional process and the National Chairman for that matter. And purporting to use the judiciary through an ex parte order to legitimise same.

"As a major practitioner in our democracy, I am duty bound to protect and defend the sanctity of the provisions of our constitution of which I am the custodian.

"If those who orchestrated and fostered this avoidable crisis had listened to wise counsel of party leaders and elders who advised the withdrawal of cases, this situation would have been avoidable. I wish the party well as always."

# Anambra Guber: 86 Polling Units Don't Have Voters — INEC Reveals

Tith one week to the November 6 governorship election in Anambra State, the Independent National Electoral Commission on Friday said 86 out of the 5,720 Polling Units in the state have no voters.

The commission, however, said it would not deploy personnel and materials to the polling units without voters. The chairman of INEC, Prof. Mahmood Yakubu, said this at a special consultative meeting with political parties in Abuja.

According to him, 894 representing 15.6 per cent of the polling units have between 1 and 49 voters.

Yakubu said, "Understandably, the voters have also been more circumspect in asking for a transfer to polling units. At the same time, the commission did not use its powers under Section 42 of the Electoral Act 2010 (as amended) to allot voters to the new polling units to minimise the disruptions that may occur from such a decision given the forthcoming governorship election.

"Consequently, out of the 5,720 polling units in Anambra State, 86; 1.5 per cent have no voters. For that reason, the commission will not be deploying personnel and materials to these polling units. Furthermore,

894 representing 15.6 per cent of the polling units have between 1 and 49 voters. The election will hold in these polling units."

The INEC boss expressed the

The INEC boss expressed the commission's commitment to work with stakeholders to ensure that all polling units have voters allotted to them ahead of the 2023 general election.

Speaking on the commission's preparation for the election, Yakubu said that all non-sensitive materials had been moved to the 21 Local Government Areas of the State.

He said the Central Bank of Nigeria was handling the delivery of sensitive materials to the State on schedule.

"Our State office in Awka is arranging for stakeholders to inspect the materials at the premises of the CBN in Awka. As is the case in all elections, the sensitive materials are moved under security escort to each Local Government Area from where they are distributed to the Registration Areas or Wards and finally to Polling Units on Election Day", he added.

The INEC chairman urged political parties to present their agents to be on the ground for the inspection of the materials at the CBN.

### PDP crisis being propelled by APC – Dino Melaye

member of the Peoples Democratic Party, Senator Dino Melaye, on Thursday said the All Progressives Congress was behind his party's recent travails.

Senator Melaye made the remark during his appearance on Channels Television's Politics Today.

The PDP's convention, scheduled to hold this weekend, is hanging in the balance due to court battles between erstwhile PDP Chairman, Uche Secondus and the party

Senator Melaye, who is a former member of the APC, said he has no plans of returning to the ruling party.


"No reasonable human being will go back to his vomit," he said. "The APC is a disaster. For every

#### COVID-19: Gov Sanwo-Olu Launches Mass Vaccination Programme Campaign

he Lagos State Governor, Babajide Sanwo-Olu has launched a mass vaccination campaign against COVID-19, as part of strategies to stave off reemergence of the viral infection.

The objective was aimed at vaccinating four million residents in Lagos before the end of the

The immunisation programme was flagged off at an event held in

The governor warned of the possibility of the fourth wave of COVID-19 as the yuletide approaches, saying residents of Lagos, who are 18 years and above were eligible to be fully immunised with the COVID-19 vaccine

The accelerated vaccine rollout is tagged: "Operation Count Me in 4 Million Lagosians Vaccinated Against COVID-19" and is being undertaken by Lagos State government in collaboration with National Primary Health Development Agency (NPHCDA).

The governor believed the mass vaccination campaign would help bolster the State's response to the emerging threat posed by the

Sanwo-Olu said the joint committee set up by the Lagos State Government and the NPHCDA to oversee the implementation of the campaign would be opening vaccination sites in high traffic locations as part of the strategies to expand vaccine access in underserved communities.

Mobile vans, the Governor added, would be deployed to move round boundary settlements in order to reach individuals in areas with limited access to health facilities.

He said: "There is potential for the fourth wave of COVID-19, as our borders would be opened to all people coming into Lagos in December. To prevent the catastrophic events we witnessed in the previous waves, the state has developed a robust vaccination drive, leveraging on both the strengths we have in the public and private sectors our healthcare system. "In development of our strategy counter-measures we prioritise the protection of human lives and keeping our economy open for business.
"Tomitigate against this potential

damage that will further spread existing variants of COVID-19 in the State, and accelerate efforts towards herd immunity, the need for a different strategy became a front burner issue. "This is what has culminated in the campaign, tagged 'Count Me In! 4 million Lagosians Vaccinated Against COVID-19' to target the full vaccination of 4 million Lagos residents before the end of December 2021. Once achieved, this will bring the State closer to reaching our promise to vaccinate 30 percent of our population within one year."

Since March when Lagos started vaccination programme, Sanwo-Olu said the state had successfully vaccinated 800,000 residents with the first dose of Moderna vaccine and 310,000 persons fully vaccinated with AstraZeneca vaccine. This, he said, made the total number of residents vaccinated with the first dose of either AstraZeneca or Moderna 1.2 million, while raising the number of fully vaccinated individuals to 550,000, which accounts for about four per cent of the State's population.

Sanwo-Olu re-emphasised that the vaccines being administered are safe and remain free of charge in public health facilities. The governor, however, said an administrative charge of N6,000 would be paid by individuals who wish to get the vaccines at approved private facilities.

The governor charged all stakeholders, including the local council chairmen, to mobilise for participation in the programme and ensure the success of the campaign.

He said: "We have set up COVID-19 vaccination in all our 205 public primary health centres, 14 of the State's second and tertiary hospitals, and we are hoping that this partnership can be implemented in over 400 private health centres across seven underserved Local Government Areas in the State.

"Let me re-emphasise that we are not compelling anyone to get vaccinated. But, we want everyone to take it as personal responsibility, which is highly important. What we seek to achieve by this campaign is to ensure there is access to the vaccines and availability. Then, give people an opportunity to get vaccinated at centres close to them. This will give nobody a reason not to get the vaccines."

Commissioner for Health, Prof. Akin Abayomi, described the vaccination campaign as "ambitious", saying the State Government had put in place twopronged approach to prevent the fourth wave of the pandemic.

"The first step is to control the in-bound flight passengers and maintain adherence to all preventive measures that have been put in place, while the second step is to closely monitor the isolation of those coming from the red zone area," Abayomi said. On his part, the NPHCDA Executive Director, Dr. Shuaib Faisal, disclosed that only 2,950,232 Nigerians had been fully vaccinated. This, he said was a far cry from reaching the target number for herd immunity.

### Court freezes Benue State Govt. bank accounts over N333m loan

federal high court in Abuja has made an interim order L Lifreezing bank accounts of the Benue state government over its involvement in securing a "N333 million loan" in 2008.

Inyang Ekwo, the presiding judge, gave the order on Wednesday following an ex-parte motion brought by the Asset Management Corporation of Nigeria (AMCON).

He also directed that the bank accounts of HPPS Multilink Services Ltd, a firm, be frozen pending the hearing and the determination of the substantive

While AMCON is the claimant, the company and the state government are first and second respondents, respectively.

According to the order, the affected bank accounts of both respondents are domiciled in Access Bank Plc, Citibank Nigeria Limited, Eco Bank Nigeria Plc, Fidelity Bank Plc, First Bank Nigeria Plc, First City Monument Bank Plc, and Guaranty Trust Bank Plc.

Others include those in Heritage Bank Plc, Keystone Bank Limited, Polaris Bank Limited, Stanbic IBTC Plc, Standard Chartered Bank Nigeria Limited, Sterling Bank Plc, Suntrust Bank Nigeria Limited, Union Bank of Nigeria Plc, United Bank for Africa Plc, Unity Bank Nigeria Plc, Wema Bank Plc and Zenith Bank Plc.

ex-parte motion, in number: FHC/ABJ/ AMC/74/2021 dated and filed on September 30, was moved by Darlington Ozurumba, counsel to AMCON.

In the affidavits in support of the suit, AMCON described the loan as a toxic loan of eligible bank assets transferred to it by law to

AMCON told the court that the first respondent (the firm), which has its office in Kaduna state, had collected a N333 million loan facility from Bank PHB Plc (now Keystone Bank Ltd) on January 31, 2008 "for the purpose of purchasing 5,000 pieces of motorcycles to the 2nd defendant and its workers through the Nigeria Labour Congress of its state vide an irrevocable standing payment order (ISPO)".

"That the 2nd respondent is the state government of the beneficiaries who equally gave ISPO guarantee for the repayment of the loan through deduction from the salaries of its workers and make payment to the bank but failed to do so," the affidavit reads.

"That the loan was for the agreed period of 24 months at the interest of 19 percent per annum.

"That the loan granted to the respondents has crystalised to the sum of seven hundred and eightyfour million, three hundred and forty thousand, five hundred and twenty-eight naira, three kobo (N784,340,428.03) as at 2014 from the sum of N333,000,000 (three hundred and thirty-three million naira) granted to the 1st defendant in 2008 and guaranteed by the 2nd defendant as contained in the letter of Aug. 15, 2014, which represents the interest and the principal sum as at August 15, 2014, and same has remained unpaid till date."

Ruling on the application, the court also made an interim order "freezing and attaching the JAAC Bank Accounts (Joint Accounts Allocation committee), Internal Generated Revenue Accounts, all bank accounts both current, savings, fixed deposits and/or investments accounts of the 2nd respondent (Benue Government) maintained with all the banks mentioned above pending the hearing and determination of the substantive suit".

"An interim order is hereby made restraining all banks and/or other financial institutions above mentioned in Nigeria forthwith from releasing or dealing in any manner howsoever with monies held in any account to which the respondents are signatories pending the hearing and determination of the substantive suit," the judge said.

"An order is hereby made directing all banks and/or other financial institutions in Nigeria to, within seven (7) days of the date of service of this order, file and serve an affidavit of compliance disclosing with statement on each account howsoever designated, held and/ or maintained by the respondents and all accounts to which the respondents are signatories for a period of six months prior to the date of service of this order till date."

The matter has been adjourned till November 2 for mention.

Chairman Independent National Electoral Commission, Prof, Mahmoud Yakubu on Wednesday, confirmed to the Senate, the body's readiness to conduct governorship polls in Anambra.

Babagana Monguno (retd) and Director-General of National Intelligence Agency, Amb. Ahmed Rufai Abubakar.

The statement read: "President Buhari's address is expected to highlight Nigeria's key priorities and action to tackle climate change as well as progress on the country's transition to low carbon economy, consistent with achieving the Paris Climate Agreement.

"The conference, hosted by the United Kingdom in partnership with Italy, will bring parties together to help accelerate action towards the Paris Agreement as well as the UN

Framework Convention on Climate Change.

"Given Nigeria's leading role in taking climate action and as a signatory to the Paris Agreement, COP 26 will afford a unique opportunity for the Nigerian delegation to work with other parties to make progress on the main goals of the conference including securing global net zero by mid-century and keeping 1.5C within reach; adapting to protect communities and natural habitats as well as mobilising the much-needed finances to meet the

### Oyo Govt. Issues Quit Notice to Illegal Occupants of Properties

The couple got married in 1997, had their first baby girl in 2000 and the second, a boy, in 2003. While the girl was named after Joe, the boy was named Abraham after the late Afenifere leader, Pa Abraham Adesanya.

Abdu-Rahman, who advised teachers to place a premium on holistic education to build academic and moral standards, also urged the principals to ensure proper training of every child that passes through them.

While he charged the Principals to ensure that syllabuses are covered within the stipulated terms, as this will aid performance of students in internal and external examinations, the Commissioner reiterated that ANCOPSS has great roles to play at achieving quality education in the state.

According to him, "principals of schools need to show case good leadership examples, because it means a lot. Do not to arrogate your responsibilities to others, in order not to compromise standards schools". in "I also want to encourage you to always look inwards, despite varying challenges, and make positive contributions at improving the Oyo state educational systems".

Schools' Governing On the Commissioner Board, ascertained that SGB is no longer formed based on political patronage as before, but on responsibilities, honesty and commitment, describing old students' associations as responsible, vibrant partners in progress.

Barr. Abdu-Raheem, however, cautioned members of the body on the need to exhibit transparency and shun acts that could tarnish their good names such as collecting illegal fees, doctoring documents and registration of external candidates.

The Commissioner lauded the sterling efforts of Governor Seyi Makinde in restoring the omoluabi ethos in schools, which were on the verge of being eroded or completely lost a few years ago.

Also speaking the National Secretary General of ANCOPSS, Mr Akin Akinade, commended Governor Makinde on the giant strides taken to move education forward in Oyo State.

He also commended the present administration recent recruitment exercise in the State, prompt payment of salaries, backlogs of promotions and benefits, reiterating the support of the body to the administration.

### IYC fault FG over N621bn approved for NNPC to construct 21 Federal Roads

The Ijaw Youth Council and and People's Democratic Party (PDP) stalwart, Chief Sunny Onuesoke, have faulted the Federal Government over the approval of N621bn for the reconstruction/rehabilitation of 21 Federal Roads across the country by the Nigeria National Petroleum Corporation (NNPC).

The IYC and Onuesoke also condemned the lopsided sharing pattern of the roads to be constructed between Northern Nigeria and Southern Nigeria and the exclusion of other vital Federal road particularly in Bayelsa State.

Recall that the Federal Executive Council (FEC) meeting presided over by Vice President Yemi Osinbajo at the Presidential Villa, last Wednesday gave the approval.

At the end of the council meeting, the Minister of Works

Housing, Babatunde Fashola who said the move was a strategic intervention under the Federal Government Road Infrastructure and Refreshment Tax Credit Scheme disclosed that the selected 21 roads covered 1804.6km.

Reacting to the development Onuesoke said it did not make sense for NNPC to spend N621.2bn tax liabilities on road projects, wondering where the money would come from and how they would account for it.

He queried how the NNPC would dip hands into the nation's oil revenue and use funds generated for the nation to build roads rather than paying it into the nation's account and allowing the Federal Ministry of Works to perform its constitutional role.

"It will appear smartly in their books again as a cost in year of expenditure. What is going on here?

"Road construction reconstruction is for the Ministry of Works and Let's borrow Housing. ourselves some sense. This is subject to plenty of fraud.

"If the Ministry of Works and Housing needs money, they should collect from the treasury through budgeting not from NNPC.

"If NNPC wants to contribute national to development, let them pay tax and do CSR with transparency. Has the NNPC taken over the functions of the Federal Ministry of Work? he queried.

He described as amazing how, out of the 1804.6 kilometers of road to be constructed NNPC, only 288.22 kilometers were allocated to the the South while 1,516.38 kilometers of roads went be built in the North, saying it was equivalent to robbing Peter to pay Paul.

# We Rejected RUGA to Secure Benue People's Lives — Ortom

he Benue State Government, Thursday, said it rejected the establishment of Cattle Colonies, Rural Grazing Area (RUGA) settlements and Grazing Reserves or any other plans by the federal government in order to secure the lives of the people of the state.

Governor Samuel Ortom, in a press statement, by his Chief Press Secretary, Mr. Nath Ikyur, however, reiterated that Benue's position has not changed on the matter

He noted that the state government only acceded to the National Livestock Transformation Programme (NLTP), because the National Economic Council (NEC), which has the 36 state governors as members, approved it after a series of engagements and incorporated suggestions by stakeholders from the state.

The governor said with the NLTP, states were at liberty to adopt and implement aspects of the plan that suited their peculiarities, adding that "unfortunately, the Presidency rejected this but would rather continue to dribble Nigerians.

"For us, in Benue State, our peculiarities are that we have a ranching law and in the area of livestock farming, our competitive advantages include indigenous cattle, piggery, goats and fisheries, etc. All these have been captured in the plan and Benue State has accepted the



implementation of the Plan based on these conditions."

Ortom also described as spurious, a statement credited to a former presidential aide, Laureta Onochie, that he was in support of the RUGA plan, saying the state government was listed as one of the states that applied for funds from the federal government for the purposes of establishing ranches.

"We read insinuations in the media, where former presidential aide, Laureta Onochie, tried to give a false narrative about the stand of Governor Samuel Ortom of Benue State on the implementation of the National Livestock Transformation Plan (NLTP).

"Onochie made spurious allegations, painting the picture that Governor Ortom supports RUGA, because the state government was listed as one of the states that applied for funds from the federal government

for the purposes of establishing ranches.

"However, it is clear to us that Onochie is not ready to amend her ways, which is why the Senate roundly rejected her nomination as a Federal INEC Commissioner."

Ortom said it was mischievous for Onochie to drag him into an argument she lacked knowledge about, and advised that if the ex-presidential aide "has any modicum of decency remaining in her tainted pedigree, she should rather commend Governor Ortom for insisting on ranching as the win-win solution to herdsmen attacks on farming communities, which has now been embraced by others states and the federal government."

### DSS denied British envoy, Ezeife access to Kanu in custody, says lawyer

Teanyi Ejiofor, counsel to Nnamdi Kanu, leader of the proscribed Indigenous People of Biafra (IPOB), has criticised the Department of State Services (DSS) for denying Chukwuemeka Ezeife and a British envoy access to his client.

Kanu, who is facing charges of treason, is currently being held by the DSS after he was brought back to Nigeria to face trial.

In July, Binta Nyako, a judge, had ruled that access to Kanu at the DSS should be "regimented".

"But it is not going to be all comers' affair; it will be regimented. You can't get up at night and say you want to visit your client," the judge had said.

But Ejiofor, in a statement issued on Thursday, said the DSS denied access to Ezeife, a former governor of Anambra, and "the British consul". Kanu's lawyer however failed to mention the name of the consul.

He described the action as "clear violation of the subsisting order of court," adding that he will initiate legal action against the leadership of the DSS.

The lawyer said the DSS had earlier denied Bruce Fein, IPOB's lawyer in the US, access to Kanu when he visited on Monday.

"Today was the turn of the British consul to experience what the civilized society may refer to as the height of abnormality in the system," the statement reads.

"The innocent woman who flew all the way from Lagos on this special diplomatic engagement, was denied access to our client and told her that she is not welcome for the visit because she's a foreigner.

"His Excellency, Dr. Chukwuemeka Ezeife who was denied access to the courtroom at the last court sitting was also denied access to our client today without offering any reason(s). Height of impunity indeed!

"It is important to point out here that the order of court with regard to the number of persons and class of persons allowed to visit our client, never restricted them to Nigerians only

"It is more so that this clarification was made by His Lordship, following our specific complaint to the court that Attorney Bruce Fein was not only denied access to our client on two occasions at the DSS Headquarters, but was not allowed inside the courtroom on 21st October, 2021.

"If His Lordship's intention was to restrict foreigners from visiting our Client, the Court would have simply made it clear while responding to our application for clarification.

"Though we have promptly filed another application for the transfer of our client to the correctional center predicated on an entirely new set of facts.

"It is now crystal clear to the world that if the DSS is allowed to remain the custodian of our client, there shall certainly be gross denial of fair hearing and fair trial in these proceedings.

"We will equally be initiating contempt proceedings against the Head of the DSS for this gross violation of court order.

"Order of the court must be obeyed regardless of the status of the person(s) involved or the

agency affected by the order.

"Even though the DSS has a history of flouting court orders with impunity, we will pursue for the Court to step in, in this case and protect the sanctity of its Order(s). Enough is enough!"

# COVID-19: Okonjo-Iweala Harps on Investments in Local Vaccines Production

The Director General, World Trade Organisation (WTO), Dr. Ngozi Okonjo-Iweala has said Africa could no longer rely completely on importation of vaccines and pharmaceuticals given the lessons drawn from the COVID-19 pandemic. She expressed concern that most of the continent's population remained unvaccinated, with only less than five per cent of Africans fully vaccinated compared to over 60 per cent in developed countries.

The WTO DG, who had predicated the economic recovery in developing countries on the availability and access to COVID-19 vaccines, pointed out that the organisation had spent a great deal of time working with manufacturers to invest in emerging and developing countries including Africa.

Okonjo-Iweala spoke virtually at the 49th Annual General Meeting and 50th anniversary of the Manufacturers Association of Nigeria (MAN) in Abuja. She said death dynamics on the continent were worsening with death ratios climbing from an

average of 33.4 per cent in 2015 to over 50 per cent in 2021.

Okonjo-Iweala who spoke on the "Role of Trade in the Post- Pandemic Recovery in Africa," stressed that unequal vaccine access had limited economic recovery especially in developing countries.

She added: "But those at the downward end of the k-shape which include Latin America, Middle East and Sub-saharan Africa lag behind because they don't have as much access to vaccines and the physical stimulus especially in Sub-Saharan Africa." She said intra-regional trade as a percentage of total trade was only 15 per cent in Africa compared to 60 per cent in Asia and 67 per cent in Europe -implying that Africans trade much less with themselves unlike other regions.

She said the pandemic had exposed how dependent Africa is, reiterating the need for the continent to make use of the The African Continental Free Trade Area (AfCFTA) to build pharmaceutical industries and also produce vaccines.

The WTO DG said the prospects

of a unified market of 1.3 billion people offered enormous opportunities for Nigerian businesses that service a whole market of 211 million people.

market of 211 million people.

According to her, "The large continental market which makes investments more attractive in Nigeria can create more wealth and more jobs. "We need to trade more with each other because we can trade more with each other and increase that percentage, we can create more wealth and create more jobs".

She said increased trade remained critical in the recovery of the Nigerian and African economy onto a sustainable upward path. Okonjo-Iweala noted: "We need to reverse our presence on the downward part of this k-shaped recovery and use the recovery from the crisis to increase Africa's share of global trade.

Earlier, President, MAN, Mansur Ahmed said industrialisation and trade were key to economic recovery and sustainability adding that this enable Nigeria compete across various frontiers.

t a recent star-studded symposium in Abuja in which there was an array of about six professors who delivered well researched and empirically verifiable lectures on the desirability and functional necessity of what is called NYSC' Youth Trust Fund, I was ever the more convinced that the idea if it materializes will provide succor to hundreds of thousands of unemployed

Some of these University teachers who spoke on different but interconnected topic of the fundamental objectives for Nigeria putting up a sustainable platform from which creative minded and entrepreneurial youngsters that have had their one year compulsory National Service (NYSC) include Professors Ukerto Gabriel Moti, C.B.N Ogbogbo, Mutiu Matiu Adejo, Okpeh Ochayi Okpeh and

As a philosopher, the specific lecture that tickled my fancy was the one delivered by Professor Okpeh in which he summed up the overview of the imperatives of an NYSC Trust Fund.

Professor Okpeh itemized eight solid and rational reasons why President Muhammadu Buhari and the National Assembly should bring to life a legal framework for the establishment of the NYSC Youth Trust Fund.

Professor Okpeh's eight Professorial and empirical reasons backing the establishment of the Trust Fund for Youth doing the NYSC are as follows: Rapid increase in the population of the country since the decades of the decades after the Nigerian Civil War. From about 60 million in the early 1970s, the nation's population is today above 200million; There has been a steady rise in the demand for formal education across all zones of the country.

He argued that as at September 2021, the country have 170 universities (43 Federal Universities, 48 State Universities, 79 private universities); In addition, the country has 43 polytechnics (17 Federal and 26 state owned). Of course these figures exclude those illegally operating across the country.

In consequence, there has been a steady rise in the population of the youths, considered to be the future of the country, he submitted.

This, he said, has remained a constant factor in the proliferation of institutions of higher learning in the country in the last three to four decades.

Besides, the learned mind affirmed that the number of corps members have also tremendously increased over the decades; From a mere 2,364 at inception, the scheme now mobilizes 350, 000 qualified Nigerian graduates, making it the largest youth social institution in Africa".

Professor Armstrong Mattie particularly thrilled the audience with his presentation which spoke to the issue of necessity to recalibrate the NYSC for the 21st Century nation building challenges just as he justified the call for the establishment of an NYSC's Youth Trust Fund by President

Hear him: The idea of a national service has global roots but every nation creates in which its core national interests are reflected and to which its citizens are committed. The idea of national service is (thus) a critical component of citizens' expressive solidarity with national goals. It has been largely associated with the military service in its primary purpose of

defending the nation.

Okpeh Okpeh identifies three main typologies of national services globally and these include: compulsory military service/conscription, mandatory national service scheme and voluntary national

The mandatory national service is the type in which youths are required to serve the nation for a definite period of time and

they are trained to acquire requisite skills for future challenges. This is the typology in which the Nigeria scheme falls.

The NYSC scheme, he asserted is also an instrument of credible motivation of the nation's youth to patriotic duties, as well as encouraging the movement of labour.

Consequently, the Corps members have had the opportunity of living and interacting with fellow Nigerians of different ethnic and cultural backgrounds, at least for a period of one year.

A second major contribution of the Scheme is in the area of labour mobility just as he noted that through its development policy, the Scheme has been able to reasonably reverse the trend of uneven distribution of high-level quality manpower in Nigeria as the members served in various sectors, especially in the rural. areas. Thirdly, by implication and arising from the training programmes, the Scheme has done reasonable well in instilling discipline, focus and high sense of purpose use in the nation's youth, he affirmed.

The Professor then states that ordinarily, a Trust Fund is a legal entity that holds property or assets on behalf of another person, group or organization. 26 It can hold a variety of assets such as money, real property, stocks and bonds, a business or a combination of many different types of properties or assets. The primary motivation for establishing a Trust Fund is for an individual or entity to create a vehicle that sets terms for the way assets are to be held, gathered or distributed in the future.

He said given the need to recalibrate the NYSC scheme within the intention of keeping to the dictates of the 21st century, and to assuage some the problems challenging the Scheme's vision and mandate, especially to re-activate the NYSC investment platform and uphold and modernize the Skills Acquisition and Entrepreneurship Development (SAED) Programme, the idea of a Trust Fund is a

It will create partial or full financial operations and providing window for drawing capital for the entrepreneurial exploits after the service year.

Also, he stated that the benefits of the fund will include unburdening the government of being the sole financier as presently obtained; reduce the menace of unemployment; curb the increasing rate of crime by meaningfully engaging youths after the service.

The good news is that there appears to be a favourable disposition of the federal government to this proposal, especially the President who is passionate about youth engagement and empowerment, he

For him, the objectives of a Proposed Bill

for an Act to establish the NYSC Trust Fund (NYSCTF) among other things, provides insight into what is expected as it harps on sustainable source of funds for the NYSC for some of the following: Skill acquisition training and provision of startup capital for corps members; Train and retrain the personnel of the NYSC; Develop camps and NYSC formations and provide facilities; Improve the general welfare of corps members and personnel of the scheme. On the mandate of NYSC when viewed side by side with the proposal for a youth trust fund, the professor said: A core mandate of the National Youth Service Corp scheme as enshrined in the NYSC

S. 1(2)(c)The development of the Nigerian Youth and Nigeria into a great and dynamic economy; S.1(3)(d) to enable Nigerian youths to acquire the spirit of self-reliance by encouraging them to develop skills for self employment; S.1(3) (e) contribute to the accelerated growth of the national economy; S1(4)(f) to induce employers, partly through their experience with members of the service corps, to employ more readily qualified Nigerians irrespective of their states of origin. He then stressed that a reading of these subsections indicate that they are most germane to the theme of this symposium which seeks to "consolidate the gains of youth empowerment for national development. It is against this background of her mandate that we seek to locate the need for a Trust and then proceed to interrogate the legal framework for setting up a Trust Fund.

On the State of Youth Unemployment in Nigeria, Brookings submits that Nigeria's population is said to have reached about 167 million people in 2012 (National Bureau of Statistics). The National Population Commission (NPoC, 2013) states about half of the population is made up of youth, defined as individuals between 15 and 34 years of

Unfortunately, as the youth population grows, so does the unemployment rate. In fact, unemployed youth numbered about 11.1 million in 2012. Here we explore a number of trends in youth unemployment in Nigeria and discuss various government programs attempting to address the problem. First, in terms of age, younger youth struggle even more to find jobs: At least two-thirds of unemployed youth are between 15 and 24 years of age. And, in terms of gender, available statistics show that a majority of unemployed youth are female. As shown in Table 1, women accounted for more than 50 percent of unemployed youth between 2008 and 2012.

Brookings presented an analysis of youth unemployment by geographical/ settlement location (rural and urban areas) indicates that youth unemployment is mostly in rural areas and rapidly growing: From 2010 to 2011, the share of unemployed youth in rural areas increased from 47.59 percent to 59.95 percent.

The population of unemployed youth in rural areas rose from 2.9 million in 2008 to about 5.9 million in 2012.

Brooking.Edu also undertook a study of economic programmes and policies adopted in Nigeria to tackle youth unemployment and then says: "Ascertaining policies that have worked in addressing unemployment in Nigeria is rather difficult in light of the incredibly high and rising unemployment rateand at least around 1.8 million youth are entering the labor market every year (Falusi, 2014). Since it is unclear to what extent any given intervention may have reduced the youth unemployment rate in aggregate, it may be more helpful to think of effective policies as those which have delivered on their stated objectives.

The sustainability of a program could also be considered an indicator of success." "Different programs have been introduced by various administrations over time to address youth unemployment, which has been an issue of significant public concern since the days of SAP.

In fact, youth unemployment became the focus of the social policy of the military government that ruled Nigeria for much of its years as an independent nation. The initial reaction of the government was to draft unemployed youth to public programs such as Operation Feed the Nation (OFN) and the Directorate of Food, Road and Rural Infrastructure (DIFRRI), which provided immediate and direct jobs to participants interested in agriculture."

However, we now stand at a threshold of history that would see millions of youths getting involved in wealth creation if the NYSC'S YOUTHS TRUST FUND is established and transparently administered.

The audience at that academic summit acknowledge the fact that the Brigadier General Shuaibu Ibrahim led management of NYSC has performed creditably and could therefore be entrusted with the administration of the much sought after NYSC'S YOUTHS TRUST FUND.

# Gombe government commends EEC for timely completion of road project

The Governor who underscored the importance of the road had said when completed, it would connect the Southern and Northern parts of Balanga Local Government as well as open up many communities around the hilly terrain and boost agriculture.

# SERAP Sues Buhari over Alleged Missing N881bn in 367 MDAs

Socio-Economic Rights and Accountability Project (SERAP) has filed a lawsuit against President Muhammadu Buhari over his failure to probe allegations that over N880 billion of public funds are missing from 367 ministries, departments and agencies (MDAs) to ensure the prosecution of those suspected to be responsible, and the recovery of any missing or diverted public funds.

Joined in the suit as respondents are the Attorney General of the Federation (AGF) and Minister of Justice, Abubakar Malami (SAN), and the Minister of Finance, Budget and National Planning, Zainab Ahmed.

The suit followed the grim allegations contained in part 2 of the 2018 annual audited report by the Office of the Auditor-General of the Federation that N880,894,733,084.811 was

spent by 367 MDAs without any appropriation.

In the suit number FHC/ABJ/CS/1281/2021 filed last week at the Federal High Court in Abuja, SERAP is seeking an order of mandamus to direct and compel President Buhari to promptly investigate the alleged missing funds and to ensure the prosecution of those suspected to be responsible, and the full recovery of any missing, mismanaged or diverted public funds

The suit filed on behalf of SERAP by its lawyer, Kolawole Oluwadare, read in part: "The failure to investigate the allegations of grand corruption contained in part 2 of the 2018 annual audited report constitutes a grave violation of the duty placed on the Nigerian government to take appropriate measures to promote transparency and accountability in the management of public finances.

"These damning revelations suggest a grave violation of the public trust, the Nigerian Constitution of 1999, and international human rights and anti-corruption standards. Transparent and accountable public financial management is a key pillar of good governance, and of vital importance to provide public goods and services to citizens, as well as to create and maintain fair and sustainable economic and social conditions in the country. No date has been fixed for the hearing of the suit."

on. Naalong Gapyil, the Majority Leader of the Plateau State House of Assembly has explained why the State Assembly impeached Hon. Nuhu Ayuba Abok last Thursday in the state.

Speaking with airport correspondents on Sunday at the Murtala Muhammed International Airport (MMIA), Lagos, Gapyil said that the former Speaker was impeached for financial misappropriation, dictatorial tendencies and gross incompetence.

According to him, the former Speaker allegedly used his position as to corruptly enrich himself and develop his personal political empire, thereby frustrating policies that could have engendered development to the state.

He also accused the former speaker of shutting down the House for three months and finding a home in the major opposition party, noting that these acts culminated in what led to his ouster last week by the House members.

He debunked the allegation that only eight out of the 24 members in the House carried out the impeachment and went ahead to showed the reporters videos of the impeachment proceedings.

According to him, 16 members of the House of Assembly signed the impeachment notice, adding that the impeachment followed the due process and was in line with the House rules

The member Representing Mikang District at Plateau State House of Assembly, further noted with regrets that the House tolerated the impeached speaker for a long time, purporting that he was at the lowest ebb on intellectual matters, especially in areas relating to legislative businesses.

"Abok is also said to have made concerted efforts to thwart all the efforts put in place by the current administration of Governor Lalong and the goodwill earned by it simply because he felt he has found a new home other than the All Progressives Party," the majority leader alleged.

He said Abok is a product of the ruling All Progressives Congress (APC), stressing that all he ought to have done was to have worked in line with the policies and programmes of the current government to ensure delivery of dividends of democracy to the people of Plateau State.

He added: "But, I want to tell you that what the House under the former Speaker Nuhu Abok was doing was totally in the negation of what is expected of a leader who is supposed to put into account his primary responsibility first in all his undertakings. This is because we have the mandate of the people of Plateau State to represent them well.

"Being a speaker is a privilege and I must tell you that the way and manner Abok has managed this House as its speaker can be summarised as embarrassing. Firstly, since autonomy was granted to the State House under Abok, there was never a time that the Principal Officers ever met, discussed, and took any decision on any issue.

"Abok was only taking decisions solely without recourse to Principal Officers of the House. And I would be bold to state that his dictatorial tendencies are one of the reasons that cost him the speakership."

The House Leader added that apart from financial recklessness, the former Speaker's attempt to undermine policies of the current government embedded in Executive Bills was also his albatross.

ast Friday 5th March 2021, nearly 3,000 of Chinese lawmakers met at the National Peoples Congress (NPC-China's top legislature) to deliberate over a draft decision on improving the electoral system of the Hong Kong Special Administrative Region (HKSAR).

The proposed changes include adjusting the size, composition and formation of Hong Kong's election committee, which selects the city's leader or chief executive, and expansion of the committee's function to include electing a "relatively large share" of Hong Kong's legislative body, and nominating candidates for the body. According to Wang Chen, vice chairman of the NPC Standing Committee, while stressing the need to systematically implement the principle of 'patriots governing Hong Kong' said that the reformed electoral system would adjust and improve the size, composition and formation of the Election Committee in Hong Kong. It is the Election Committee that will elect the chief executive of the province, and will be entrusted with the new function of electing a relatively large share of Legislative Council (LegCo) members and directly participating in the nomination of all candidates for the LegCo.

This initiative promises a fresh and improved approach that will unleash Hong Kong democratic values, contrary to what the some media and critics will make the world to believe. They claimed it would erode Hong Kong's democracy and violate Beijing's commitment made to the international community regarding Hong Kong's high degree of autonomy since its return in 1997. But this will not be so based on the experience on China's structure, system and values. Hong Kong, which is a special administrative region (SAR) of China under the 'one country, two systems' principle, has now become an object of politicization and confrontation with China by external forces. The proposed electoral reform will deter the meddlesomeness of the system; and also will strengthen fundamental freedoms, political pluralism and democratic principles.

Essentially, the crux of the revised electoral system is patriotism, one of the key attributes of the Chinese culture. Which country does not demand patriotism from its citizens or institutions? When asked about why China is so ahead on the race to 5G on GPS' Fareed Zakaria on CNN on 7th March 2021, Eric Schmidt, former Google chief, said China was ten times ahead of the United States. A country that has four times more population might eclipse the US.

According Schmidt, the Chinese "...are a significant global competitor

to the west and to America; they are organized in central planning way...very smart people with global ambition.

I'm worried because of the structure of China], they're gonna move quicker than we are, even as a democracy." He was apparently referring to the structure that delivers world-class and reference-point development to China in the way the US is not.

Such structure is propelled by patriotism or national pride. Hong Kong Secretary for Mainland and Constitutional Affairs Erick Tsang has defined patriotism as "holistic love" for China, including the leadership of the Chinese Communist Party.

China demands devotion and vigorous support from its citizens. Without this, China would not have been the economic, industrial and technological powerhouse of the world.

Just this 2021, it has eradicated poverty by bringing the remaining 93 million people out of poverty and coupled with its success in keeping covid-19 under control. This is the quality borne out of age-long efficiency and effectiveness the NPC, that represents the voice of the people, is bringing to bear in Hong Kong.

Though, as a nation that is represented by distinctive traditions, cultures and languages, China still remains a cohesive whole like most nations of the world. Regardless of the 'one country, two systems' model bequeathed to it by the British, China is simply promoting civic patriotism that takes the existing imbrication of politics and cultures of both the mainland and Hong Kong seriously. According to Cecile Laborde (2002), "civil patriotism, ... emphasizes the motivational prerequisites of democratic governance, stresses the need to preserve existing co-operative ventures such as nation-states, and demands that existing political cultures be democratically scrutinized and reshaped in an inclusive direction."

It is that inclusiveness that will

promote a political identity that will be compatible with Chinese characteristics that is being planned with the electoral reform. Therefore, one is confident that Hong Kong will be better for it in the long term.

The NPC's effort to rejig the electoral system could be described as a major improvement for Hong Kong as it will serve as a constitutional assurance for implementing the principle of 'patriots governing Hong Kong, and therefore brings it in tandem with the Chinese mainland. Definitely, the political life of Hong Kong that had been challenged by crises in recent years would return back to normal. In other words, the revised electoral system will remove chaos in Hong Kong. More robust and meaningful political roles have now been created for the city's Chief Executive. As proposed, the Chief Executive will now be elected by the Election Committee and entrusted with the new function of electing a relatively large share of Legco members and directly participating in the nomination of all candidates for the LegCo, contrary to what had

Again, once the electoral system is reformed, the divisive political issues and processes that entangled the city in recent history will be a thing of the past. Political encumbrances that could regress the economic and financial successes of the region through political shenanigans and protest will be blocked by the new system. The political process will be able to elect competent hands that serve Hong Kong's development. Also, Hong Kong stands to gain tremendously if the electoral system is connected with governance process.

Over the last three years or so, there have been some misunderstandings and deep-seated problems about elections and democracy in Hong Kong. With the coming electoral regime, these misinterpretations or confusions will be explicitly explained and straightened-out. The intrusion

of foreign influences into the Chinese politics and internal affairs that are stoking unrest will be a thing of the past when this revised electoral system takes off. Li Keqiang, the country's premier buttressed it, saying 'we will resolutely guard against and deter external forces' interferences in the affairs of Hong Kong.' What is more important is the protection and vibrancy of democracy in which people who truly love the country's ideals and willing to sacrifice for its survival are involved in its democratic processes, participation and decision. It is when this is fixed that people around the world will envy the Chinese system yet again. Hong Kong is a democratic region.

Whatever that needs to be done for its improvement is both in the interest of the Hong Kongers and the rest of the Chinese people, inasmuch as those who are patriotic to the region's cause and Chinese characteristics are in positions of authority.

Election is the hallmark of participatory democracy. Thus, the central government is on the right path to help improve the electoral process of Hong Kong. The desire to return to the political stability and prosperity that Hong Kong was known for is more imperative particularly in the covid-19 pandemic era where nations are devising pragmatic means to overcome the attendant socio-economic and development challenges.

To this end, China's central government and other stakeholders particularly the people of the city must ensure to further develop Hong Kong as an international and technology hub as well as support its development as a China-foreign cultural and artistic exchange centre. Hong Kong must be better than when it was returned by the British. Fortunately, the 14 Five-Year Plan (2021-2025) is loaded with opportunities that will transform the social and economic development of the special region to keep up with what it is used to be, 'the Pearl of the Orient'. The new national security law and the revised electoral system are veritable mechanisms to achieve such feat for the region.

Carrie Lam, the Hong Kong's chief executive, instils confidence that the revised electoral system is 'timely, necessary, lawful and constitutional'. It is time for Hong Kong to wake up and put the interest of the region on the up and up. There is great optimism that the region is poised for an unprecedented development journey. Hong Kong will be for the Hong Kong people.







#### How Arapaja floored Oyinlola to emerge Deputy National Chairman South

The Peoples Democratic Party weekend elected Professor Iyorchia Ayu as its new national chairman alongside 20 other members of the new National Working Committee (NWC) that will take office December 9.

The election came amid failed last-ditch attempts by governors elected under the party to get former governor Olagunsoye Oyinlola to step down for Ambassador Taofeek Arapaja as the anointed candidate for the office of the national deputy chairman (south) of the party.

Following a decision to back Arapaja for the post, the governors had invited Olagunsoye to a meeting where they appealed to him to step aside in the interest of the party.

But an adamant former Osun State governor expressed bitterness over the poor treatment he said he was getting from the state chief executives.

He was said to have told the governors that he would not be humiliated as he was on his own when he has approached to contest for National Working Committee (NWC) post.

But worried by the negative message a lack of consensus going into the national convention may cause, the governors resolved to send emissaries to his house to continue their pressure on him.

Five of the governors were said to have stormed Oyinlola's house in Abuja on Thursday night with "a package," which sources said did not appeal to him.

When the governors realized that they were not making any headway, they decided to allow Oyinlola and Arapaja to contest but ensure that state delegates were mobilized for the former Oyo state deputy governor.

At the poll, Arapaja garnered 2,004 votes to defeat Oyinlola who polled 705 votes while a total of 165 votes were declared invalid.

Hajia Inna Ciroma, who is the wife of the late former Minister of Finance and PDP chieftain, Malam Adamu Ciroma, also vowed not to withdraw from the race for the national deputy chairman (north) in favour of Umar Ilya Damagum despite the pressure from the state governors.

She had insisted that she had paid her dues in the party where she was a minister and woman leader.

Mrs. Ciroma also frowned at the lack of inclusion of women in the PDP leadership and pointed out that her emergence as the national deputy chairman could assuage the womenfolk.

Her insistence caused the National Convention Organizing Committee (NCOC) led by Governor Ahmadu Fintiri to promise constitutional review that will ingrain affirmative action in the party constitution.

Damagum polled 2, 222 votes to beat Ciroma who garnered a paltry 365 votes.

### **EFCC** moves to end menace of fake Visa

hairman of the Economic and Financial Crimes Commission (EFCC), Abdulrasheed Bawa, yesterday, assured Nigerians of the commission's effort towards tackling the menace of fake visas, by working with embassies with a view to sanitising the process, which has led to increase in the demand for foreign exchange.

This is as the Central Bank of Nigeria has said its ban on sales of forex had begun to yield results.

Bawa gave the assurance in Abuja, at the Roundtable conference on: Depreciating value of naira and the Nigerian economy', organised by the National Institute of Legislative and Democratic Studies (NILDS), during which various stakeholders drawn from the academia and Association of Licensed Bureaude-Change operators frowned at the impacts of the recent policy statement issued by the CBN on

over N300 billion investment of the BDCs operators.

The EFCC boss, who was represented by the Director of Operations, Mr. Abdulkareem Chiko, observed that the prevailing economic situation has constrained government's ability and capacity to generate the required revenue and provide the needed infrastructure.

He reiterated the commission's resolve towards the enactment of legislative framework that would help in coordinating and ensuring the return of the looted funds back into the country with a view to addressing the revenue gaps.

"But from all these angle of the commission, there can be a very good contribution if there is a push on the side of the commission to ensure that there is a legislative framework to coordinate and ensure the return of the loots and funds back into the country to address the revenue gap. So, what we are trying to do is have a system whereby you can confirm if this visa is genuine or not there and there, because anybody that wants forex and wants to travel genuinely will go through the process of getting visa.

"That angle of looking at if the visa is genuine or not is not there yet, so you can as well afix any passport or visa on that passport, so it's more like saying just do the needful and I will give you the dollars. But if you are working with embassies, it could make it very easy, there and then, you can send those things and within two or three days, once it's confirmed that it's fake, then EFCC will take over from there and we will get to the root of the matter."

In his presentation, Central Bank of Nigeria (CBN) Director, Legal Services, Mr. Kofo Salam-Alada, said the ban on sale of foreign exchange to BDCs operators has been yielding positive results.

While assuring the people that the apex bank would spare no effort towards ensuring the stability of naira, Salam-Alada explained that the stability of the value was the key for investors, who were coming into the country for the projection of their investment.

According to him, "The panelists may not have been aware, a lot has been going on regarding all the associated issues, which we are dealing with. Nobody can be more concerned about this than Central Bank of Nigeria. Why, the Institute that put this together also, is a child of the parliament, its ancillary to the Parliament and the parliament has donated certain powers to Central Bank of Nigeria.

"Section 2 of the Central Bank of Nigeria Act, 2007 sets out the mandate of the Central Bank and one of it is that, we issue legal

tender currency and management of foreign reserve to ensure the value of that legal currency, which

"You can see that these three things are inter-twin. Nigerian populace has come to ascribe the value of the currency to just the activities of the Central Bank, forgetting the most important part, which is the fiscal part of it. So, these are the things the CBN has been doing.

"It's when you manage liquidity that you can also impact the value of the currency itself. And in doing most of the things we do, apart from what is statutory, there are other fallout of those statutory powers and that's collaboration with other agencies of government."

On his part, Deputy Chairman, House Committee on Finance, Hon. Saidu Abdullahi,disclosed that the lawmakers would meet with the apex bank to interrogate various intervention programmes initiated by it.

Abdullahi expressed concern over the foreign exchange crisis and huge fund being used for the payment of under recovery.

While affirming that the country was in a very dire situation financially and was in need for deliberate policy to ensure price stability and effective foreign exchange management, lawmaker stressed the need to measure the performance of CBN in terms of achieving their set out objectives.

Earlier, in his remarks, NILDS Director General, Prof. Abubakar Sulaiman, while applauding the contributions of the BDCs to economic development, stressed the need for a paradigm shift by ensuring diversification of the country's economy.

He noted that exchange rate policy remained one of the most important indices that shapedeconomic growth, especially, for developing countries.

"With the increasing globalisation, varying factor endowment and the compelling needs to engage in transborder exchanges, exchange rate has become indispensable international transactions. Most developing countries such as Nigeria depend on import of machineries, spare parts and other finished goods for capital development and consumption purposes.

"These require foreign exchange reserves for build-up to ensure that panic measures are not resorted to when foreign exchange receipts dwindles or when there is disequilibrium in the foreign exchange market caused by inadequate supply of foreign exchange reserve," the DG added.

### FBI Indictment: No Formal Extradition Request For Abba Kyari – IGP

The Inspector General of Police (IGP), Usman Alkali Baba, says he is yet to see or receive a formal extradition request for Deputy Commissioner of Police (DCP), Mr Abba Kyari following his indictment by a US Court.

Kyari had earlier in the year been accused of being a conspirator in a 1.1-milliondollar fraud deal involving Instagram celebrity Ramon Abbas, popularly known as Hushpuppi.

Giving an update on the case, IGP Alkali Baba disclosed on Thursday that he had only heard it on social media, stressing that there was no extradition request as some have reported.

The Inspector General further explained that the panel constituted to investigate the case has submitted its report to the Secretary General of the Federation (SGF) Boss Mustapha for vetting and advice on the findings.

He added that the Force has only just received feedback from the SGF and is contemplating the next step to take.

The police chief's comment is the latest on the controversial issue in spite of a warrant issued by a US magistrate judge, Otis Wright, ordering the arrest of Kyari.

About a month ago, Minister of Police Affairs, Muhammadu Maigari Dingyadi affirming that investigations have been concluded and findings submitted, noted that President Muhammadu Buhari will have the final consideration on the matter.



### **NECO Releases 2021 SSCE Results**

he National Examinations Council (NECO) has released the results of the 2021 Senior Secondary School Certificate Examination

Wushishi, the Registrar, who announced the release of the results at the Council's Headquarters in Minna, Niger State, said out of 1,233,631 candidates who registered for the examination, 1,226,796 sat

He said the number of male candidates was 657,389, representing 53.28%, higher than the number of female candidates which was 576,242, representing 46.71%.

Wushishi revealed that 878, 925 candidates, representing 71.64% had five credits in English Language and Mathematics, with a decrease of 2.25% as compared to the results of 2020.

He said 1,226,796 candidates, representing 94.04% Professor Dantani Ibrahim obtained five credits and above irrespective of English Language and Mathematics with an increase of 2.13% as compared to 2020 results.

The Registrar said the council recorded 20,003 various cases of examination Malpractices, representing 1.63% this year, which is lower than the 2.61% cases in 2020.

He said one school each in Bauchi, Kaduna and Bayelsa and two in Katsina States were de-recognised for two years for their involvement in Mass Cheating while 20 supervisors were also also blacklisted for various offences including "poor supervision, Aiding and Abetting, Connivance with non-candidates to write answers on chalkboard, compromise and extortion."

"The council has a longstanding tradition for zero tolerance for malpractice. Thus, it can be noticed that the malpractice incidence in 2021 dropped compared to 2020," he said.

Wushishi said the late release of results this year was due to challenges "as a result of some actions by agencies that have direct bearing on our operations."

The Registrar also announced the release of the BECE results and directed the candidate to visit the Council's website to check their results.

### Sudan coup: Khartoum barricaded by pro-democracy activists

protesters barricaded roads in the capital, Khartoum, as part of week-long demonstrations against a military

Three people were killed on Saturday when security forces fired shots and tear gas to disperse protesters in the nearby city of Omdurman, medics said.

The interior ministry denied that live rounds had been fired.

The army seized power on Monday, detaining Prime Minister Abdalla Hamdok and other civilian leaders.

The UN's Sudan envoy, Volker Perthes, met Mr Hamdok at his residence on Sunday.

Mr Perthes said Mr Hamdok was well but remained under house arrest.

"We discussed options mediation and the way forward for Sudan," he added.

Coup leader Gen Abdel Fattah Burhan dissolved civilian rule on Monday.

The general, who also called a state of emergency, said his actions were justified to avoid "civil war" and stop political infighting. The military takeover has drawn widespread international condemnation.

Saturday saw the biggest demonstrations yet, with tens of thousands marching across the country with Sudanese flags and chanting, "No to military rule!"

"These protests are going to continue being peaceful even when faced with the guns," Shaheen al Shaheef, a member of the Khartoum Resistance Committee, declares.

More than 10 protesters have died in clashes with security forces last

The Sudanese authorities have cut off the internet and other communications.

Until Monday's coup, civilian and military leaders had been in an uneasy power-sharing agreement since long-time ruler Omar al-Bashir was overthrown in 2019.

The deal was designed to steer Sudan towards democracy, but it proved to be fragile with a number of previous coup attempts.

Gen Burhan, who was head of the power-sharing council, said Sudan was still committed to the transition to civilian rule, with elections planned for July 2023.

## G20 in final push to reach deal on climate at Rome summit

he leaders of the world's richest economies will spend Sunday trying to reach a meaningful deal on preventing climate change.

The G20 is hoping to make progress ahead of the COP26 summit in Glasgow, which begins on Sunday.

However, they have yet to announce any firm new commitments to reduce carbon emissions in the coming years.

The G20 group, made up of 19 countries and the European Union, accounts for 80% of the world's

The first day of the summit, being held in Rome, Italy, focused on Covid and the economy, with an agreement being reached on a global tax rate which will see the profits of large businesses taxed at least 15%.

It follows concern that multinational companies are re-routing their profits through low tax jurisdictions.

Sunday is dedicated to discussions on climate, with Britain's Prince Charles addressing the group.

He urged the leaders to take action "for

the sake of humanity", but acknowledged with the costs for new infrastructure likely to spiral into "trillions of dollars" it needed both government and the private sector to work in tandem.

Italian Prime Minister Mario Draghi - who is hosting the event - went on to call on his colleagues to accelerate phasing coal and investing in renewable energy, while outlining long term goals.

However, reaching an agreement on how best to cut carbon emissions - and to stop climate change getting worse - is proving difficult.

After years of talking, the planet is now at least 1.1C hotter than the preindustrial level. Climate scientist want warming restricted to 1.5C to prevent climate catastrophe.

There were already concerns reaching a deal would not be easy, as among the leaders not appearing in person is China's President Xi Jinping. China is the world's biggest polluter - although, per person, its emissions are about half those of the US.

Activists are disappointed with what is

currently being discussed. Reuters news agency suggested that the agreement in latest draft communiqué did not toughen the language used in previous versions and has even been softened in

Oscar Soria, of the activist network Avaaz, told the agency there was "little sense of urgency" coming from the group, adding: "There is no more time for vague wish-lists, we need concrete commitments and action."

However, others have been keen to paint the G20 as a stepping stone to COP26, which will see delegates from about 200 countries gather to discuss cutting carbon emissions.

A US official told reporters the G20 was about "helping build momentum" before the leaders headed to Glasgow later on Sunday, while France's President Emmanuel Macron told newspaper Journal du Dimanche that "nothing is ever written before a COP".

"Let's not forget that in Paris, in 2015, nothing was decided in advance," he told the weekly.

### Sudan coup: Khartoum barricaded by pro-democracy activists

man has been left in a critical condition after a knife and arson Lattack on an underground train line in the Japanese capital, Tokyo.

At least 10 others were also injured in the incident, which happened at around 20:00 (11:00 GMT) near Kokuryo station, in the city's western suburbs.

Passengers ran for their lives, some climbing out of windows, as fire raged in a carriage on the Keio Line train.

The suspected attacker, a man in his

20s, was arrested at the scene.

Eyewitness reports say the suspect sprayed a clear liquid around the carriage before setting it alight.

Images from the scene show some passengers running from the attacker, stumbling through a connecting door into the next carriage. The train later stops in a station - but the doors remain closed as the train begins to fill with smoke.

Finally, the trapped passengers start forcing the windows and climbing on to the platform.

There have been a number of knife attacks in Japan in recent years - two on Tokyo's subway system in 2021. In August nine people were injured by a knife wielding man. And in the same month two people were injured in acid attack at subway station.

In 2019, a man also attacked a group of schoolchildren waiting for a bus in Kawasaki. Two people were killed and at least 18 were injured.

"He has just trained this week.

He was to come on [in the last] fifteen to twenty minutes maximum, that was our plan [on Saturday]," Rodgers told the media as quoted by All Nigeria

"But obviously we were chasing the game so there wasn't that need to put him on. [But] it's great to have him back and available and we'll see how his fitness looks over

the coming days."

The former Liverpool coach went on to explain why his team lost the match against the North Londoners.

"A poor start cost us, it's a lack of concentration and then you're chasing the game against a good side," Rodgers told Leicester's website.

"We have been able to do it in a few games recently where we've not had a great start and come back, but you can't give teams a 2-0 start, especially a good team like Arsenal.

"We were too passive, so it is a concern. When you have players finding the level and the constant mentality, if you don't start the game well, then it can cost you and today it cost us. In the second half, we can't have any complaints. I thought we were excellent.

"We had to make changes to shift the dynamic of the game, but we got punished for that opening 20 minutes. Both [Harvey Barnes and Ademola Lookman] were excellent. They gave us that pressure higher up the pitch. We could condense the game up there and we were much better.'

After the loss, Leicester are now placed 10th with 14 points while Arsenal climbed to sixth with 17

### 'Koulibaly and Osimhen are extraordinary players for Napoli' - Salernitana manager Colantuono

At the back, Senegal star Koulibaly has also been a rock and to date, the team has conceded just three goals in the league this

But while Osimhen, is expected to miss the trip to Salernitana due to a muscle strain, the center-back is fit and ready for the match.

"Koulibaly and Osimhen are two extraordinary players, but Napoli are a very strong team, which deserves great consideration,"

Colantuono said as quoted by Area

They are living. a moment of grace, they have won almost all of [league matches this season] and we can't do anything wrong otherwise they will punish us.

"We will try to play with our characteristics, working in the details that will make the difference. Napoli, together with Milan, are the strongest [in the league]

The 59-year-old has further commented on their opponent's attack that has so far scored in nine of the 10 league matches. The tactician has hinted they will not be sitting back to defend.

"Napoli attack in many ways. They have depth, dribble, jump the man, have a center forward that is difficult to limit. If you enhance his characteristics he is a striker who puts not Salernitana in crisis, but the whole championship," Colantuono continued.

he novel coronavirus has shown glaring flaws in the world's collective ability to respond to infectious disease outbreaks, with none more evident than wealthy countries' self-destructive unwillingness to cooperate on vaccine equity for the benefit of the entire global population.

Since the world's wealthiest countries have been the primary contributors to the great global disparity between the vaccine haves and have-nots, it's time that African leaders push G20 heads of state to address and rectify the life-threatening vaccine imbalance at the upcoming summit in Rome, Italy at the end of October.

As of early October, 3.6 billion COVID-19 vaccine doses had been administered globally, with 78 per cent of those going to people in high-and upper-middle-income countries. Less than 7 per cent of the 1.3 billion people on the African continent have received even one dose. The discrepancy is worse for people in low-income countries, where less than 1 per cent have gotten a shot.

It's no surprise that there are not enough doses to vaccinate our world when wealthy countries have secured enough vaccines to inoculate their populations as much as five times over, according to Duke University. Even though the world will have created 11 billion total doses by the end of this year, almost 9.9 billion of those have already been promised to wealthy nations.

The Covax initiative, while promising, was supposed to supply lower-income countries with sufficient vaccine doses. However, that mechanism clearly has fallen short of its initial goal to vaccinate 20 per cent of recipient countries, which is still far too little when the World Health Organisation (W.H.O) states that a vaccination rate of 70 per cent is required to protect the world.

A debate in the U.S. and other high-income countries now centers around booster shots, while Africa and other hard-hit regions struggle. W.H.O Director-General Tedros Adhanom Ghebreyesus recently said it was "unconscionable" that some countries are now offering booster shots "while so many people remain unprotected."

The time has come for African leaders to amplify their voices in a

for successful vaccines against the coronavirus, whose development was supported by \$100 billion in public funding from taxpayers in the U.S., Germany, and other countries.

Taxpayers were the primary funders of COVID-19 vaccine research, development, and production – the world owns that intellectual property, not the drug companies that continue to profit from the pandemic.

According to Action Aid, Moderna, BioNTech, and Pfizer are reaping astronomical and unconscionable profits due to their monopolies of mRNA COVID vaccines, with the three corporations having earned more than \$26 billion in revenue in the first half of the year.

Further steps that leaders of the wealthiest economies must take are raising at least \$100 billion, enough to vaccinate our world, committing to international cooperation as the most fundamental way to address pandemics, and drafting a new Global Public Health Convention to serve as the worldwide health governance system to rapidly respond to future outbreaks.
